Propositions accompanying the PhD thesis

Probation officers in Turkey: The relevance of attitudes toward offenders

- 1. Attitudes toward juvenile probationers play a role in juvenile probation officers' recidivism risk perceptions (*Chapter 4, this thesis*)
- 2. Gender role attitudes among the public appear to be more relevant to punitive attitudes toward offenders than offender gender (*Chapter 5*, *this thesis*).
- 3. Punitive (and rehabilitative) attitudes could be a target in dealing with, and possibly preventing, job burnout in probation officers (*Chapter 3, this thesis*).
- 4. Punitive and rehabilitative attitudes of juvenile probation officers should not be viewed as two ends of the same continuum, but rather as two separate dimensions (*Chapters 4 and 6, this thesis*).
- 5. A brief training program based on the Risk-Need-Responsivity model is promising in terms of decreasing punitive attitudes toward probationers in juvenile probation officers in the short term (*Chapter 6, this thesis*).
- 6. Implementation of an evidence-based risk assessment tool is an urgent and important need of the Turkish probation system.
- 7. Youth do not belong in prisons; juvenile offender rehabilitation in the community should be prioritized.
- 8. It is the responsibility of every individual and organization to take an active role in the re-integration into the community of juveniles who have been in contact with the law.
- Conducting research on the effectiveness of probation interventions without the availability of recidivism data is like commanding a ship in the ocean without a compass.
