1. Directive 2011/24/EU represents a new stage in the legal protection of classical individual patients' rights within the EU. | This dissertation
2. 'Patients' rights' in Article 6(3) of Directive 2011/24/EU refers to the protection of classical individual patients' rights to which a(n) (incoming) patient is entitled according to the legislation of the Member State of treatment. | This dissertation
3. The nature of Article 6(3) of Directive 2011/24/EU implies that a consistent definition of 'patients' rights' in Directive 2011/24/EU is not only desirable but also inevitable. | This dissertation
4. The minimal implementation of Article 6(3) of Directive 2011/24/EU results in potential unintended consequences as it threatens classical individual patients' rights of an individual patient seeking to receive cross-border healthcare within the EU. | This dissertation
5. The new individual patients' rights to information under Article 6(3) of Directive 2011/24/EU cannot contribute very much if EU citizens are not even familiar with the existence of the NCPs for cross-border healthcare.
6. The EU is a supranational organisation with objectives that have patchy consequences for the area of healthcare.
