Propositions belong to the thesis

**Impairments in Social Interaction of Individuals
with Personality Disorders and Dark Personality Traits**

1. Healthy volunteers show a “positivity bias” towards various forms of social feedback. (this thesis)
2. Individuals with borderline personality disorder often engage in turbulent relationships in spite of clear awareness of the risks. (this thesis)
3. Oxytocin elicits anti-aggressive effects in young antisocial adults by enhancing the recognition of distress signals in potential victims and amplifying the rewarding nature of happy facial cues. (this thesis)
4. Societal role expectations influence the economic decision-making of women in relation to leadership emergence, particularly among those with lower levels of dark traits. (this thesis)
5. Remission raises the question whether recovery is a fleeting moment or a lasting victory. (Yang et al, Fron Psychiatry, 2022)
6. A negative attitude towards borderline personality disorder persists among clinical staff members. (Baker & Beazley, J Psychiatr Pract, 2022)
7. Individuals with borderline personality disorder to seek the anonymity of the internet as a social refuge. (Blumer & Renneberg, ZPPP, 2015)
8. Self-compassion paves the way for empathetic healing. (Book of Leviticus)
