Firm Participation, Learning and Innovation in Heterogeneous Value Chains of IT-enabled Service:

The case of South-Africa

1. Firm participation in local- and regional value chains could provide a steppingstone into GVCs (Chapter 3, 4 and 6).
2. The blending of both international and domestic linkages for capability development is important to compensate for an initially weak innovation system (Chapter 6).
3. GVC participation is a route to upgrading, but not the only route (Chapter 5, 6).
4. Multiple feedback loops exist between the NIS and GVCs in capacity development at the firm level and (ultimately) the development of the ITES sector in South Africa (Chapter 5 and 6).
5. The development of skills is critical for GVC participation and sustained growth of the South African ITES sector (Chapter 3, 5 and 6).
6. Over time, the distinction between RVCs and GVCs, based on a geographical definition, may become blurred (Chapter 7).
7. "African policymakers need to place greater emphasis on how to move towards the provision of more sophisticated services where there is greater value addition, opportunities for technology transfer and linkage development with other sectors of the economy" - UNCTAD, 2016.
