Propositions

- Health and health care of persons affected by war and displacement cannot be regarded isolated but must be considered in a societal, political, historical and religious context (dissertation)
- Administrative processes for newly arrived refugees in Germany are basically well developed but actually work inefficient (dissertation)
- Trends in term of the use of the German health care system that are already known by migrants may also occur in the newly arrived refugee population (dissertation)
- Mental health burden must not be disregarded in the integration of refugee children/adolescents (dissertation)
- Due to the evidence of the improved health care through the Electronic Health Insurance Card for refugees, the focus regarding its introduction should not be on the question IF administrative costs could increase but HOW solutions can be developed (valorisation)
- Prosperity creates responsibility (field)
- Disadvantage due to the educational background of the parents may be even more pronounced for new immigrants and refugees (field)
- The introduction of the Electronic Health Insurance Card for refugees represents a step forward towards an equal health care service (field)
- "Wir schaffen das" (31.8.2015, Angela Merkel) (else)
- "[translated from German] The Electronic Health Insurance Card" can improve the care of the refugees and reduce the administrative burden. It now threatens to remain on the track in the distribution of the actors at federal, state and local level." (Stefan Etgeton, Bertelsmann Stiftung) (else)
