TRENDS IN DIAGNOSTIC CONFIRMATION AND TREATMENT OF PRE-MALIGNANT ABNORMALITIES AT SCREENING MAMMOGRAPHY

1. Screening reduceert de incidentie van hooggradige invasieve carcinomen door middel van vroege diagnostiek en behandeling van hooggradige DCIS (*dit proefschrift*).
