1. An exposure to DTT at pH 9.5 induces sufficient decondensation of DNA in the sperm head to guarantee optimal (F)ISH results (*this thesis*).
2. (F)ISH enables rapid and reliable accumulation of information with respect to the numerical chromosome constitution of a large number of spermatozoa (*this thesis*).
3. (F)ISH is a valid alternative for karyotypic analysis of structural chromosomal abnormalities in male gametes (*this thesis*).
4. The discrepancy between the expected and observed aneuploidy rate in XYY and XXY males can be explained by natural selection during spermatogenesis (*this thesis*).
5. Predivision of chromatids is more often seen in aneuploid oocytes than in haploid oocytes (*this thesis*).
