Stellingen bij het proefschrift

- Door kinderen een stem te geven worden verkeerde aannames met betrekking tot de kwaliteit van leven van het kind voorkomen
- Kindermishandeling leidt tot lagere kwaliteit van leven bij kinderen
- Kindfactoren zijn belangrijker voor de kwaliteit van leven van mishandelde kinderen dan ouderfactoren en omgevingsfactoren
- Het kind-interview als onderdeel van het AMK onderzoek is van cruciaal belang voor de verwijzing naar passende hulpverlening

Stellingen bij de valorisatie

- AMK's en verschillende maatschappelijke en gezondheidszorginstellingen voor zowel kinderen als volwassenen zouden beter moeten samenwerken om de daling in kwaliteit van leven op de langere termijn na AMK interventie te voorkomen
- Het kind-interview moet volledig geïmplementeerd worden in de AMK werkwijze

Stellingen over het vakgebied

- De jeugdgezondheidszorg richt zich te weinig op mishandelde kinderen
- De politiek zou meer moeten investeren in de behandeling van mishandelde kinderen om de kwaliteit van leven nu en in de toekomst te waarborgen
- De grootste groep mishandelde kinderen valt nog steeds buiten de boot en wordt (nog) niet geholpen
