Chapter 1

Introduction

Formal treatment of game theory arguably starts with the work of Zermelo (1913), Borel (1921), and von Neumann (1928). But, the theory received widespread attention only after the publication of the seminal book of von Neumann and Morgenstern (1944). Game theory is the study of strategic decision making. More precisely, it is the mathematical discipline that addresses the situation where each of a group of strategic agents, the players, interact and jointly determine the outcome. Each player has certain personal preferences over the set of possible outcomes, which is measured on a given utility scale and is called the payoff of the player. A game consists of a set of players, each player's set of available choices (so-called player's action space), and each player's payoff function that is a function of all possible profiles of actions chosen by the players. In game theory we assume that players are intelligent and rational and this is common knowledge between them. A player is *rational* if his objective is to maximize his utility and he is *intelligent* if he can make any inferences about the game that we can make. A strategy for a player in a game is a decision rule that tells him which action to choose at different stages of the game.

Traditionally, games have been divided into two classes: cooperative games and noncooperative games. Noncooperative games are games in which there are no possibilities for binding agreements. A specific class of noncooperative games are normal form games. In such games, players simultaneously choose an action from their action space and subsequently each player receives a payoff depending on the resulting profile of all actions chosen by the players. Interestingly, every game can be reduced to a normal form game. In order to do this, one needs to consider the set of all possible strategies for a player as his action space. In this way, each player by choosing a strategy at the start of the game knows in advance how to act at any possible stage of the game. In this monograph, we restrict our attention to normal form games.

A main question in game theory is how each player should act so that his partial influence on the game benefits him the most. An answer to this question is called a solution for the game. John Nash in 1950 [36] introduced the solution concept of Nash equilibrium for normal form games. A Nash equilibrium is a profile of (possibly randomized) strategies in which no player can improve his payoff by unilateral deviation. In other words, a strategy profile in equilibrium is self-enforcing. Nash proved the existence of Nash equilibrium in randomized strategies for normal form games with finite action spaces. He received the Nobel prize in 1994 for his contribution to game theory and economic science.

However, Nash equilibrium fails to select the intuitive equilibrium in some games. As an example of such cases, consider the following public good game. In this game at least two players are involved and each player has to choose an action from the set $\{yes, no\}$. If all of them choose *yes*, the public good will be provided to the players, consequently they will all enjoy a strictly positive payoff. Otherwise, they do not get anything and the payoff is zero for all players. This game contains many Nash equilibria. The most obvious Nash equilibrium is the strategy profile in which all players choose *yes*. However, the strategy profile where all players choose *no* is also a Nash equilibrium. Because, when each player believes that his opponents choose *no*, he is indifferent between *yes* and *no*, therefore he does not have any incentive to deviate from saying *no*. Nevertheless, the latter equilibrium is not intuitive. Notice that each player by choosing action *yes* is never worse off when compared to action *no*, no matter what other players do. For this reason, action *no* is called weakly dominated by action *yes*. Formally speaking, a strategy for a player is weakly dominated if it is (weakly) inferior in terms of payoffs to other choices available to him, regardless what other players choose. In the example of public good game, the strategy profile in which every player chooses *no* is a Nash equilibrium but actually every player chooses a strategy that is weakly dominated.

Hence, it seems necessary to refine the Nash equilibrium in order to obtain more intuitive solutions. To address this issue, in 1975 Nash's co-Nobel prize winner Selten [41] introduced trembling hand perfect equilibrium, a refinement of Nash equilibrium for games with finite action spaces that rules out equilibria where such weakly dominated strategies are played. Perfect equilibrium is a Nash equilibrium in which players choose strategies that are robust against small mistakes in the choice of strategies by opponents. In the above public good game, the only perfect equilibrium is the strategy profile in which every player says *yes*. The reason is that if each player takes making mistakes by his opponents serious, then he believes that all his opponents say *yes* at least with a small positive probability. This is enough for

him to make *yes* the unique best response, as by doing so he gets a strictly positive payoff, even though with a small positive probability. But, by choosing *no*, he gets zero surely. The strategy profile (yes, yes, \dots, yes) , that is robust with respect to small perturbations, is the only intuitive equilibrium in this game.

In modern economic theory, there are many game theoretic models that feature an infinity of possible choices. Some of the important examples of such games are auctions, Cournot competition models, cake division games, and location games. Since also in such models Nash equilibria may use weakly dominated strategies, in 1995 Simon and Stinchcombe [42] defined perfect equilibrium for games with infinite compact action spaces. They distinguished two different approaches. The first approach is a direct generalization of the original definition of Selten, whereas the second approach is based on finite approximations of the infinite game in question and is called the finitistic approach.

Note that in the some of the applications mentioned above, information is not always fully disclosed. Those are situations where players may have private information about the game, consequently players may be uncertain about the payoffs. Such games are called games with incomplete information. One of the interesting examples of games with incomplete information is auctions. We discuss auctions more in detail here. Consider an auction where bidders submit written bids without knowing the bid of other bidders in the auction, and in which the highest bidder wins, but the price paid is the second-highest bid. This auction is a sealed bid second-price auction and it is known as the Vickrey auction, after Vickrey who won the Nobel prize in 1996 for his research in the economic theory of incentives under asymmetric information. In such auctions each bidder knows the valuation of the object for himself, but he does not know the other bidders' valuation. There maybe many equilibria in this auction, however Vickrey showed that bidding his own valuation of the object is a weakly dominant strategy for each bidder. Now, consider a sealed bid second-price auction in which each bidder has only partial information on the valuation of the object even for himself. In this auction, bidders might not have any dominant strategy while there are multiple equilibria. Therefore, a selection tool is needed that can rule out the less intuitive equilibria. This motivates us to study perfect equilibrium as a selection criterion in games with infinite action spaces as well as in games with incomplete information.

In chapter 2, we investigate the relations between different types of perfect equilibrium, introduced by Simon and Stinchcombe. We propose an improved refinement along finitistic approach and prove its existence. Despite the fact that the finitistic approach appeals to basic intuition, our results seem to imply a severe critique

of this approach.

In chapters 3 and 4, we extend Selten's trembling hand approach to equilibrium refinement to games with incomplete information with infinite action spaces. We develop the concept of perfect equilibrium for such games, by taking two different approaches. The difference between these two approaches is at using two distinct strategies, so-called *behavioral strategies* and *distributional strategies*. In chapter 3, we formulate and examine several definitions of perfection based on behavioral strategies. We distinguish three definitions, using various notions of convergence of randomized strategies such as uniform, pointwise and almost everywhere pointwise convergence. In chapter 4, we define perfection by making use of distributional strategies and prove its existence under some continuity assumptions. It should be emphasized here that the approach taken in chapter 3 is a more straightforward way of defining perfection in games with incomplete information than the one in chapter 4. However, in developing the theory, particularly in proving existence, it is difficult to work with behavioral strategies while the second approach does not have this problem. Additionally, in chapters 3 and 4 by using both approaches, we apply perfection to a class of symmetric second-price auctions with incomplete information and observe that perfect equilibrium selects a specific type of equilibrium and rules out less intuitive equilibria.

Related literature Equilibrium selection and refinement theory already have a long and steady-going tradition, arguably starting with essential equilibrium (Wu Wen-Tsün, Jiang Jia-He [47]). A Nash equilibrium in a normal form game is essential if neighboring games with slightly perturbed payoffs have equilibria close to the Nash equilibrium. Thereafter, perfect equilibrium (Selten [41]) was defined which is the main focus in this monograph. Perfect equilibrium in games with infinite action spaces is a useful tool to select Nash equilibria, for example in auction models with incomplete information, such as the ones studied in Compte and Jehiel [9] and Crémer et al. [10], where dominant strategies are not available as a selection criterion. Concrete applications of perfect equilibrium in infinite strategic form games can among others be found in Jackson et al. [16], Simon and Stinchcombe [42], and Andersson et al. [2]. A further refinement of perfect equilibrium is proper equilibrium (Myerson [35]). The idea behind proper equilibrium is that more costly mistakes occur with less probability than less costly ones. Kalai and Samet [19] by defining persistent equilibrium develop the notion of stability to neighborhood stability. All of the mentioned refinements are for finite normal form games.

Progress on refinements in the context of extensive form games are for example

sequential equilibrium (Kreps and Wilson [22]). This concept focuses attention on the beliefs of the players at information sets not reached in the equilibrium under consideration.

Kohlberg and Mertens [21], introduce the concept of strategically stable equilibrium by motivating a number of requirements a solution concept should satisfy. Generally speaking, a stable set of equilibria is a minimal closed set of equilibria such that small perturbations of the game have equilibria close to the stable set. They fail to define a solution concept satisfying all their requirements. Mertens [28] [29] reformulates the concept of stable equilibrium. Hillas [15], shows that by changing the definition of perturbation it is possible to define a solution concept that does satisfy all of the requirements introduced by Kohlberg and Mertens. More recently Govindan and Wilson [14] work on metastable equilibria.

Theory on refinements for games with compact action spaces has been developed in, among others, Méndez et al. [27], Simon and Stinchcombe [42], and Yu [48], and Carbonell-Nicolau [7].

The above line of literature mainly concerns what Andersson et al. [2] refer to as “strategic uncertainty”. In this study, they formulate a notion of strategic uncertainty for games with infinite action spaces and propose a criterion for robustness to such uncertainty.

An alternative line of research on equilibrium refinement is on “structural uncertainty” where, due to informational uncertainty, iterated deletion of weakly dominated strategies is used as a refinement technique. This approach, also known as the global games approach, was developed by Carlsson and van Damme [8], with applications in for example banking and finance (Morris and Shin [34]).

Chapter 2

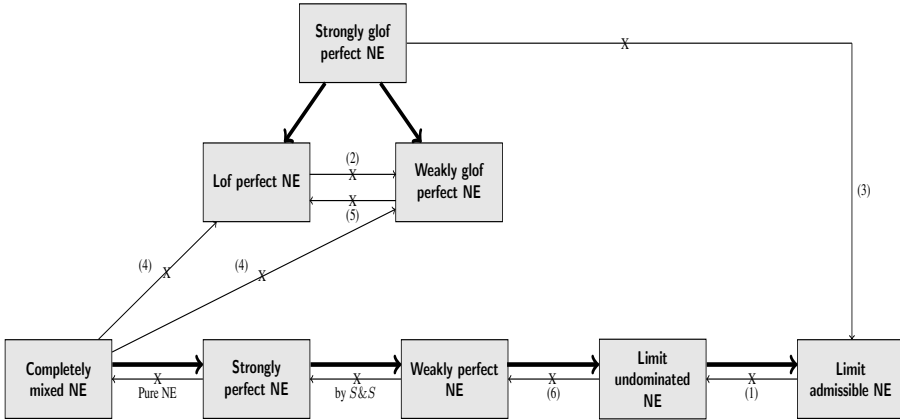
Perfect equilibrium in games with compact action spaces

2.1 Introduction

In 1995 Simon and Stinchcombe [42], for brevity referred to as S&S, defined perfect equilibrium for games with an infinite compact set of actions. They distinguished two main lines of definitions of perfection. The first line is based on the notion of a completely mixed strategy, giving rise to the notions of strongly perfect and weakly perfect equilibrium. This approach can be viewed as a direct generalization of the original trembling hand definition of perfect equilibrium introduced by Selten [41]. The second line of definitions, in S&S referred to as the finitistic approach, uses the notion of an ε -perfect equilibrium in finite approximations of the original game. The resulting notion of perfect equilibrium is called limit-of-finite perfect equilibrium.¹ They showed that the first type of perfect equilibrium only admits limit admissible strategies. Furthermore, they conjectured that the two approaches are incomparable.

In this chapter we investigate the existing relations between the various types of perfect equilibrium within the framework of strategic form games with compact action spaces and continuous payoff functions. The diagram below gives an overview of those relations between different types of perfect equilibrium that are currently known. Strongly perfect, weakly perfect, and lof (limit-of-finite) perfect equilibrium are introduced by S&S. Strongly glof (global limit-of-finite) and weakly glof perfect equilibrium are introduced in this chapter. Limit undominated Nash equilibrium, a stronger version of limit admissibility from S&S, is also introduced in this chapter.

Boldface arrows indicate valid implications. For example, every strongly glof perfect equilibrium is a lof perfect equilibrium. Roman face arrows with a “X” through it indicate implications that do not hold in general. Counterexamples are provided by previous studies, and examples (1) to (6) in this chapter.

Results This chapter makes two main contributions. The first contribution is the introduction of global limit-of-finite perfection, from now on referred to as glof perfection. S&S already introduced lof perfect equilibrium as the limit of ε -perfect equilibria of large but finite approximations of the original game. Despite its relative straightforward intuition, lof perfect equilibrium does not always select available dominant strategies. Strongly glof perfect equilibrium is defined in the same way as lof perfect equilibrium, but with the added requirement that best responses in the approximating games are in fact best responses in the original game. Strongly glof perfect equilibrium is a stronger version of finitistic perfection than lof perfect equilibrium. Weakly glof perfect equilibrium adds to the definition of lof perfection the weak requirement that best responses in the approximating games are only close to best responses in the original game. We show existence of weakly glof perfect equilibrium. Moreover, we show that weakly (and therefore also strongly) glof perfect equilibrium does uniquely select dominant strategy Nash equilibria as soon as dominant strategies are available to a player.

Second, we provide five illustrative counterexamples. Example 2 features a lof perfect equilibrium that is not limit admissible. In fact the game in the Example encompasses Examples 2.1 and 2.4 of S&S with the added feature that the action spaces are countable instead of the union of an interval and an isolated point. Example 3 presents a strongly glof perfect equilibrium that is not limit admissible.

This result is in line with Example 2.4 of S&S and our Example 2 of a lof perfect equilibrium that is not limit admissible. Example 4 verifies the conjecture of Simon and Stinchcombe that strong perfection does not imply finitistic perfection. More precisely, it is an example of a completely mixed, and therefore strongly perfect, equilibrium that is neither lof perfect (and therefore also not anchored perfect) nor weakly (and therefore also not strongly) glof perfect. Example 5 presents a weakly glof perfect equilibrium that is not lof perfect, and therefore also not strongly glof perfect.

Example 6 is a comment on the theorem of van Damme that for bimatrix games a Nash equilibrium is perfect precisely when the equilibrium strategies are undominated. This equivalence no longer holds in the more general context of two-player games with compact action spaces and continuous payoff functions. Example 6 presents a two-person game, where player 1 has two pure strategies and player 2 has a countably infinite number of pure strategies, with a Nash equilibrium in undominated strategies that is not weakly perfect. An added feature of the example is that there is another Nash equilibrium in this game that is payoff equivalent to the first Nash equilibrium, while the second Nash equilibrium is weakly perfect. Thus, weakly perfect equilibrium is not invariant, in contrast to perfect equilibrium for finite strategic form games. The example highlights the fact that for infinite compact action spaces, the topology on the action spaces starts to matter for perfection.

All our examples use countably infinite pure action spaces. We specifically chose not to use compact intervals as action spaces, in order to highlight the underlying logic of the constructions. It is nevertheless evident from the constructions that, with a bit (well, for some examples perhaps a bit more than a bit) of extra work the examples can also be transformed to counterexamples on the unit interval.

2.2 Strategic form games

A strategic form game (with compact action spaces) is a triplet $\Gamma = (N, A, u)$ where $N = \{1, \dots, n\}$ is the set of the players, $A = \prod_{i \in N} A_i$ is the set of profiles of actions, and $u = (u_1, \dots, u_n)$ is the vector of payoff functions. We assume for every player $i \in N$ that the sets A_i of actions are non-empty and compact metric spaces with the metric d_{A_i} and that the payoff functions $u_i: A \rightarrow \mathbf{R}$ are continuous. Note that a compact metric space is separable.

The set $\Delta(A_i)$ is the set of (mixed) strategies of player i . We identify every action a_i with the Dirac measure $\delta(a_i)$, the strategy that selects a_i with probability 1. A vector $\sigma = (\sigma_i)_{i \in N}$ with $\sigma_i \in \Delta(A_i)$ for all i is called a strategy profile. The

set of strategy profiles is denoted ² by $\Delta(A)$. For every strategy profile $\sigma \in \Delta(A)$ we define $u_i(\sigma) = \int u_i d\sigma$ which is continuous in σ with respect to the weak metric ρ^w on $\Delta(A)$.³

We write $A_{-i} = \prod_{j \in N \setminus \{i\}} A_j$. A generic element of $\Delta(A_{-i})$ is denoted by $\sigma_{-i} = (\sigma_j)_{j \neq i}$. By (σ_{-i}, τ_i) or $(\sigma \mid \tau_i)$ we denote the strategy profile where every player $j \neq i$ adheres to strategy σ_j , while player i uses τ_i . A strategy $\tau_i \in \Delta(A_i)$ is called a best response of player i to the strategy profile $\sigma \in \Delta(A)$ if $u_i(\sigma \mid \tau_i) \geq u_i(\sigma \mid \rho_i)$ for all $\rho_i \in \Delta(A_i)$. A strategy profile $\sigma = (\sigma_i)_{i \in N}$ is a Nash equilibrium if

$$u_i(\sigma) \geq u_i(\sigma \mid \tau_i)$$

for all i and all $\tau_i \in \Delta(A_i)$. So, σ is a Nash equilibrium if each σ_i is a best response to σ .

For a non-empty compact subset X_i of A_i and strategy profile σ

$$BR_i(\sigma \mid X_i) = \{\rho_i \in \Delta(X_i) \mid u_i(\sigma \mid \rho_i) \geq u_i(\sigma \mid \tau_i) \text{ for all } \tau_i \in \Delta(X_i)\}$$

is the set of player i 's best strategies against σ given that the pure choices of player i are restricted to actions in X_i . Moreover, let $BR_i(\sigma) = BR_i(\sigma \mid A_i)$. An action $a_i \in A_i$ is a pure best response of player i to σ if $\delta(a_i) \in BR_i(\sigma)$. By $PBR_i(\sigma \mid X_i)$ we denote the set of those actions of player i that belong to $BR_i(\sigma \mid X_i)$ and $PBR_i(\sigma) = PBR_i(\sigma \mid A_i)$. The set $PBR_i(\sigma)$ is non-empty by compactness of A_i and continuity of u_i . Note that σ_i is a best response to σ if and only if it puts weight 1 on pure best responses, i.e., $\sigma_i(PBR_i(\sigma)) = 1$.

We say that $\tau_i \in \Delta(A_i)$ dominates $\sigma_i \in \Delta(A_i)$ if

$$u_i(\sigma \mid \tau_i) \geq u_i(\sigma \mid \sigma_i)$$

for all strategy profiles $\sigma \in \Delta(A)$, and the inequality is strict for at least one strategy profile $\sigma \in \Delta(A)$. Note that we use “dominates” rather than “weakly dominates”, due to the already heavy use of the adjective “weak” in this . The reader should be aware though that our use of dominance is slightly different from standard game theoretic use of this notion.

A strategy τ_i is dominant if $u_i(\sigma \mid \tau_i) \geq u_i(\sigma \mid \sigma_i)$ for all $\sigma \in \Delta(A)$ and $\sigma_i \in \Delta(A_i)$. The set of all dominant strategies for player i is denoted by D_i . Equivalently,

²With a slight abuse of notation we implicitly identify each strategy profile $\sigma = (\sigma_i)_{i \in N}$ with its induced probability distribution in $\Delta(A)$. Obviously not every element of $\Delta(A)$ can be obtained this way. We restrict attention to the independent elements of $\Delta(A)$ that are induced by strategy profiles.

D_i is the set of those strategies of player i that are a best response against any strategy profile. Obviously D_i may be empty.

If there is no τ_i that dominates σ_i , we say that σ_i is undominated. We denote the set of undominated strategies of player i by U_i . We write $\sigma_i \in LU_i$ if there exists a sequence $(\sigma_i^k)_{k \in \mathbf{N}}$ such that $\rho^w(\sigma_i^k, \sigma_i) \rightarrow 0$ as $k \rightarrow \infty$, and σ_i^k is undominated for all k .⁴ For $a_i \in A_i$ we write $a_i \in PU_i$, if a_i is not dominated by any $\sigma_i \in \Delta(A_i)$. Following S&S (1995), a strategy σ_i is limit admissible if $\sigma_i(\overline{PU_i}) = 1$, where $\overline{PU_i}$ denotes the closure of the set PU_i .

Every limit undominated strategy is also limit admissible. The converse does not hold though, not even for finite strategic form games.

EXAMPLE 1. In the table below the payoff matrix of player 2 is given:

$$u_2 = \begin{bmatrix} 4 & 0 & 3 \\ 0 & 4 & 3 \end{bmatrix}.$$

The strategy $\sigma_2 = (\frac{1}{2}, \frac{1}{2}, 0)$ is limit admissible for player 2. Nevertheless, σ_2 is dominated by $(0, 0, 1)$.⁵

2.3 Perfect equilibrium

Selten [41] introduced the notion of perfect equilibrium for non-cooperative extensive form games. The definition of perfect equilibrium is based on the idea that a satisfactory interpretation of equilibrium points should accommodate possible slight mistakes. Selten showed that perfect equilibrium exists for finite extensive form games with perfect recall.

Twenty years later Simon and Stinchcombe [42] provided a general treatment of perfect equilibria for infinite strategic form games with compact action spaces and continuous payoffs. S&S discuss two distinct approaches to perfect equilibrium for infinite normal form games. In the first approach, as in Selten's original definition, players may "tremble", modeled by having players choose completely mixed strategies. Players are then required to play approximate best responses to opponents' trembling strategies. In the strong version of the first approach, a tremble assigns high probability to the set of pure best responses itself, while in the weak version a tremble is only required to assign high probability to a neighborhood of this set. The second, limit-of-finite, approach applies traditional refinements to sequences of

successively larger finite approximations of the original infinite game. S&S proved the existence of these three generalized notions of perfect equilibrium. Moreover, they showed that the set of strongly perfect equilibria is a closed, non-empty subset of the set of weakly perfect equilibria, which is a closed subset of the collection of limit admissible Nash equilibria.

Both the strong and weak versions of the first approach of S&S use a direct generalization of the notion of completely mixed strategies in the definition of perfect equilibrium. Let $\varepsilon > 0$. A completely mixed strategy profile $\sigma = (\sigma_i)_{i \in N}$ in $\Delta(A)$ is a strongly ε -perfect equilibrium if for every player $i \in N$ it holds that $\rho^s(\sigma_i, BR_i(\sigma)) < \varepsilon$. It is a weakly ε -perfect equilibrium if $\rho^w(\sigma_i, BR_i(\sigma)) < \varepsilon$.

Definition 2.3.1 (Simon and Stinchcombe) A strategy profile σ is a strongly (respectively weakly) perfect equilibrium if there is a sequence $(\sigma^k)_{k=1}^\infty$ of strongly (weakly) $\frac{1}{k}$ -perfect equilibria with $\rho^w(\sigma^k, \sigma) \rightarrow 0$ as $k \rightarrow \infty$.

In order to guarantee existence of limit points, the above definition only considers weak limits of ε -perfect equilibria. Finitistic perfection is based on a different approach where games with infinite action spaces are approximated by games with large, but still finite, action spaces. Recall that compact metric action spaces are separable.

Definition 2.3.2 (Simon and Stinchcombe) A strategy profile $\sigma = (\sigma_i)_{i \in N}$ is a limit-of-finite (lof) perfect equilibrium if for every player $i \in N$ there is a sequence $(B_i^k)_{k=1}^\infty$ of finite subsets of A_i and a sequence $(\sigma_i^k)_{k=1}^\infty$ of completely mixed strategies in $\Delta(B_i^k)$ such that for every $i \in N$

- [1] for every $\varepsilon > 0$ there is a $K \in \mathbf{N}$ such that for each $k > K$ and for each $a_i \in A_i$ there is a $b_i \in B_i^k$ with $d_{A_i}(a_i, b_i) < \varepsilon$,⁶
- [2] $\rho^w(\sigma_i^k, \sigma_i) \rightarrow 0$ as $k \rightarrow \infty$,
- [3] $\sum_{x \in PBR_i(\sigma^k | B_i^k)} \sigma_i^k(x) \rightarrow 1$ as $k \rightarrow \infty$ (where $\sigma^k = (\sigma_i^k)_{i \in N}$).⁷

This definition has quite some appeal given our basic intuition that infinite games often serve as a proxy for large finite games, and that therefore strategic behavior should carry over from the finite setting to infinite games.

Despite this basic intuition, S&S already noted that, even in games where players have a dominant action, lof perfection may fail to eliminate Nash equilibria that do

not use the dominant action (S&S, Example 2.1). The following example illustrates these features of S&S Examples 2.1 and 2.4 in a more straightforward game.

EXAMPLE 2. The action spaces are $A_1 = \{T, B\}$ and $A_2 = \{0, 1, 2, \dots, \infty\}$, where all natural numbers are isolated points, whereas ∞ is the limit point of the sequence $0, 1, 2, 3, \dots$. The payoffs for the players are given by

$$u_1 = \begin{bmatrix} 1 & 1 & 1 & \dots & 1 \\ 0 & 0 & 0 & \dots & 0 \end{bmatrix} \quad \text{and} \quad u_2 = \begin{bmatrix} 0 & -1 & -\frac{1}{2} & -\frac{1}{3} & -\frac{1}{4} & \dots & 0 \\ 0 & 0 & \frac{1}{2} & \frac{2}{3} & \frac{3}{4} & \dots & 1 \end{bmatrix}$$

Claim. The action pair $(a_1, a_2) = (T, 0)$ is a lof perfect Nash equilibrium. However, $a_2 = 0$ is dominated by the (dominant) pure action $b_2 = \infty$.

Proof. We show that $(a_1, a_2) = (T, 0)$ is lof perfect. Take $B_1^k = A_1 = \{T, B\}$ and $B_2^k = \{0, 1, \dots, k\}$. Take a natural number $m > k$. Take $\sigma_1^k = (1 - \frac{1}{m})\delta(T) + \frac{1}{m}\delta(B)$ and $\sigma_2^k = (1 - \frac{1}{k})\delta(0) + \frac{1}{k^2}\delta(1) + \dots + \frac{1}{k^2}\delta(\infty)$. Clearly $\rho^w(\sigma_1^k, a_1) \rightarrow 0$ and $\rho^w(\sigma_2^k, a_2) \rightarrow 0$ as $k \rightarrow \infty$. Also [1] of Definition 4.2 is straightforward to check. We show that σ_1^k and σ_2^k satisfy condition [3] of Definition 4.2. It is trivial for player 1, since T is strictly dominates B for player 1.

We compute the payoff of a pure action $\ell \in B_2^k$ for player 2 against σ_1^k . If $\ell = 0$, the payoff is evidently zero. Suppose $\ell \neq 0$. Then, since $\ell \leq k < m$, the payoff is

$$-(1 - \frac{1}{m}) \cdot \frac{1}{\ell} + \frac{1}{m} \cdot (1 - \frac{1}{\ell}) = -\frac{1}{\ell} + \frac{1}{m \cdot \ell} + \frac{1}{m} - \frac{1}{m \cdot \ell} = \frac{1}{m} - \frac{1}{\ell} < 0.$$

Hence, σ_2^k puts weight $1 - \frac{1}{k}$ on the pure best response within the set B_2^k , and $(a_1, a_2) = (T, 0)$ is lof perfect indeed. \blacksquare

In order to circumvent this drawback, S&S introduced the notion of anchored perfect equilibrium. Let $F = \prod_{i \in N} F_i \subseteq A$ be finite.

Definition 2.3.3 (Simon and Stinchcombe) A strategy profile $\sigma = (\sigma_i)_{i \in N}$ is said to be anchored at F if for every player $i \in N$ there is a sequence $(B_i^k)_{k=1}^\infty$ of finite subsets of A_i with $F_i \subseteq B_i^k$ for every i and k , and a sequence $(\sigma_i^k)_{k=1}^\infty$ of completely mixed strategies in $\Delta(B_i^k)$ such that for every $i \in N$

[1] for every $\varepsilon > 0$ there is a $K \in \mathbf{N}$ such that for each $k > K$ and for each $a_i \in A_i$ there is a $b_i \in B_i^k$ with $d_{A_i}(a_i, b_i) < \varepsilon$,⁸

[2] $\rho^w(\sigma_i^k, \sigma_i) \rightarrow 0$ as $k \rightarrow \infty$,

[3] $\sum_{x \in PBR_i(\sigma^k | B_i^k)} \sigma_i^k(x) \rightarrow 1$ as $k \rightarrow \infty$ (where $\sigma^k = (\sigma_i^k)_{i \in N}$).⁹

A strategy profile $\sigma = (\sigma_i)_{i \in N}$ is an anchored perfect equilibrium if σ is anchored at F for every possible finite set $F = \prod_{i \in N} F_i \subseteq A$.

It is clear that the equilibrium $(a_1, a_2) = (T, 0)$ from Example 1 is not anchored perfect. So, as S&S already noted, anchored perfection does move the finitistic approach closer to satisfying admissibility. However, because of the condition that we need to construct an approximating sequence *for every possible finite subset* F of A , anchored perfection is in general quite difficult to verify (or to falsify for that matter). We propose the following modification of lof perfection.

Definition 2.3.4 A strategy profile $\sigma = (\sigma_i)_{i \in N}$ is a strongly global-limit-of-finite (strongly glof) perfect equilibrium if in Definition 4.2 condition [3] is replaced by

$$[4] \quad \rho^s(\sigma_i^k, BR_i(\sigma^k)) \rightarrow 0 \text{ as } k \rightarrow \infty.$$

In comparison with condition [3], note that condition [4] is equivalent to

$$\sum_{x \in B_i^k \cap PBR_i(\sigma^k)} \sigma_i^k(x) \rightarrow 1 \text{ as } k \rightarrow \infty.$$

The strategy profile $\sigma = (\sigma_i)_{i \in N}$ is a weakly glof perfect equilibrium if in Definition 4.2 condition [3] is replaced by

$$[5] \quad \rho^w(\sigma_i^k, BR_i(\sigma^k)) \rightarrow 0 \text{ as } k \rightarrow \infty.$$

As we demonstrate in the examples in this chapter, our modification of lof perfection is still comparatively straightforward to check, since it only involves construction of a single approximating sequence as in the definition of lof perfection. Moreover we show that our modification exclusively selects dominant strategies in case such strategies are available to a player. The main idea of the definition is that each player i has to choose the probabilities with which he plays the actions in the finite approximation B_i^k of his action space A_i in such a way that the resulting probability distribution on B_i^k is still close to his true best response in the action space A_i itself given the strategies chosen by his opponents. This is in contrast to lof perfection in which attention is restricted only to the best responses within the finite approximation B_i^k of A_i .

S&S introduced the method of anchoring as a partial-remedy to the failure of lof perfection to select limit admissible strategies. Nevertheless, anchoring still allows for the possibility that, no matter which set we selected a priori, best responses are not in the selected pure actions along the sequence. Our approach is more flexible in

the sense that the inclusion of best responses is required to be contingent on the approximating sequence of strategy profiles we consider. Moreover, as already noted, checking anchored perfection requires us to construct an approximating sequence for every possible finite set $F \subseteq A$, while glof perfection only requires construction of a single approximating sequence.

Simon and Stinchcombe established existence of lof perfect and anchored perfect equilibrium. We show that weakly glof perfect equilibrium exists, and that every weakly glof perfect equilibrium is a Nash equilibrium. The rather lengthy proof is deferred to Appendix A.

Theorem 2.3.5 *The set of weakly glof perfect equilibria of every strategic form game with compact action spaces and continuous payoff functions is a non-empty subset of the Nash equilibria that is closed with respect to the weak metric.*

Since clearly every strongly glof perfect equilibrium is also weakly glof, both strong and weak glof perfection refines the set of Nash equilibria. Existence of strongly glof perfect equilibrium remains an open question.

2.4 Admissibility

In this section we analyze the relation between the various notions of perfection and admissibility. We show that weak perfection exclusively selects limit undominated strategies. We also show that this statement is a genuine generalization of the classical result for finite games that perfection implies undominatedness.

For the finitistic approach the connection to admissibility is much weaker. As said before in Example 2 of this chapter, Example 2.4 of S&S already presents a lof perfect equilibrium that does not select the unique dominant strategy. We show that glof perfection performs better: for every game in which a player has dominant strategies, glof perfect equilibrium exclusively selects equilibria in which such a player plays one of his dominant strategies. However, the analogous result for undominated strategies again fails to hold. Example 3 presents a two-player game with a strongly glof perfect equilibrium in which both players play dominated strategies that are not limits of undominated strategies.

Weak perfection and admissibility

S&S already showed that weakly perfect equilibrium is limit admissible. In this section we show the somewhat stronger claim that weakly perfect equilibrium strategies

are limit undominated. We also show that this is the exact analogue of the classical result for finite games that perfect equilibrium strategies are undominated.

Theorem 2.4.1 *Let σ be a weakly perfect equilibrium. Then $\sigma_i \in LU_i$ for each i .*

Proof. By Definition 4.1 and Theorem 3.2 of Billingsley [6], there exists a sequence of completely mixed strategy profiles $\sigma^k = (\sigma_i^k)_{i \in N}$ such that for every $i \in N$ we have $\rho^w(\sigma_i^k, \sigma_i) \rightarrow 0$ and $\rho^w(\sigma_i^k, BR_i(\sigma^k)) \rightarrow 0$ as $k \rightarrow \infty$.

So, for every $i \in N$, there is a sequence $\tau_i^k \in BR_i(\sigma^k)$ with $\rho^w(\sigma_i^k, \tau_i^k) \rightarrow 0$ as $k \rightarrow \infty$. Therefore, by the triangle inequality, $\rho^w(\tau_i^k, \sigma_i) \rightarrow 0$ as $k \rightarrow \infty$. Since τ_i^k is a best response against the completely mixed profile σ^k , by Lemma 2.9.2, τ_i^k is undominated. Therefore σ_i is limit undominated. ■

At first glance Theorem 2.4.1 seems to be a compromise between the well-known result for finite normal form games that the strategies in a perfect equilibrium are undominated, and the transition to infinite compact action spaces. The following Proposition shows that this compromise is only seemingly, since for finite games limit undominated strategies are in fact undominated.

Proposition 2.4.2 *For strategic form games with finite action spaces, the set U_i is closed, so that $U_i = LU_i$ for such games.*

Proof. To prove that the set of undominated strategies is closed, we show that the set of dominated strategies is open. Suppose σ_i is dominated by τ_i . We prove that there is an open set $V \ni \sigma_i$ such that every $\nu_i \in V$ is dominated as well. Define $\varepsilon = \frac{1}{2} \min\{\sigma_i(a) \mid a \in A_i \text{ and } \sigma_i(a) > 0\}$. Since A_i is a finite set, $\varepsilon > 0$. Define

$$V = \{\nu_i \in \Delta(A_i) \mid \|\nu_i - \sigma_i\|_\infty < \varepsilon\}.$$

Here, $\|\cdot\|_\infty$ denotes the maximum norm. Take $\nu_i \in V$. Write $\mu_i = 2\nu_i - \sigma_i$. We show that $\mu_i \in \Delta(A_i)$. Note that if $\sigma_i(a) = 0$ then $\mu_i(a) \geq 0$. Now assume that $\sigma_i(a) > 0$. Since $\|\nu_i - \sigma_i\|_\infty < \varepsilon$, we have

$$|\nu_i(a) - \sigma_i(a)| < \varepsilon \leq \frac{1}{2}\sigma_i(a).$$

Consequently, $\mu_i(a) = 2\nu_i(a) - \sigma_i(a) = 2\nu_i(a) - 2\sigma_i(a) + \sigma_i(a) > 0$. Because $\sum_{a \in A_i} \mu_i(a) = 1$ clearly holds, we obtain $\mu_i \in \Delta(A_i)$.

We show that $\nu_i = \frac{1}{2}\sigma_i + \frac{1}{2}\mu_i$ is dominated by $\frac{1}{2}\tau_i + \frac{1}{2}\mu_i$. As σ_i is dominated by τ_i , there is a strategy profile $\rho_{-i} \in \Delta(A_{-i})$ such that $u_i(\rho_{-i}, \tau_i) > u_i(\rho_{-i}, \sigma_i)$.

Since u_i is linear in each player's strategy we have

$$\begin{aligned} u_i(\rho_{-i}, \frac{1}{2}\tau_i + \frac{1}{2}\mu_i) &= \frac{1}{2}u_i(\rho_{-i}, \tau_i) + \frac{1}{2}u_i(\rho_{-i}, \mu_i) \\ &> \frac{1}{2}u_i(\rho_{-i}, \sigma_i) + \frac{1}{2}u_i(\rho_{-i}, \mu_i) \\ &= u_i(\rho_{-i}, \frac{1}{2}\sigma_i + \frac{1}{2}\mu_i). \end{aligned}$$

Similarly we conclude for every $\sigma_{-i} \in \Delta(A_{-i})$ that

$$u_i(\sigma_{-i}, \frac{1}{2}\tau_i + \frac{1}{2}\mu_i) \geq u_i(\sigma_{-i}, \frac{1}{2}\sigma_i + \frac{1}{2}\mu_i).$$

Hence, $\nu_i = \frac{1}{2}\sigma_i + \frac{1}{2}\mu_i$ is dominated by $\frac{1}{2}\tau_i + \frac{1}{2}\mu_i$. ■

Finitistic perfection and admissibility

The relation between finitistic perfection and admissibility is much weaker than it is for weakly perfect equilibrium. Example 2 already shows that, even in games with dominant actions, lof perfection does not exclusively select equilibria in limit admissible strategies.

We show that our alternative definition of finitistic perfection, glof perfect equilibrium, does select only dominant strategies in case such strategies are available to a player. In an example we show that for games without dominant strategies also glof perfect equilibrium may use strategies that are not limit admissible.

Write $PD_i := \{a_i \in A_i \mid \delta(a_i) \in D_i\}$. In Appendix B we show that D_i is closed with respect to the weak metric in $\Delta(A_i)$, that PD_i is closed in A_i , and that $D_i = \Delta(PD_i)$.

Theorem 2.4.3 *Let $\sigma \in \Delta(A)$ be a weakly glof equilibrium. Suppose that D_i is not empty. Then $\sigma_i \in D_i$.*

Proof. Because σ is a weakly glof equilibrium, for every player i there is a sequence $(\sigma_i^k)_{k=1}^\infty$ such that $\rho^w(\sigma_i^k, \sigma_i) \rightarrow 0$ and $\rho^w(\sigma_i^k, BR_i(\sigma^k)) \rightarrow 0$ as $k \rightarrow \infty$. So, for every k we can take $\tau_i^k \in BR_i(\sigma^k)$ such that $\rho^w(\sigma_i^k, \tau_i^k) \rightarrow 0$ as $k \rightarrow \infty$. Then, by the triangle inequality for ρ^w , also $\rho^w(\sigma_i, \tau_i^k) \rightarrow 0$ as $k \rightarrow \infty$.

Suppose that D_i is not empty. Then, by Proposition 2.9.4, PD_i is not empty either. Let $U \supset PD_i$ be open. First we show that $\tau_i^k(U) = 1$ for sufficiently large k . When $U = A_i$, this is evident. Suppose $U \neq A_i$. Take $a_i \in A_i \setminus U$ and $b_i \in PD_i$. By Lemma 2.9.1, there is an $a_{-i} \in A_{-i}$ such that

$$u_i(b_i, a_{-i}) > u_i(a_i, a_{-i}).$$

Since u_i is continuous, there are open sets $V(a_i) \ni a_i$ and $W(a_{-i}) \ni a_{-i}$ such that for every $x_i \in V(a_i)$ and $x_{-i} \in W(a_{-i})$ we have

$$u_i(b_i, x_{-i}) > u_i(x_i, x_{-i}).$$

Take $x_i \in V(a_i)$. Since b_i is a dominant strategy, we have

$$u_i(b_i, y_{-i}) \geq u_i(x_i, y_{-i})$$

for every $y_{-i} \in A_{-i}$. Further, define $B_{-i}^k = \prod_{j \neq i} B_j^k$. Then $B_{-i}^k \cap W(a_{-i}) \neq \emptyset$ for large k by Definition 4.3. So, since σ_{-i}^k is a completely mixed strategy in $\Delta(B_{-i}^k)$, we know that

$$u_i(b_i, \sigma_{-i}^k) > u_i(x_i, \sigma_{-i}^k)$$

for large k . Hence, for large k , x_i is not a best response to σ^k . We conclude for every $a_i \in A_i \setminus U$ that

$$V(a_i) \cap PBR_i(\sigma^k) = \emptyset$$

for large k . Now note that $A_i \setminus U$ is compact, since it is a closed subset of a compact set. Therefore, there are actions a_i^1, \dots, a_i^p in $A_i \setminus U$ such that $A_i \setminus U$ is a subset of $\bigcup_{r=1}^p V(a_i^r)$. Moreover,

$$PBR_i(\sigma^k) \cap \bigcup_{j=1}^p V(a_i^j) = \emptyset$$

for large k . Consequently $PBR_i(\sigma^k) \subseteq U$ for large k . But $\tau_i^k \in BR_i(\sigma^k)$, so that $\tau_i^k(PBR_i(\sigma^k)) = 1$ for all k . Hence, $\tau_i^k(U) = 1$ for large k , as claimed.

We show that $\sigma_i \in D_i$. Take $\varepsilon > 0$. Since $\rho^w(\sigma_i, \tau_i^k) \rightarrow 0$ as $k \rightarrow \infty$,

$$\tau_i^k(U) - \varepsilon \leq \sigma_i(U^\varepsilon)$$

for large k . Because $\tau_i^k(U) = 1$ for large k , we get $1 - \varepsilon \leq \sigma_i(U^\varepsilon)$. Since $\varepsilon > 0$ and $U \supseteq PD_i$ were chosen arbitrarily, and since PD_i is a closed set, we can conclude that $\sigma_i(PD_i) = 1$. Hence, $\sigma_i \in \Delta(PD_i) = D_i$. \blacksquare

Theorem 2.4.3 shows that in games where players have dominant strategies, weak glof perfection can only select those equilibria in which dominant strategies are played. However, the next example shows that, in games where players do not have dominant strategies, even strong glof perfection may fail to exclusively select equilibria in limit admissible strategies.

EXAMPLE 3. The action spaces are

$$A_1 = A_2 = \{-\infty, \dots, -3, -2, -1, 1, 2, 3, \dots, \infty\},$$

in which each integer is an isolated point, whereas $-\infty$ is the limit of the sequence $-1, -2, \dots$ and ∞ is the limit of the sequence $1, 2, \dots$. The topological structure is shown in the picture below.



The payoff functions u_1 and u_2 are symmetric and u_1 is given in the table below.

\vdots	\vdots	\ddots	\vdots	\vdots	\vdots	\vdots	\vdots	\vdots	\ddots	\vdots

Player 1 is the row player, and player 2 is the column player.

Claim. The action pair (∞, ∞) is a strongly glof perfect equilibrium. However, ∞ is not limit admissible for either player.

Proof. For either player, ∞ is not limit admissible because ∞ is dominated by every action $k \in \mathbb{Z}$, and every action $k \in \mathbb{N}$ is dominated by action $-k$.

Now, we prove that $\sigma = (\infty, \infty)$ is a strongly glof perfect equilibrium. For every player $i = 1, 2$ and $k \in \mathbb{N}$, let $B_i^k = \{-k, \dots, -1, 1, \dots, k+1\}$ and let σ_i^k be the completely mixed strategy on B_i^k which assigns probability $\frac{1}{(k+2)^2}$ to every action in B_i^k except action $k+1$ and assigns probability $(1 - \frac{2k}{(k+2)^2})$ to action $k+1$. It is clear

that $(B_i^k)_{k=1}^\infty$ satisfies the first condition of Definition 4.4. Since $\rho^w(\sigma_i^k, \sigma_i) \rightarrow 0$ for $i = 1, 2$ as $k \rightarrow \infty$, the second condition also holds. Using the payoff table, one can verify that strategies $(-k - 1)$ and $(k + 1)$ are the best responses for player 1 against σ_2^k in A_1 . Due to symmetry, the same holds for player 2. Thus,

$$\rho^s(\sigma_i^k, BR_i(\sigma^k)) = 1 - \left(1 - \frac{2k}{(k+2)^2}\right) = \frac{2k}{(k+2)^2},$$

which tends to zero as $k \rightarrow \infty$. Hence, condition [4] of Definition 4.4 is valid as well, and σ is a strongly glof perfect equilibrium. ■

2.5 Relations between definitions of perfect equilibrium

Simon and Stinchcombe [42] conjectured (on page 1433) that there are strongly perfect equilibria that are not anchored perfect. We provide a concrete example of a completely mixed, and therefore surely strongly perfect, equilibrium that is neither lof perfect nor glof perfect (and therefore also not anchored perfect). Thus, the finitistic approach to perfection does not have a straightforward logical relation to the trembling hand approach.

EXAMPLE 4. The action spaces are $A_1 = A_2 = \{1, 2, 3, \dots, \infty, \infty + 1\}$, where all natural numbers and $\infty + 1$ are isolated points, whereas ∞ is the limit of the sequence $1, 2, \dots$. The topology is shown in the picture below:



The payoff functions u_1 and u_2 are symmetric and u_1 is given in the table below.

u_1	1	2	3	4	...	∞	$\infty + 1$

Define the strategies σ_1 and σ_2 by

$$\sigma_1 = \sigma_2 = \frac{1}{4} \cdot \delta(1) + \frac{1}{8} \cdot \delta(2) + \frac{1}{16} \cdot \delta(3) + \dots + \frac{1}{4} \cdot \delta(\infty) + \frac{1}{4} \cdot \delta(\infty + 1).$$

Claim. The strategy profile (σ_1, σ_2) is a completely mixed, and hence strongly perfect equilibrium. However, it is neither lof perfect nor weakly glof perfect. This verifies the conjecture of S&S [42].¹⁰

Proof. It is clear that (σ_1, σ_2) is a completely mixed Nash equilibrium. Hence, it is a strongly perfect equilibrium.

We show that the completely mixed equilibrium is not lof perfect. Suppose by way of contradiction that (σ_1, σ_2) is lof perfect. For every player i , take a sequence $(B_i^k)_{k=1}^\infty$ of finite subsets of A_i and a sequence of strategies $(\sigma_i^k)_{k=1}^\infty$ that satisfy the conditions in Definition 4.2. Let m_k and n_k be the largest positive integers in the sets B_1^k and B_2^k , respectively. Since $\infty + 1$ is an isolated point of the action sets, for large k each B_i^k includes $\infty + 1$. Moreover, for large k , $\infty + 1$ must be a best response for player 1 against σ_2^k among B_1^k , because σ_1 places positive probability on $\infty + 1$. As strategy $\infty + 1$ has payoff zero for player 1, for large k player 1 cannot have an action in B_1^k which gives him a positive payoff against σ_2^k . Since player 1 would get a positive payoff for every action $m \geq n_k$, we have $m_k < n_k$. Then also $n_k < m_k$ by symmetry, which is a contradiction. By similar arguments the completely mixed equilibrium is not weakly glof either. ■

We continue with a discussion of the relations between the different approaches to finitistic perfect equilibrium.

Proposition 2.5.1 *Every strongly glof perfect equilibrium is lof perfect.*

Proof. Suppose that $\sigma = (\sigma_i)_{i \in N}$ is a strongly glof perfect equilibrium. Then, for every $i \in N$, there is a sequence $(B_i^k)_{k=1}^\infty$ of finite subsets of A_i and a sequence of strategies $(\sigma_i^k)_{k=1}^\infty$ that satisfy the conditions in Definition 4.4. We show that they also satisfy condition [3] of Definition 4.2. Since for every i , we have $\rho^s(\sigma_i^k, BR_i(\sigma^k)) \rightarrow 0$ as $k \rightarrow \infty$, there exists a sequence $(\mu_i^k)_{k=1}^\infty$ such that $\mu_i^k \in BR_i(\sigma^k)$ for every $k \in \mathbb{N}$ and $\rho^s(\sigma_i^k, \mu_i^k) \rightarrow 0$ as $k \rightarrow \infty$. As u_i is a continuous function, $PBR_i(\sigma^k)$ is a closed, hence Borel, subset of the action space A_i . Moreover, since best responses put weight 1 on pure best responses,

$$\rho^s(\sigma_i^k, \mu_i^k) \geq \frac{\left| \sigma_i^k(PBR_i(\sigma^k)) - \mu_i^k(PBR_i(\sigma^k)) \right|}{\left| \sigma_i^k(PBR_i(\sigma^k)) - 1 \right|}$$

¹⁰Their conjecture only concerns *anchored* perfect equilibrium. We show the *stronger* claim that the completely mixed equilibrium is even not a lof perfect equilibrium.

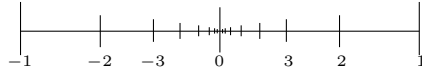
for every i and k . So, $\sigma_i^k(PBR_i(\sigma^k)) \rightarrow 1$ as $k \rightarrow \infty$. This implies that for large k , player i has a pure best response to σ^k which lies in B_i^k . Consequently, $\sigma_i^k(PBR_i(\sigma^k | B_i^k)) \rightarrow 1$ as $k \rightarrow \infty$, and σ is a lof perfect equilibrium. ■

Theorem 2.4.3 shows that the lof perfect equilibrium in Example 1 is not weakly glof perfect (and hence not strongly glof perfect either). Next we present an example of a weakly glof perfect equilibrium that is not lof perfect. Consequently, lof perfection and weak glof perfection are not comparable.

EXAMPLE 5. In this game the action spaces are

$$A_1 = A_2 = \{-1, -2, -3, \dots, 0, \dots, 3, 2, 1\},$$

where all integers except 0 are isolated points, whereas 0 is the limit point of the sequences $-1, -2, \dots$ and $1, 2, \dots$. The topological structure is shown in the picture below.



The topology can be metrized by the following metric. For every $k, l \in A_i$,

$$d(k, l) = \begin{cases} 0 & \text{if } k = l = 0 \\ \left| \frac{1}{l} \right| & \text{if } k = 0 \text{ and } l \neq 0 \\ \left| \frac{1}{k} \right| & \text{if } k \neq 0 \text{ and } l = 0 \\ \left| \frac{1}{k} - \frac{1}{l} \right| & \text{if } k \neq 0 \text{ and } l \neq 0. \end{cases}$$

The payoff functions u_1 and u_2 are symmetric and u_1 is given in the table below.

u_1	-1	-2	-3	...	0	...	+3	+2	+1
-1	1	$\frac{1}{2}$	$\frac{1}{3}$...	0	...	0	0	1

Claim. The Nash equilibrium $(\sigma_1, \sigma_2) = (0, 0)$ is weakly glof perfect. However, (σ_1, σ_2) is not lof perfect, and therefore by Proposition 2.5.1 not strongly glof perfect either.

Proof. We show that (σ_1, σ_2) is a weakly glof perfect. For every $k \in \mathbf{N}$, define $\varepsilon_k = \frac{1}{k(k+3)}$. Moreover, for $k \in \mathbf{N}$ and $i = 1, 2$, write

$$B_i^k = \{-1, -2, \dots, -k\} \cup \{k, \dots, 2, 1\}.$$

Let σ_i^k be the completely mixed strategy on B_i^k that assigns probability ε_k to every action in B_i^k except action k , to which it assigns probability $1 - (2k - 1)\varepsilon_k$. Note that due to the choice of ε_k , we have $1 - (2k - 1)\varepsilon_k > \varepsilon_k > 0$. It is clear that conditions [1] and [2] of Definition 4.4 are satisfied. It remains to verify that condition [5] holds as well. According to the payoff table, player 1's pure best response to σ_2^k is either -1 or $-k$. Since for every $k \geq 2$ we have

$$\begin{aligned} u_1(\delta(-1), \sigma_2^k) &= \varepsilon_k \left(1 + \frac{1}{2} + \frac{1}{3} + \dots + \frac{1}{k} + 1\right) \\ &\leq \varepsilon_k(k + 1) \\ &< (1 - (2k - 1)\varepsilon_k) \frac{1}{k} \\ &= u_1(\delta(-k), \sigma_2^k), \end{aligned}$$

player 1's unique best response against σ_2^k is $-k$. We prove that

$$\rho^w(\sigma_1^k, BR_1(\sigma^k)) = \rho^w(\sigma_1^k, \delta(-k)) \leq \frac{2}{k}.$$

Let $\varepsilon > \frac{2}{k} = d(-k, k)$. It is easy to see that $(2k-1)\varepsilon_k \leq \varepsilon$. Take an arbitrary set $B \subseteq A_1$.

A. We show that $\delta(-k)(B) \leq \sigma_1^k(B^\varepsilon) + \varepsilon$. If $-k \notin B$. Then

$$\delta(-k)(B) = 0 \leq \sigma_1^k(B^\varepsilon) + \varepsilon.$$

If $-k \in B$. Then $k \in B^\varepsilon$. So

$$\delta(-k)(B) = 1 \leq (1 - (2k-1)\varepsilon_k) + \varepsilon = \sigma_1^k(k) + \varepsilon \leq \sigma_1^k(B^\varepsilon) + \varepsilon.$$

B. We show that $\sigma_1^k(B) \leq \delta(-k)(B^\varepsilon) + \varepsilon$. If $-k \in B$. Then

$$\sigma_1^k(B) \leq 1 < 1 + \varepsilon = \delta(-k)(B^\varepsilon) + \varepsilon$$

If $-k \notin B$ and $k \notin B$. Then

$$\sigma_1^k(B) \leq (2k-1)\varepsilon_k \leq \varepsilon \leq \delta(-k)(B^\varepsilon) + \varepsilon.$$

If $-k \notin B$ and $k \in B$. Then $-k \in B^\varepsilon$. So

$$\sigma_1^k(B) \leq 1 + \varepsilon = \delta(-k)(B^\varepsilon) + \varepsilon.$$

So, by **A**, **B**, and the choice of ε , $\rho^w(\sigma_1^k, \delta(-k)) \leq \frac{2}{k}$. Since the payoff functions are symmetric this argument is also valid for the second player. Therefore, condition [5] of Definition 4.4 holds and σ is a weakly glof perfect equilibrium as claimed ¹¹.

We show that $(0, 0)$ is not lof perfect. Suppose the opposite. Then by Definition 4.2 for each $i = 1, 2$ there is non-empty finite subset B_i of A_i and a completely mixed strategy σ_i in $\Delta(B_i)$ such that

$$\sigma_i(PBR_i(\sigma | B_i)) \geq \frac{2}{3},$$

where $\sigma = (\sigma_1, \sigma_2)$. Since -1 is an isolated point, w.l.o.g. $-1 \in B_i$ for each $i = 1, 2$. Furthermore, $PBR_i(\sigma | B_i)$ is a subset of $\{-1, -2, \dots\}$. Define

$$M_i = -\min \{x \mid x \in PBR_i(\sigma | B_i)\} \quad \text{for } i = 1, 2.$$

¹¹Note that strategy σ_i^k puts almost all weight on pure action $+k$, which is in fact a worst pure action in terms of payoffs.

Assume w.l.o.g. that $M_1 \geq M_2$. Because $-M_1 \in PBR_1(\sigma \mid B_1)$ and $-1 \in B_1$ we have

$$u_1(\delta(-1), \sigma_2) \leq u_1(\delta(-M_1), \sigma_2).$$

Thus, according to the payoff table,

$$\frac{2}{3} \cdot \frac{1}{M_2} \leq u_1(\delta(-1), \sigma_2) \leq u_1(\delta(-M_1), \sigma_2) \leq \frac{1}{3} \cdot \frac{1}{M_1}.$$

Rewriting yields $\frac{M_2}{2} \geq M_1$. Consequently $\frac{M_2}{2} \geq M_2$. Contradiction. \blacksquare

Finally, notice that in the pure lof perfect equilibrium of Example 1, players 2 plays an action that is not just not limit admissible, it is even dominated by a unique dominant action. It follows from Theorem 2.4.3 that this equilibrium is not weakly glof.

2.6 Two players

For finite strategic form games it is well-known that perfection implies undominatedness. A similarly well-known theorem of van Damme (see for example van Damme [43], Theorem 3.2.2) states that for bimatrix games the converse implication also holds.

Theorem 2.6.1 *Let (p, q) be a strategy pair of the bimatrix game (A, B) . Equivalent are*

- [1] *The strategy pair (p, q) is a perfect equilibrium.*
- [2] *The strategy pair (p, q) is a Nash equilibrium and both p and q are undominated strategies.*

Theorem 2.4.1 and Proposition 2.4.2 show that, in the appropriately adjusted sense, the implication from [1] to [2] is also valid in the setting with infinite compact action spaces. A natural guess would be that the appropriately adjusted converse would also be true for two-player infinite games. However, the following example shows that the converse implication from [2] to [1] no longer holds for games with infinite action spaces. (In their Example 2 Méndez et al. [27] address the same issue in a game with interval action spaces.)

EXAMPLE 6. The action spaces are $A_1 = \{T, B\}$ and $A_2 = \{1, 2, 3, 4, \dots, \infty\}$, where all natural numbers are isolated points, whereas ∞ is the limit point of the sequence $1, 2, 3, \dots$. The payoffs for the players are given by

$$u_1 = \begin{bmatrix} 0 & 0 & 0 & \dots & 0 \\ 1 & 1 & 1 & \dots & 1 \end{bmatrix} \quad \text{and} \quad u_2 = \begin{bmatrix} 0 & \frac{1}{2} & \frac{1}{3} & \frac{1}{4} & \dots & 0 \\ 0 & -\frac{1}{4} & -\frac{1}{9} & -\frac{1}{16} & \dots & 0 \end{bmatrix}$$

Claim. The action pair $(B, 1)$ is a Nash equilibrium in undominated strategies, yet $(B, 1)$ is not a weakly perfect equilibrium.

Proof. Clearly $(B, 1)$ is a Nash equilibrium and actions B and 1 are undominated in A_1 and A_2 respectively.

We prove that the action pair $\sigma = (B, 1)$ is not a weakly perfect equilibrium. Take any completely mixed strategy $\tau_1 = (p, 1 - p)$ of player 1. Take a natural number $k > \frac{1-p}{p}$. Then $\frac{1-p}{k} < p$, so that

$$\begin{aligned} u_2(\tau_1, \delta(k)) &= p \cdot \frac{1}{k} - (1-p) \cdot \frac{1}{k^2} \\ &= \frac{1}{k} \cdot \left[p - \frac{1-p}{k} \right] \\ &> 0. \end{aligned}$$

Since $u_2(\tau_1, \delta(1)) = 0$, this implies that $\delta(1)$ is not a best response for player 2 against any completely mixed strategy of player 1. Hence, $\sigma = (B, 1)$ is not a weakly perfect equilibrium. ■

Note that the above example is in a very strong sense minimal. The action space A_2 is in a very natural way the “smallest” example of a compact set that is not finite. And also A_1 is minimal in the sense that it is the smallest example of an action space in which player 1 actually has a genuine choice to make.

2.7 Invariance

Another remarkable feature of the game in Example 6 is that (B, ∞) is a strongly (and hence also weakly) perfect equilibrium. This is surprising in the sense that ∞ is payoff equivalent to 1 for player 2. Thus, both strong and weak perfection violate invariance in this setting, while perfect equilibrium satisfies invariance in the setting of finite strategic form games (see for example Mertens [30] and Vermeulen and Jansen [44]).

The underlying cause of this seeming breakdown of invariance is that in the finite case the space of actions is, from a topological perspective, a very simple object. All actions are isolated points, and hence there is a homeomorphism that transforms one

into the other while the induced transformation on payoffs equals the identity in the case of payoff equivalence.

However, in the infinite case two actions giving the same payoff might be totally different from a topological perspective. Therefore, only conditional on having a homeomorphism that preserves payoffs, we can conclude that strong and weak perfection are invariant too. This result is stated in the following theorem.

Theorem 2.7.1 *Both strongly and weakly perfect equilibrium are invariant under payoff preserving homeomorphic transformations of the action spaces.*

Note that, for finite games, invariance with respect to payoff preserving homeomorphic transformations is in fact equivalent to invariance. Hence, the above Theorem implies that for finite strategic form games perfect equilibrium is invariant.

2.8 Discussion

We studied the relations between various generalizations of the basic notion of perfect equilibrium to the context of strategic form games with compact action spaces and continuous payoff functions. We showed the existence of weakly glof perfect equilibrium, and presented several examples of games with compact action spaces that clarify the relationships between admissibility, trembling hand perfect equilibrium, and finitistic perfect equilibrium.

Specifically, we showed in Example 6 that the equivalence between perfection and undominatedness for bimatrix games no longer holds for general two-person strategic form games with compact action spaces and continuous payoffs.

We also verified a conjecture of Simon and Stinchcombe [42] with an example of a completely mixed Nash equilibrium that is not perfect in any of the finitistic definitions. Example 3 shows that finitistic perfection may easily fail to be limit admissible, a fact that was already observed by Simon and Stinchcombe for lof perfection. Example 4 shows that a completely mixed equilibrium need not be perfect in any of the finitistic approaches.

In Example 4 the completely mixed equilibrium is part of a component of Nash equilibria, one of which is still finitistically perfect. It remains an open question whether an isolated completely mixed equilibrium is automatically perfect in the finitistic approach. Another possible question for future research is the existence of strongly glof perfect equilibrium.

Despite its appeal to basic intuition of the finitistic approach, our results (especially Examples 3 and 4) seem to imply a severe critique of the finitistic approach. The connection of the finitistic notions of perfection to admissibility and undominatedness seems hazy at best, and a cure for this—still somewhat surprising—failure of finitistic solutions on simple performance criteria such as undominatedness does not seem to be easily available. Still, as the anonymous referee pointed out, there may be an alternative interpretation for our results. Flipping our stance towards the finitistic approach—that finite games are “approximations” for the “true” infinite game we want to study—around, we could also adopt the view that all games people might ever encounter are finite. Under that view, infinite games function as “approximations” of large, but still finite, games. Infinite games in this view are only analytic tools, they are not the true game under consideration. Our results now show that this view, infinite games function as approximations of large finite games to facilitate computation of solutions, can no longer be maintained when we wish to apply perfect equilibrium as the central solution concept¹².

2.9 Appendix

Proof of Theorem 2.3.5

The proof of Theorem 2.3.5 is based on the fixed point Theorem of Kakutani. Since A_i is compact and metric, we know that it is totally bounded. Fix $k \in \mathbf{N}$. For every i , construct a finite subset B_i^k of A_i such that for every $a \in A_i$ there is a $b \in B_i^k$ with $d_{A_i}(a, b) \leq \frac{1}{k}$. Write $n_{ik} = |B_i^k|$, and $n_k = \max\{n_{ik}\}$. Take $\varepsilon \in (0, \frac{1}{n_k} \cdot \frac{1}{k})$. W.l.o.g. we can assume that $n_{ik} \geq 2$. For every i , define

$$\Delta_i^k(\varepsilon) = \{\nu_i \in \Delta(B_i^k) \mid \nu_i(b) \geq \varepsilon \text{ for every } b \in B_i^k\}$$

and $\Delta^k(\varepsilon) = \prod_{i \in N} \Delta_i^k(\varepsilon)$. Define the correspondence $ABR_i^k: \Delta^k(\varepsilon) \rightarrow \Delta_i^k(\varepsilon)$ by

$$ABR_i^k(\sigma) = \{\mu_i \in \Delta_i^k(\varepsilon) \mid \rho^w(\mu_i, BR_i(\sigma)) \leq \frac{2}{k}\}$$

¹²Perhaps a bit bold to put this chapter on par with the development of quantum physics, but exactly this phenomenon occurred when physicists tried to explain Kirchoff’s laws for the solar emission spectrum. Classical physics that treated light as a continuous wave could not explain the shape of the solar spectrum. This forced Planck in 1900 to propose a discretized model of light emission, where light was only allowed to be emitted in little blocks of fixed size, dubbed “quanta”, which exactly reproduced the solar spectrum. Planck had made the first step in the development of quantum physics. Apparently, at least when it concerned light emission spectra, reality was undeniably discrete, no continuous model for light emission could explain the observations of the solar spectrum. Now, we are definitely aware of the fact that thus far the theory on infinite games has not come up with its own version of the solar emission spectrum. Still, as an analogy to clarify the view pointed out by the referee, we believe the story of the birth of quantum physics is unrivaled.

for every $\sigma = (\sigma_i)_{i \in N} \in \Delta^k(\varepsilon)$.¹³ Furthermore, for every $\sigma \in \Delta(A)$, define the correspondence $ABR^k: \Delta^k(\varepsilon) \rightarrow \Delta^k(\varepsilon)$ by

$$ABR^k(\sigma) = \prod_{i \in N} ABR_i^k(\sigma).$$

We verify the conditions of Theorem 4.6.6.

I. Clearly $\Delta^k(\varepsilon)$ is compact and convex. Further, since $\varepsilon \leq \frac{1}{n_k} \leq \frac{1}{n_{ik}}$, the set $\Delta^k(\varepsilon)$ is not empty.

II. We verify that $ABR^k(\sigma)$ satisfies the conditions of the Theorem of Kakutani.

II.1. We show for every $i \in N$ that $ABR_i^k(\sigma)$ is non-empty. Take $a \in PBR_i(\sigma)$. Then, there is a $b \in B_i^k$ such that $d_{A_i}(a, b) \leq \frac{1}{k}$. Hence, $\rho^w(\delta(a), \delta(b)) \leq \frac{1}{k}$. Now, for $x \in B_i^k$ define

$$\mu_i(x) = \begin{cases} \varepsilon & \text{if } x \neq b \\ 1 - (n_{ik} - 1) \cdot \varepsilon & \text{if } x = b. \end{cases}$$

Then, $\mu_i \in \Delta_i^k(\varepsilon)$. Moreover,

$$\rho^w(\mu_i, \delta(b)) \leq \|\mu_i - \delta(b)\|_\infty = (n_{ik} - 1) \cdot \varepsilon \leq (n_{ik} - 1) \cdot \frac{1}{n_k} \cdot \frac{1}{k} \leq \frac{1}{k}.$$

Then, by the triangle inequality we have

$$\rho^w(\mu_i, \delta(a)) \leq \frac{1}{k} + \frac{1}{k} = \frac{2}{k}.$$

Thus, $\rho^w(\mu_i, BR_i(\sigma)) \leq \frac{2}{k}$, which implies $\mu_i \in ABR_i^k(\sigma)$. Hence, $ABR^k(\sigma)$ is non-empty.

II.2. Clearly, for every i , $ABR_i^k(\sigma)$ is closed and therefore $ABR^k(\sigma)$ is closed as well.

II.3. We prove that $ABR_i^k(\sigma)$ is convex for every i . Take strategies $\mu, \nu \in ABR_i^k(\sigma)$. We prove that $c\mu + (1 - c)\nu \in ABR_i^k(\sigma)$ for every $c \in [0, 1]$. Since $\mu, \nu \in ABR_i^k(\sigma)$, we have $\rho^w(\mu, BR_i(\sigma)) \leq \frac{2}{k}$ and $\rho^w(\nu, BR_i(\sigma)) \leq \frac{2}{k}$. So there are strategies $\mu', \nu' \in BR_i(\sigma)$ such that

$$\rho^w(\mu, \mu') \leq \frac{2}{k} \quad \text{and} \quad \rho^w(\nu, \nu') \leq \frac{2}{k}.$$

¹³ ABR stands for approximate best response.

Take an arbitrary $\delta > \frac{2}{k}$. Then, for every non-empty measurable set $A \subseteq A_i$, we have

$$\mu(A) \leq \mu'(A^\delta) + \delta$$

$$\mu'(A) \leq \mu(A^\delta) + \delta$$

and

$$\nu(A) \leq \nu'(A^\delta) + \delta$$

$$\nu'(A) \leq \nu(A^\delta) + \delta.$$

Then,

$$c\mu(A) + (1-c)\nu(A) \leq c\mu'(A^\delta) + (1-c)\nu'(A^\delta) + \delta$$

$$c\mu'(A) + (1-c)\nu'(A) \leq c\mu(A^\delta) + (1-c)\nu(A^\delta) + \delta.$$

Hence,

$$\rho^w(c\mu + (1-c)\nu, c\mu' + (1-c)\nu') \leq \delta,$$

which by the choice of δ implies

$$\rho^w(c\mu + (1-c)\nu, c\mu' + (1-c)\nu') \leq \frac{2}{k}.$$

Since $BR_i(\sigma)$ is a convex set, $c\mu' + (1-c)\nu' \in BR_i(\sigma)$. Thus,

$$\rho^w(c\mu + (1-c)\nu, BR_i(\sigma)) \leq \frac{2}{k},$$

which implies $c\mu + (1-c)\nu \in ABR_i^k(\sigma)$.

III. We show that ABR^k is upper-hemicontinuous. Take sequences $(\sigma^m)_{m=1}^\infty$ and $(\tau^m)_{m=1}^\infty$ in $\Delta^k(\varepsilon)$ such that $\lim_{m \rightarrow \infty} \sigma^m = \sigma$ and $\lim_{m \rightarrow \infty} \tau^m = \tau$ in Euclidean distance, and such that $\tau^m \in ABR^k(\sigma^m)$ for every $m \in \mathbf{N}$. We show $\tau_i \in ABR_i^k(\sigma)$ for every $i \in N$, so that $\tau \in ABR^k(\sigma)$.

Take $m \in \mathbf{N}$. Since $\tau_i^m \in ABR_i^k(\sigma^m)$, we have $\rho^w(\tau_i^m, BR_i(\sigma^m)) \leq \frac{2}{k}$. As $BR_i(\sigma^m)$ is a closed set with respect to the weak metric, there is a strategy $\mu_i^m \in BR_i(\sigma^m)$ such that $\rho^w(\tau_i^m, \mu_i^m) \leq \frac{2}{k}$. Because $\Delta(A_i)$ is sequentially compact with respect to the weak metric, the sequence $(\mu_i^m)_{m=1}^\infty$ has a subsequence $(\mu_i^{m_\ell})_{\ell=1}^\infty$ with $\rho^w(\mu_i^{m_\ell}, \mu_i) \rightarrow 0$ as $\ell \rightarrow \infty$ for some $\mu_i \in \Delta(A_i)$. Then, by continuity of u_i with respect to ρ^w , we have $\mu_i \in BR_i(\sigma)$. Moreover, $\rho^w(\tau_i, \mu_i) \leq \frac{2}{k}$. Hence, $\rho^w(\tau_i, BR_i(\sigma)) \leq \frac{2}{k}$. This shows that ABR^k is upper-hemicontinuous. This concludes **III**.

By **I**, **II**, and **III** we know that each ABR^k satisfies the conditions of Theorem 4.6.6. Hence, for every k , there is a $\sigma^k \in \Delta^k(\varepsilon)$ such that $\sigma^k \in ABR^k(\sigma^k)$, which

means that $\sigma_i^k \in ABR_i^k(\sigma^k)$ for every i . Hence, $\rho^w(\sigma_i^k, BR_i(\sigma^k)) \leq \frac{2}{k}$ for every i . Since $\Delta(A)$ is sequentially compact with respect to the weak metric, we can assume w.l.o.g. that the sequence $\sigma^k = (\sigma_i^k)_{i \in N}$ converges to a strategy profile $\sigma = (\sigma_i)_{i \in N}$ when $k \rightarrow \infty$. Note that $\rho^w(\sigma_i^k, BR_i(\sigma^k)) \rightarrow 0$ as $k \rightarrow \infty$. Hence, $\sigma = (\sigma_i)_{i \in N}$ is a weakly glof perfect equilibrium.

It remains to show that every weakly glof perfect equilibrium is a Nash equilibrium. Suppose that $\sigma = (\sigma_i)_{i \in N}$ is a weakly glof perfect equilibrium. Then, by definition, for every i there is a sequence $(\sigma_i^k)_{k=1}^\infty$ such that $\rho^w(\sigma_i^k, \sigma_i) \rightarrow 0$ and $\rho^w(\sigma_i^k, BR_i(\sigma^k)) \rightarrow 0$ as $k \rightarrow \infty$. Therefore, for every i there is also a sequence $(\mu_i^k)_{k=1}^\infty$ such that $\mu_i^k \in BR_i(\sigma^k)$ for every $k \in \mathbb{N}$ and $\rho^w(\sigma_i^k, \mu_i^k) \rightarrow 0$ as $k \rightarrow \infty$. By the triangle inequality for ρ^w , this implies that for every i , $\rho^w(\mu_i^k, \sigma_i) \rightarrow 0$ as $k \rightarrow \infty$. Hence, again by continuity of u_i , we obtain $\sigma_i \in BR_i(\sigma)$ for every $i \in N$, as desired.

Now, we prove that the set of weakly glof perfect equilibria is closed with respect to the weak metric. Let $(\sigma_\ell)_{\ell=1}^\infty$ be a sequence of weakly glof perfect equilibria in which $\sigma_\ell = (\sigma_{\ell,1}, \dots, \sigma_{\ell,n})$ and suppose that for every player i we have $\rho^w(\sigma_{\ell,i}, \sigma_i) \rightarrow 0$ as $\ell \rightarrow \infty$. We show that $\sigma = (\sigma_1, \dots, \sigma_n)$ is weakly glof perfect. Since for every $\ell \in \mathbb{N}$ the strategy profile σ_ℓ is weakly glof perfect, for every ℓ and every player i , there exist $(B_{\ell,i}^k)_{k=1}^\infty$ and $(\sigma_{\ell,i}^k)_{k=1}^\infty$ satisfying the conditions of Definition 4.3. Hence, there is a K_ℓ^1 such that for every $k \geq K_\ell^1$, we have $\rho^w(\sigma_{\ell,i}^k, \sigma_{\ell,i}) < \frac{1}{\ell}$. Similarly, there is a K_ℓ^2 such that for every $k \geq K_\ell^2$ we have $\rho^w(\sigma_{\ell,i}^k, BR_i(\sigma_\ell^k)) < \frac{1}{\ell}$. Let $K_\ell = \max\{K_\ell^1, K_\ell^2\}$. Notice that one can make K_ℓ large enough such that for every $a_i \in A_i$ there is a $b_i \in B_i^{K_\ell}$ with $d_{A_i}(a_i, b_i) < \frac{1}{\ell}$, for every player i . Now, the sequence $(B_{\ell,i}^{K_\ell})_{\ell=1}^\infty$ of finite subsets of A_i and $(\sigma_{\ell,i}^{K_\ell})_{\ell=1}^\infty$ of completely mixed strategies in $\Delta(B_{\ell,i}^{K_\ell})$ satisfy the conditions of Definition 4.3 for the strategy profile σ when $\ell \rightarrow \infty$. Namely, for every player i we have

$$\rho^w(\sigma_{\ell,i}^{K_\ell}, \sigma_i) \leq \rho^w(\sigma_{\ell,i}^{K_\ell}, \sigma_{\ell,i}) + \rho^w(\sigma_{\ell,i}, \sigma_i) < \frac{1}{\ell} + \rho^w(\sigma_{\ell,i}, \sigma_i),$$

and

$$\rho^w(\sigma_{\ell,i}^{K_\ell}, BR_i(\sigma_\ell^{K_\ell})) < \frac{1}{\ell},$$

both converge to 0 when $\ell \rightarrow \infty$. ■

Proofs for Section 5

Lemma 2.9.1 *Suppose that τ_i dominates σ_i . Then there is an $a_{-i} \in A_{-i}$ such that $u_i(a_{-i}, \tau_i) > u_i(a_{-i}, \sigma_i)$.*

Proof. Suppose that $u_i(a_{-i}, \tau_i) = u_i(a_{-i}, \sigma_i)$ for every $a_{-i} \in A_{-i}$. Then, for every $\sigma_{-i} \in \Delta(A_{-i})$ we have $u_i(\sigma_{-i}, \tau_i) = u_i(\sigma_{-i}, \sigma_i)$. Contradiction. ■

Lemma 2.9.2 *Suppose that strategy $\tau_i \in \Delta(A_i)$ dominates $\sigma_i \in \Delta(A_i)$. Then*

$$u_i(\sigma \mid \tau_i) > u_i(\sigma \mid \sigma_i)$$

for any completely mixed strategy profile $\sigma \in \Delta(A)$. Consequently, any best response to a completely mixed strategy profile is undominated.

Proof. This is a direct consequence of Lemma 2.9.1 and the continuity of the payoff function u_i on $\Delta(A)$. ■

The next Theorem is a direct consequence of the continuity of measure on monotonic sequences.

Lemma 2.9.3 *Suppose that f is a real function on X which is strictly positive and μ is a measure on X such that $\mu(X) > 0$. Then, $\int_X f d\mu > 0$.*

Proposition 2.9.4 *The set D_i is closed with respect to the weak metric in $\Delta(A_i)$ and PD_i is closed in A_i . Moreover, $D_i = \Delta(PD_i)$.*

Proof. Assume that D_i is non-empty, otherwise the statements are obvious. Take a $\rho_i \in D_i$. For every $\sigma_{-i} \in \Delta(A_{-i})$ define

$$F_{\sigma_{-i}} = \{\sigma_i \in \Delta(A_i) \mid u_i(\sigma_{-i}, \sigma_i) = u_i(\sigma_{-i}, \rho_i)\}.$$

Since u_i is a continuous function on $\Delta(A_i)$ with respect to the weak metric, $F_{\sigma_{-i}}$ is a closed set. Moreover, $D_i = \bigcap_{\sigma_{-i} \in \Delta(A_{-i})} F_{\sigma_{-i}}$. Therefore, D_i is also a closed set with respect to the weak metric. With a similar argument we can conclude that PD_i is a closed subset of A_i .

Now we show that $D_i = \Delta(PD_i)$. Since $\Delta(PD_i) \subseteq D_i$, we only need to prove that $\rho_i \in D_i$ implies $\rho_i \in \Delta(PD_i)$, or equivalently $\rho_i(PD_i) = 1$. Suppose by way of contradiction that $\rho_i(PD_i) < 1$, implying $\rho_i(A_i \setminus PD_i) > 0$. Take a completely mixed strategy profile $\tau \in \Delta(A)$. Let $c = u_i(\tau \mid \rho_i)$. By Lemma 2.9.2 we have

$$u_i(\tau \mid x_i) < u_i(\tau \mid \rho_i) = c$$

for every $x_i \in A_i \setminus PD_i$, while $u_i(\tau | x_i) = u_i(\tau | \rho_i) = c$ for every $x_i \in PD_i$. Then, using Lemma 2.9.3 to get the strict inequality, we have

$$\begin{aligned}
 c = u_i(\tau | \rho_i) &= \int_{A_i} u_i(\tau | x_i) d\rho_i \\
 &= \int_{PD_i} u_i(\tau | x_i) d\rho_i + \int_{A_i \setminus PD_i} u_i(\tau | x_i) d\rho_i \\
 &< c \rho_i(PD_i) + c \rho_i(A_i \setminus PD_i) = c
 \end{aligned}$$

which is a contradiction. ■

Chapter 3

Behavioral perfect equilibrium in Bayesian games

3.1 Introduction

As in games with incomplete information, for example in auction models, there is a need for a selection tool to rule out less intuitive equilibria, we examine possible extensions of perfect equilibrium to such games, specifically to Bayesian games. In a Bayesian game, first each player receives a private information, called the type of this player, which is drawn according to a known probability distribution. Subsequently, depending on his own type, each player chooses an action, and then receives a payoff depending on the types and the chosen actions of all players. We assume that the set of types and the set of actions are both metric spaces, but we generally do not require that they are compact and also do not require that the payoff functions are continuous. Our intention is to keep the model as wide as possible, so that it includes various applications.

We base our investigation on so-called behavioral strategies, which are much in the spirit of Bayesian games. A behavioral strategy for a player prescribes a probability measure on his set of actions, depending on the type of this player, and only satisfies an additional measurability assumption. A central solution concept in these Bayesian games is the concept of Bayesian Nash Equilibrium (BNE), which is a direct extension of Nash equilibrium. A BNE is a profile of behavioral strategies, one for each player, such that each player's strategy, given any type for this player, is in expectation a best response to the strategies of his opponents, where in the expectation all possible types of the opponents have to be taken into account. So, the best response property is required at the interim stage when the player already knows his own type. We remark that a similar but weaker concept arises if one calculates

ex-ante probabilities, and only requires the best response property for each player before he receives his own type. This approach is investigated for example by Reny [40] and by Milgrom and Weber [33]. From now on, we will work with ex-interim probabilities, unless mentioned otherwise.

In this chapter, our goal is to define the notion of perfect BNE in Bayesian games, and analyze its properties. We base our approach on completely mixed behavioral strategies, i.e. behavioral strategies which prescribe a completely mixed probability measure for each possible type. As a first step, we define perfection for a behavioral strategy profile, so not necessarily for a BNE yet. We define three versions of perfection, which differ in the kind of convergence over the set of types. The main idea roughly is that a behavioral strategy profile β is called perfect, if there is a sequence $(\beta^k)_{k=1}^\infty$ of completely mixed behavioral strategy profiles such that, for every player i , the distance between β_i^k and β_i and the distance between β_i^k and player i 's best responses against β^k both converge to 0. Here, by convergence we mean convergence on the set of actions with respect to the weak metric, and convergence on the set of types in one of the following three senses: uniformly for all types, pointwisely for each type, and almost everywhere pointwisely. Respectively, we call β uniform-perfect, pointwise-perfect, or a.e.-pointwise-perfect. In general, such a profile β is not necessarily a BNE. If β is also a BNE, then we call β a uniform-perfect, pointwise-perfect, or a.e.-pointwise-perfect BNE, respectively.

We analyze each of these three notions of perfection in Bayesian games in detail, and we discuss the relations between them. We also pay attention to special cases, mainly when compactness is imposed on the type and action spaces or when the payoff functions satisfy some kind of continuity property. We also devote a small section to finite Bayesian games, i.e. when there are only finitely many types and actions.

In the second part of this chapter, we illustrate that perfection can be a useful tool to select the more intuitive BNEs in Bayesian games. We do so by examining a sealed-bid second-price auction with two bidders. In this auction, the valuation function of each bidder does not only depend on his own type, but also on type of his opponent. More precisely, for each $i = 1, 2$, bidder i 's valuation is given by $v_i = 5 + t_i - \alpha t_j$, where $\alpha \in (0, 1)$ and $j \neq i$. Jackson et al. [16] and [17] considered the first price version of this auction with $\alpha = 4$ and proved that no BNE exists if each player has a positive probability to win in case of a tie.

This second-price auction admits multiple BNEs, but we find that perfection selects a BNE β that is unique in a certain class of strategies and rules out various BNEs which are less intuitive. We highlight that the choice of sequence of com-

pletely mixed behavioral strategy profiles $(\beta^k)_{k=1}^\infty$ is a very subtle task, because the most straightforward candidate for this sequence does not work. We also provide additional results, such as that β is not sincere and that neither player has a dominant strategy in this auction.

This chapter is structured as follows. First, we discuss some preliminary notions in section 3.2 and present the model of Bayesian games in section 3.3. Then, in section 3.4 we define the concept of perfect BNE and analyze its properties. In section 3.5, we apply our results to the above mentioned auction. The chapter ends with an extensive appendix, which contains the proofs of several technical results that we use in the earlier part of the chapter.

3.2 The model

A Bayesian game is a tuple $\Gamma = (N, (T_i)_{i \in N}, (A_i)_{i \in N}, (\mu_i)_{i \in N}, (\Pi_i)_{i \in N})$ where:

1. $N = \{1, 2, \dots, n\}$ is the set of players.
2. T_i is a nonempty set of player i 's possible types with metric d_{T_i} . Let \mathcal{T}_i denote the induced Borel σ -field on T_i , $T = \times_{i=1}^n T_i$, and $\mathcal{T} = \otimes_{i=1}^n \mathcal{T}_i$.
3. A_i is a nonempty set of player i 's actions with metric d_{A_i} . Let \mathcal{A}_i denote the induced Borel σ -field on A_i , $A = \times_{i=1}^n A_i$, and $\mathcal{A} = \otimes_{i=1}^n \mathcal{A}_i$.
4. μ_i is a probability measure on (T_i, \mathcal{T}_i) for player i . Let $\mu = \times_{i=1}^n \mu_i$ be the product measure on (T, \mathcal{T}) .
5. $\Pi_i : T \times A \rightarrow \mathbf{R}$ is player i 's payoff function, bounded and measurable with respect to $\mathcal{T} \otimes \mathcal{A}$. Let $\Pi = (\Pi_i)_{i=1}^n$.

The Bayesian game Γ is played as follows: First, nature draws a type $t_i \in T_i$ for each player i according to the probability measure μ_i . Each player i learns his own type t_i , but not the types of the other players. Then, each player i chooses an action $a_i \in A_i$, simultaneously and independently. Finally, depending on the types $t = (t_1, \dots, t_n)$ and the chosen actions $a = (a_1, \dots, a_n)$, each player i receives the payoff $\Pi_i(t, a)$.

Now, we discuss different classes of strategies for the players. We start with the simplest ones.

Definition 3.2.1 A pure strategy for player i is a measurable function $p_i : T_i \rightarrow A_i$.

Thus, a pure strategy prescribes one specific action depending on the player's type. Now we move on to the strategies which use some randomization for the choice of an action. In the finite version of the model, i.e., when T_i and A_i are finite, a mixed strategy is a probability measure on the set of pure strategies, whereas a behavioral strategy prescribes, for each possible type, a probability measure on the set of available actions. Aumann [4] observed however that, for our infinite model, the above view of a mixed strategy leads to measure theoretic problems and does not provide an acceptable definition. Instead, a mixed strategy should be modeled by a random variable with values in the set of pure strategies, whose domain is a probability measure space that is used as the randomization device. This is the underlying idea of the definition of a mixed strategy for player i as a measurable function $\alpha_i : T_i \times [0, 1] \rightarrow A_i$, where the uniform distribution is imposed on $[0, 1]$. The interpretation of a mixed strategy α_i is that, after observing his own type t_i and drawing a randomization-variable s_i from $[0, 1]$ according to uniform distribution, player i plays $\alpha_i(t_i, s_i)$. Note that, for every $s_i \in [0, 1]$, the section function $\alpha_i(\cdot, s_i) : T_i \rightarrow A_i$ is a pure strategy. Behavioral strategies are defined with similar considerations:

Definition 3.2.2 (Milgrom and Weber) A behavioral strategy for player i is a function $\beta_i : T_i \times \mathcal{A}_i \rightarrow [0, 1]$ such that

1. the section function $\beta_i(t_i, \cdot) : \mathcal{A}_i \rightarrow [0, 1]$ is a probability measure for every $t_i \in T_i$,
2. the section function $\beta_i(\cdot, B) : T_i \rightarrow [0, 1]$ is measurable for every $B \in \mathcal{A}_i$.

A behavioral strategy β_i prescribes, depending on player i 's type t_i , to choose an action according to the probability measure $\beta_i(t_i, \cdot)$. The second condition in the definition is included so that the ex-ante probability that player i 's action falls into a set $B \in \mathcal{A}_i$ exists and is equal to $\int_{T_i} \beta_i(t_i, B) \mu_i(dt_i)$. We will usually define a behavioral strategy by specifying the section function $\beta_i(t_i, \cdot)$ for every type $t_i \in T_i$. Behavioral strategies are well suited for our purpose to define perfect equilibrium. Indeed, the probability measures $\beta_i(t_i, \cdot)$ are sufficient to describe player i 's behavior. Moreover, as Aumann [4] showed, there is a many-to-one mapping from mixed to behavioral strategies that preserves the players' expected payoffs, so mixed strategies would have no significant added value. For these reasons, we build our definitions on behavioral strategies. From now on, by a strategy we will always mean a behavioral strategy, unless mentioned otherwise.

Definition 3.2.3 A strategy β_i for player i is called deterministic if, for every type $t_i \in T_i$, there is an action $a_{i,t_i} \in A_i$ such that $\beta_i(t_i, \cdot)$ is the Dirac measure on a_{i,t_i} . A strategy β_i is called completely mixed if the section function $\beta_i(t_i, \cdot) : A_i \rightarrow [0, 1]$ is a completely mixed probability measure for every $t_i \in T_i$. The vector $\beta = (\beta_1, \beta_2, \dots, \beta_n)$, where β_i is a strategy of player i , is called a strategy profile.

Each pure strategy p_i naturally induces a deterministic strategy β_i , for which $\beta_i(t_i, \cdot)$ is the Dirac measure on $p_i(t_i)$ for every type $t_i \in T_i$.

For every strategy profile β and every player $i \in N$, we write $\beta_{-i} = (\beta_j)_{j \in N \setminus \{i\}}$ to denote the profile consisting of strategies of the players in $N \setminus \{i\}$. Further, we use $\mathbf{E}_{\tau_{-i}}(\Pi_i \mid t_i, \beta_i)$ to denote player i 's expected payoff, given his type t_i and his strategy β_i , against a strategy profile τ_{-i} . Thus,

$$\mathbf{E}_{\tau_{-i}}(\Pi_i \mid t_i, \beta_i) = \int_{T_{-i}} \int_{A_{-i}} \int_{A_i} \Pi_i(t, a) \beta_i(t_i, da_i) \tau_{-i}(t_{-i}, da_{-i}) \mu_{-i}(dt_{-i}).$$

In the expected payoff above, i.e. $\mathbf{E}_{\tau_{-i}}(\Pi_i \mid t_i, \beta_i)$, by integrals with respect to $\tau_{-i}(t_{-i}, da_{-i})$ and $\mu_{-i}(dt_{-i})$ we mean the iterated integrals with respect to $\tau_j(t_j, da_j)$ and $\mu_j(dt_j)$ for all $j \neq i$. Fubini's Theorem and Theorem 4.6.5 in the appendix guarantee the existence of the iterated integrals in the expression above, and also that the order of integration with respect to $\beta_i(t_i, da_i)$ and $\tau_j(t_j, da_j)$, $j \neq i$, is not relevant. In the special case where player i uses a deterministic strategy with corresponding pure strategy p_i , player i 's expected payoff is denoted simply by $\mathbf{E}_{\tau_{-i}}(\Pi_i \mid t_i, p_i)$, and it is equal to

$$\mathbf{E}_{\tau_{-i}}(\Pi_i \mid t_i, p_i) = \int_{T_{-i}} \int_{A_{-i}} \Pi_i(t, (p_i(t_i), a_{-i})) \tau_{-i}(t_{-i}, da_{-i}) \mu_{-i}(dt_{-i}).$$

Since in the expected payoffs $\mathbf{E}_{\tau_{-i}}(\Pi_i \mid t_i, \beta_i)$ and $\mathbf{E}_{\tau_{-i}}(\Pi_i \mid t_i, p_i)$ it is irrelevant how player i chooses his actions for types other than t_i , we can naturally define $\mathbf{E}_{\tau_{-i}}(\Pi_i \mid t_i, \sigma_i)$ and $\mathbf{E}_{\tau_{-i}}(\Pi_i \mid t_i, a_i)$ for every probability measure σ_i on (A_i, \mathcal{A}_i) and respectively for every action $a_i \in A_i$.

A probability measure σ_i on (A_i, \mathcal{A}_i) is called a best response of player i for type $t_i \in T_i$ against a strategy profile τ_{-i} , if for every probability measure σ'_i on (A_i, \mathcal{A}_i) we have

$$\mathbf{E}_{\tau_{-i}}(\Pi_i \mid t_i, \sigma_i) \geq \mathbf{E}_{\tau_{-i}}(\Pi_i \mid t_i, \sigma'_i).$$

The set of such best responses is denoted by $BR_i(t_i, \tau_{-i})$. For a strategy profile τ , we will also use the notation $BR_i(t_i, \tau)$ instead of $BR_i(t_i, \tau_{-i})$.

A strategy β_i is called a best response of player i against a strategy profile τ_{-i} , if $\beta_i(t_i, \cdot) \in BR_i(t_i, \tau_{-i})$ for every $t_i \in T_i$. The set of such best responses is denoted

by $BR_i(\tau_{-i})$. For a strategy profile τ , we will also use the notation $BR_i(\tau)$ instead of $BR_i(\tau_{-i})$. Note that all these best response sets can be empty, which is illustrated by the following simple example.

Example 3.2.4 Consider the following Bayesian game with only one player: $T_1 = \{t_1\}$, $A_1 = [0, 1]$, $\Pi_1(t_1, x) = x$ for every $x \in [0, 1)$, and $\Pi_1(t_1, 1) = 0$. In this game, the set of the best responses (that is, optimal strategies) of player 1 is empty.

■

Now we define a central solution concept of Bayesian games, namely the concept of Bayesian Nash equilibrium.

Definition 3.2.5 A strategy profile $\beta = (\beta_1, \beta_2, \dots, \beta_n)$ is called a Bayesian Nash equilibrium (BNE), if β_i is a best response of player i against β , for every player i .

There are Bayesian games which admit no BNE at all, for instance the game in Example 3.2.4. In many Bayesian games of economic interest, however, there exist multiple BNEs, and some of them are arguably more intuitive than others. As mentioned before, our goal is to develop the definition of perfection for BNEs, which can be a useful tool in such games to distinguish the more intuitive BNEs.

3.3 Behavioral perfect Bayesian Nash equilibrium

In this section we propose a number of possible definitions of perfect BNE for Bayesian games. We introduce three main definitions. In each of them, a different notion of convergence is used on the set of strategies. At the end of the section, we draw some conclusions in the context of finite games, i.e. when there are only finitely many types and actions.

Uniform-perfect BNE

Definition 3.3.1 A strategy profile $\beta = (\beta_1, \dots, \beta_n)$ is called uniform-perfect, if there exists a sequence of profiles of completely mixed strategies $(\beta^k)_{k=1}^\infty = (\beta_1^k, \dots, \beta_n^k)_{k=1}^\infty$ with the following properties for every player i :

- (1) $\lim_{k \rightarrow \infty} \sup_{t_i \in T_i} \rho^w(\beta_i^k(t_i, \cdot), \beta_i(t_i, \cdot)) = 0,$
- (2) $\lim_{k \rightarrow \infty} \sup_{t_i \in T_i} \rho^w(\beta_i^k(t_i, \cdot), BR_i(t_i, \beta^k)) = 0.$

A strategy profile β is called a uniform-perfect BNE if β is a BNE and uniform-perfect.

Note that conditions (1) and (2) in the above definition require a uniform convergence of the corresponding distances over the set of possible types. In the special case when the game has complete information, i.e. each T_i is a singleton, our definition coincides with Simon and Stinchcombe's weak perfect equilibrium in [42].

A uniform-perfect strategy profile, and therefore a uniform-perfect BNE, does not always exist, which is for instance the case in Example 3.2.4, because the best response set in this game is always empty. Furthermore, even if a uniform-perfect strategy profile exists, it is not necessarily a BNE, which is illustrated by the following example.

Example 3.3.2 Consider the following Bayesian game with only one player: $T_1 = \{t_1\}$, $A_1 = [0, 1]$, $\Pi_1(t_1, x) = 1$ for every $x \in [0, 1)$, and $\Pi_1(t_1, 1) = 0$. Define strategies β_1 and β_1^k , for every $k \in \mathbf{N}$, as follows: $\beta_1(t_1, \cdot) = \delta_1(\cdot)$ and $\beta_1^k(t_1, \cdot) = (1 - \frac{1}{k})\delta_{1-\frac{1}{k}}(\cdot) + \frac{1}{k}\sigma(\cdot)$, for every $k \in \mathbf{N}$, where δ_x is the Dirac measure on action x and σ is the uniform distribution on the Borel sets of $[0, 1]$. Note that the set of the pure best responses (that is, optimal strategies) of player 1 consists of all actions in $[0, 1)$. So, the strategy β_1 and the sequence of completely mixed strategies $(\beta_1^k)_{k=1}^\infty$ satisfy conditions (1) and (2) of Definition 3.3.1. Therefore, β_1 is a uniform-perfect strategy profile, but it is clearly not a BNE. ■

A uniform-perfect strategy profile may fail to exist, even if the type and action spaces are compact and the payoff functions are continuous, as is shown in Example 3.3.5. Nevertheless, it follows from Theorem 3.3.4 under fairly weak conditions that every uniform-perfect strategy profile is a BNE.

Pointwise-perfect BNE

Definition 3.3.3 A strategy profile $\beta = (\beta_1, \dots, \beta_n)$ is called pointwise-perfect, if there exists a sequence of profiles of completely mixed strategies $(\beta^k)_{k=1}^\infty = (\beta_1^k, \dots, \beta_n^k)_{k=1}^\infty$ with the following properties for every player i and each type $t_i \in T_i$:

$$(1) \lim_{k \rightarrow \infty} \rho^w(\beta_i^k(t_i, \cdot), \beta_i(t_i, \cdot)) = 0,$$

$$(2) \lim_{k \rightarrow \infty} \rho^w(\beta_i^k(t_i, \cdot), BR_i(t_i, \beta^k)) = 0.$$

A strategy profile β is called a pointwise-perfect BNE if β is a BNE and pointwise-perfect.

Note that conditions (1) and (2) in the above definition require pointwise convergence of the corresponding distances over the set of possible types.

A pointwise-perfect strategy profile, and therefore a pointwise-perfect BNE, does not always exist, which is for instance the case in Example 3.2.4, because the best response set in this game is always empty. Furthermore, it follows from Example 3.3.2 that a pointwise-perfect strategy profile is not necessarily a BNE.

We do not know if a pointwise-perfect strategy profile always exists under the condition that the type and action spaces are compact and the payoff functions are continuous. Nevertheless, we have the following result.

Theorem 3.3.4 *In a Bayesian game where the action spaces are separable and $\Pi_i(t, \cdot)$ is continuous on A for every player i and every $t \in T$, every pointwise-perfect strategy profile is a BNE.*

Proof. Suppose that $\beta = (\beta_1, \dots, \beta_n)$ is a pointwise-perfect strategy profile in such a Bayesian game. For β , take a sequence of strategy profiles $(\beta^k)_{k=1}^\infty$ as in Definition 3.3.3. Fix a player i and a type $t_i \in T_i$. Due to condition (2) in Definition 3.3.3, there exists a $K_i(t_i) \in \mathbf{N}$ such that $BR_i(t_i, \beta^k)$ is nonempty for every $k \geq K_i(t_i)$. Therefore, by condition (2) once more, there exists a sequence $(\sigma_{i,t_i}^k)_{k=1}^\infty$ of probability measures on (A_i, \mathcal{A}_i) such that $\sigma_{i,t_i}^k \in BR_i(t_i, \beta^k)$ for every $k \geq K_i(t_i)$ and $\rho^w(\beta_i^k(t_i, \cdot), \sigma_{i,t_i}^k) \rightarrow 0$ as $k \rightarrow \infty$. By condition (1) and by the triangle inequality for ρ^w , this implies that $\rho^w(\beta_i(t_i, \cdot), \sigma_{i,t_i}^k) \rightarrow 0$ as $k \rightarrow \infty$.

For every $k \geq K_i(t_i)$ and every probability measure σ' on (A_i, \mathcal{A}_i) , we have due to $\sigma_{i,t_i}^k \in BR_i(t_i, \beta^k)$ that $\mathbf{E}_{\beta_{-i}^k}(\Pi_i | t_i, \sigma_{i,t_i}^k) \geq \mathbf{E}_{\beta_{-i}^k}(\Pi_i | t_i, \sigma')$, which means that

$$\begin{aligned} & \int_{T_{-i}} \int_{A_{-i}} \int_{A_i} \Pi_i((t_i, t_{-i}), a) \sigma_{i,t_i}^k(da_i) \beta_{-i}^k(t_{-i}, da_{-i}) \mu_{-i}(dt_{-i}) \quad (3.1) \\ & \geq \int_{T_{-i}} \int_{A_{-i}} \int_{A_i} \Pi_i((t_i, t_{-i}), a) \sigma'(da_i) \beta_{-i}^k(t_{-i}, da_{-i}) \mu_{-i}(dt_{-i}). \end{aligned}$$

According to Theorem 3.2 in [6], in a separable product space the weak convergence of the product measure is equivalent to the weak convergence of the marginal measures. Hence, because A is separable, the weak convergence of σ_{i,t_i}^k to $\beta_i(t_i, \cdot)$ and of $\beta_j^k(t_j, \cdot)$ to $\beta_j(t_j, \cdot)$ for every player $j \neq i$ and every type $t_j \in T_j$ implies that, for any $t_{-i} \in T_{-i}$, the product measure $\sigma_{i,t_i}^k \times (\times_{j \neq i} \beta_j^k(t_j, \cdot))$ on (A, \mathcal{A}) weakly converges to the product measure $\beta_i(t_i, \cdot) \times (\times_{j \neq i} \beta_j(t_j, \cdot))$. Since the payoff function $\Pi_i((t_i, t_{-i}), \cdot)$ is continuous on A for every $t_{-i} \in T_{-i}$, by Fubini's theorem we have for every $t_{-i} \in T_{-i}$

$$\lim_{k \rightarrow \infty} \int_{A_{-i}} \int_{A_i} \Pi_i((t_i, t_{-i}), a) \sigma_{i,t_i}^k(da_i) \beta_{-i}^k(t_{-i}, da_{-i})$$

$$= \int_{A_{-i}} \int_{A_i} \Pi_i((t_i, t_{-i}), a) \beta_i(t_i, da_i) \beta_{-i}(t_{-i}, da_{-i}),$$

and similarly

$$\begin{aligned} & \lim_{k \rightarrow \infty} \int_{A_{-i}} \int_{A_i} \Pi_i((t_i, t_{-i}), a) \sigma'(da_i) \beta_{-i}^k(t_{-i}, da_{-i}) \\ &= \int_{A_{-i}} \int_{A_i} \Pi_i((t_i, t_{-i}), a) \sigma'(da_i) \beta_{-i}(t_{-i}, da_{-i}). \end{aligned}$$

Thus, if we take the limit in inequality (3.1) when $k \rightarrow \infty$, by the dominated convergence theorem we obtain

$$\begin{aligned} & \int_{T_{-i}} \int_{A_{-i}} \int_{A_i} \Pi_i(t, a) \beta_i(t_i, da_i) \beta_{-i}(t_{-i}, da_{-i}) \mu_{-i}(dt_{-i}) \\ & \geq \int_{T_{-i}} \int_{A_{-i}} \int_{A_i} \Pi_i(t, a) \sigma'(da_i) \beta_{-i}(t_{-i}, da_{-i}) \mu_{-i}(dt_{-i}), \end{aligned}$$

which means $\mathbf{E}_{\beta_{-i}}(\Pi_i | t_i, \beta_i(t_i, \cdot)) \geq \mathbf{E}_{\beta_{-i}}(\Pi_i | t_i, \sigma')$. Hence, $\beta_i(t_i, \cdot) \in BR_i(t_i, \beta)$. Since player i and type t_i were chosen arbitrary, the strategy profile β is a BNE as claimed. \blacksquare

It is clear that every uniform-perfect BNE is also pointwise-perfect. Now, we provide a game which demonstrates that the opposite is not always true. This game has a pointwise-perfect BNE, but it has no uniform-perfect BNE, in fact not even a uniform-perfect strategy profile, although the type and action spaces are compact and the payoff functions are continuous.

Example 3.3.5 Consider the following Bayesian game with two players: Player 1 has only one possible type, $T_1 = \{t_1\}$, whereas player 2's type space is $T_2 = \{t_2^1, t_2^2, \dots, t_2^\infty\}$ in which t_2^∞ is the limit point of the sequence $(t_2^m)_{m=1}^\infty$. The probability measure μ_2 on (T_2, \mathcal{T}_2) is arbitrary. The action spaces are $A_1 = \{U, D\}$ and $A_2 = \{L, R\}$. The payoff matrix when player 1 is the row-player and is given type t_1 , and player 2 is the column-player and is given type t_2^m , for every $m \in \mathbf{N}$, is the following:

(t_1, t_2^m)	L	R
U	$0, -\frac{1}{m}$	$0, 0$
D	$1, \frac{1}{m^2}$	$1, 0$

and the payoff matrix when player 1 is given type t_1 and player 2 is given type t_2^∞ is:

(t_1, t_2^∞)	L	R
U	0, 0	0, 0
D	1, 0	1, 0

Observe that the type and action spaces in this game are compact, and the payoff functions are continuous.

Define $p_1(t_1) = D$ and $p_2(t_2^m) = L$, for every $m \in \mathbf{N} \cup \{\infty\}$. Let β_1 and β_2 be the deterministic strategies corresponding to p_1 and p_2 respectively. We claim that (β_1, β_2) is a pointwise-perfect BNE, but the game has no uniform-perfect strategy profile, so no uniform-perfect BNE either.

The proof that (β_1, β_2) is a pointwise-perfect BNE: Clearly, (β_1, β_2) is a BNE, so it remains to prove that (β_1, β_2) is pointwise-perfect. For every $k \in \mathbf{N}$, define two completely mixed strategies β_1^k and β_2^k by letting $\beta_1^k(t_1, \cdot) = (1 - \frac{1}{k})\delta_D(\cdot) + \frac{1}{k}\delta_U(\cdot)$ and $\beta_2^k(t_2^m, \cdot) = (1 - \frac{1}{k})\delta_L(\cdot) + \frac{1}{k}\delta_R(\cdot)$ for every $m \in \mathbf{N} \cup \{\infty\}$, where δ_x denotes the Dirac measure on x . The sequence $(\beta^k)_{k=1}^\infty = (\beta_1^k, \beta_2^k)_{k=1}^\infty$ clearly satisfies condition (1) of Definition 3.3.3, and it also satisfies condition (2) for player 1 and condition (2) for type t_2^∞ of player 2. It remains to verify condition (2) for an arbitrary type t_2^m for player 2 where $m \in \mathbf{N}$. Take such a type t_2^m . We have

$$\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2^m, L) = (1 - \frac{1}{k}) \cdot \frac{1}{m^2} + \frac{1}{k} \cdot (-\frac{1}{m}),$$

which is strictly positive for large k . Hence, $BR_2(t_2^m, \beta^k) = \{\delta_L\}$ for large k , which implies that condition (2) of Definition 3.3.3 holds for type t_2^m . Thus, (β_1, β_2) is pointwise-perfect indeed.

The proof that this game has no uniform-perfect strategy profile: Suppose by way of contradiction that $\tau = (\tau_1, \tau_2)$ is a uniform-perfect strategy profile. Then, there is a sequence of completely mixed strategy profiles $(\tau^k)_{k=1}^\infty = (\tau_1^k, \tau_2^k)_{k=1}^\infty$ that satisfy conditions (1) and (2) of Definition 3.3.1 for τ . First notice that, by the triangle inequality for ρ^w , we have

$$\begin{aligned} & \sup_{t_2 \in T_2} \rho^w(\tau_2(t_2, \cdot), BR_2(t_2, \tau^k)) \\ & \leq \sup_{t_2 \in T_2} [\rho^w(\tau_2^k(t_2, \cdot), \tau_2(t_2, \cdot)) + \rho^w(\tau_2^k(t_2, \cdot), BR_2(t_2, \tau^k))] \\ & \leq \sup_{t_2 \in T_2} \rho^w(\tau_2^k(t_2, \cdot), \tau_2(t_2, \cdot)) + \sup_{t_2 \in T_2} \rho^w(\tau_2^k(t_2, \cdot), BR_2(t_2, \tau^k)), \end{aligned}$$

and therefore conditions (1) and (2) imply

$$\lim_{k \rightarrow \infty} \sup_{t_2 \in T_2} \rho^w(\tau_2(t_2, \cdot), BR_2(t_2, \tau^k)) = 0. \quad (3.2)$$

For every $k \in \mathbf{N}$, the probability measure $\tau_1^k(t_1, \cdot)$ can be written in the form $\tau_1^k(t_1, \cdot) = (1 - \varepsilon_k)\delta_U(\cdot) + \varepsilon_k\delta_D(\cdot)$ with some $\varepsilon_k \in (0, 1)$. Due to condition (2) for player 1, we must have that $\varepsilon_k \rightarrow 1$ as $k \rightarrow \infty$.

For every $k \in \mathbf{N}$ and every type t_2^m for player 2, where $m \in \mathbf{N}$, we have

$$\mathbf{E}_{\tau_1^k}(\Pi_2 \mid t_2^m, L) = \varepsilon_k \cdot \frac{1}{m^2} + (1 - \varepsilon_k) \cdot \left(-\frac{1}{m}\right),$$

whereas $\mathbf{E}_{\tau_1^k}(\Pi_2 \mid t_2^m, R) = 0$. It has two consequences. First, for every t_2^m , where $m \in \mathbf{N}$, we have $BR_2(t_2^m, \tau^k) = \{\delta_L\}$ for large k , which in view of (3.2) yields $\tau_2(t_2^m, \cdot) = \delta_L(\cdot)$ for every t_2^m , where $m \in \mathbf{N}$. Second, for every $k \in \mathbf{N}$, we have $BR_2(t_2^m, \tau^k) = \{\delta_R\}$ for large m . In conclusion, for every $k \in \mathbf{N}$, if m is large, then $\tau_2(t_2^m, \cdot) = \delta_L(\cdot)$ and $BR_2(t_2^m, \tau^k) = \{\delta_R\}$. This is in contradiction with (3.2), so τ is not a uniform-perfect strategy profile. ■

A.e.-pointwise-perfect BNE

Definition 3.3.6 A strategy profile $\beta = (\beta_1, \dots, \beta_n)$ is called a.e.-pointwise-perfect (where a.e. stands for almost everywhere), if for every player i there exists a set $S_i \in \mathcal{T}_i$ with $\mu_i(S_i) = 0$ and a sequence of profiles of completely mixed strategies $(\beta^k)_{k=1}^\infty = (\beta_1^k, \dots, \beta_n^k)_{k=1}^\infty$ with the following properties for every player i and every type $t_i \in T_i \setminus S_i$:

$$(1) \quad \lim_{k \rightarrow \infty} \rho^w(\beta_i^k(t_i, \cdot), \beta_i(t_i, \cdot)) = 0,$$

$$(2) \quad \lim_{k \rightarrow \infty} \rho^w(\beta_i^k(t_i, \cdot), BR_i(t_i, \beta^k)) = 0.$$

A strategy profile β is called an a.e.-pointwise-perfect BNE if β is a BNE and a.e.-pointwise-perfect.

An a.e.-pointwise-perfect strategy profile, and therefore an a.e.-pointwise-perfect BNE, does not always exist, which is for instance the case in Example 3.2.4, because the best response set in this game is always empty. Furthermore, it follows from Example 3.3.2 that an a.e.-pointwise-perfect strategy profile is not necessarily a BNE.

It is clear that every pointwise-perfect BNE is also a.e.-pointwise-perfect. The following example proves that the converse is not always true.

Example 3.3.7 Consider the following Bayesian game with two players: The type spaces are $T_1 = \{t_1\}$ and $T_2 = \{t_2^1, t_2^2\}$, and μ_2 is given by $\mu_2(t_2^1) = 1$ and $\mu_2(t_2^2) = 0$. The action spaces are $A_1 = \{U, D\}$ and $A_2 = \{L, R\}$. The payoff

matrix is the following if player 1 is given type t_1 whereas player 2 is given type t_2^m for $m = 1, 2$:

(t_1, t_2^m)	L	R
U	0, 1	0, 0
D	1, 0	1, 0

Define $p_1(t_1) = D$, $p_2(t_2^1) = L$ and $p_2(t_2^2) = R$. Let β_1 and β_2 be the deterministic strategies corresponding to p_1 and p_2 respectively. It is clear that (β_1, β_2) is an a.e.-pointwise-perfect BNE, by choosing $S_1 = \emptyset$ and $S_2 = \{t_2^2\}$ in Definition 3.3.6. Yet, (β_1, β_2) is not pointwise-perfect, because player 2 chooses R with probability 1 if he receives type t_2^2 .

We remark that a similar example can be made where $T_2 = [0, 1]$, μ_2 is the uniform distribution on T_2 , and where the strategy profile is not pointwise-perfect only due to a single type, say type $t_2 = 1$. ■

The following theorem presents conditions under which there is a strong connection between a.e.-pointwise and pointwise-perfection.

Proposition 3.3.8 *Let β be an a.e.-pointwise-perfect BNE in a Bayesian game with compact action spaces. Let S_i , for every player i , and $(\beta^k)_{k=1}^\infty$ be as in Definition 3.3.6 for β . Suppose that S_i is countable for every player i and $BR_i(t_i, \beta^k)$ is nonempty for every player i , every type $t_i \in S_i$ and every $k \in \mathbf{N}$. Then, there is a pointwise-perfect BNE $\hat{\beta}$ such that $\hat{\beta}_i(t_i, \cdot) = \beta_i(t_i, \cdot)$ holds for every player i and every type $t_i \in T_i \setminus S_i$.*

Proof. For such an a.e.-pointwise-perfect BNE β , we can construct a desired pointwise-perfect BNE $\hat{\beta}$ as follows. For every player $i \in N$, every type $t_i \in S_i$, and every $k \in \mathbf{N}$, by assumption of the proposition, we can choose a probability measure $\sigma_{i,t_i}^k \in BR_i(t_i, \beta^k)$. Now, define a profile of completely mixed strategies $\hat{\beta}^k$, for every $k \in \mathbf{N}$, by letting

$$\hat{\beta}_i^k(t_i, \cdot) = \begin{cases} \beta_i^k(t_i, \cdot) & \text{if } t_i \in T_i \setminus S_i \\ (1 - \frac{1}{k})\sigma_{i,t_i}^k(\cdot) + \frac{1}{k}\beta_i^k(t_i, \cdot) & \text{if } t_i \in S_i \end{cases}$$

for every player $i \in N$ and type $t_i \in T_i$. Note that since for every $B \in \mathcal{A}_i$ the maps $\hat{\beta}_i^k(\cdot, B)$ and $\beta_i^k(\cdot, B)$ only differ on a countable subset of T_i , namely the set S_i , $\hat{\beta}_i^k(\cdot, B) : T_i \rightarrow [0, 1]$ is measurable. Therefore, $\hat{\beta}_i^k$ is a behavioral strategy.

In the remaining part of the proof, we use several fairly known results from analysis, which can all be found in [1]. By assumption, A_i is compact in the topology

induced by the metric d_{A_i} , so the set $\Delta(A_i)$ of probability measures on (A_i, \mathcal{A}_i) is also compact with respect to the topology induced by the weak metric. Consequently, the product space $\times_{i \in N} \times_{t_i \in S_i} \Delta(A_i)$ is compact in the product topology by Tychonoff's theorem, and because S_i is countable, this topology is even metrizable. Therefore, this topological space is sequentially compact, which assures the existence of a subsequence $(k_r)_{r=1}^\infty$ so that $\sigma_{i,t_i}^{k_r}$ converges to some $\sigma_{i,t_i} \in \Delta(A_i)$, for every player $i \in N$ and every $t_i \in T_i$, with respect to the weak metric. So, define a strategy for every player $i \in N$ by

$$\hat{\beta}_i(t_i, \cdot) = \begin{cases} \beta_i(t_i, \cdot) & \text{if } t_i \in T_i \setminus S_i \\ \sigma_{i,t_i}(\cdot) & \text{if } t_i \in S_i \end{cases}$$

for every type $t_i \in T_i$. With the same argument as for $\hat{\beta}_i^k$, it is clear that $\hat{\beta}_i$ is a behavioral strategy too. Notice that the profile $\hat{\beta} = (\hat{\beta}_i)_{i \in N}$ is a pointwise-perfect equilibrium. Indeed, for the sequence $\hat{\beta}^{k_r}$, condition (1) of Definition 3.3.3 is obviously satisfied, and so is condition (2) because $BR_i(t_i, \hat{\beta}^{k_r}) = BR_i(t_i, \beta^{k_r})$ holds due to $\mu_j(S_j) = 0$ for all players j . ■

The next example shows that the condition that S_i is countable is crucial in Proposition 3.3.8 if there are at least three players. We do not know if this condition is also crucial for games with only two players.

Example 3.3.9 Consider the following Bayesian game with three players. The type spaces are $T_1 = \{0, 1\}^{\mathbf{N}}$, $T_2 = \{t_2\}$ and $T_3 = \{t_3\}$. The metric d_{T_1} on T_1 is defined as follows: for $t_1, t'_1 \in T_1$, if $t_1 = t'_1$ then let $d_{T_1}(t_1, t'_1) = 0$, otherwise if m is the first coordinate in which t_1 and t'_1 differ, then let $d_{T_1}(t_1, t'_1) = 2^{-m}$. Notice that d_{T_1} induces the product topology on T_1 . Further, let $\mu_1 = \delta_{(1,1,\dots)}$, i.e. the Dirac measure on the type $(1, 1, \dots)$. The action spaces are $A_1 = \{U, D\}$, $A_2 = \{a_1, a_2, \dots, a_\infty\}$, and $A_3 = \{b_1, b_2, \dots, b_\infty\}$, in which $a_m = b_m = 1 - \frac{1}{m}$ for every $m \in \mathbf{N}$ and $a_\infty = b_\infty = 1$. For every type $t_1 \in \{0, 1\}^{\mathbf{N}}$, let $f_m(t_1)$ be the m -th coordinate of the sequence t_1 . When player 1 is given type $t_1 \in \{0, 1\}^{\mathbf{N}} \setminus \{(1, 1, \dots)\}$, the payoff of player 1 is independent of the action chosen by player 3, and it is given by

$t_1 \in \{0, 1\}^{\mathbf{N}} \setminus \{(1, 1, \dots)\}$	a_m	a_∞
U	$f_m(t_1)$	0
D	$1 - f_m(t_1)$	0

whereas if player 1 is given type $t_1 = (1, 1, \dots)$:

$t_1 = (1, 1, \dots)$	a_m	a_∞
U	0	0
D	0	0

The payoffs of players 2 and 3 are independent of the action chosen by player 1, and are given by:

	b_1	b_2	b_3	b_4	\dots	b_∞
a_1	0,0	$0, \frac{1}{2}$	$0, \frac{1}{3}$	$0, \frac{1}{4}$	\dots	0,0
a_2	$\frac{1}{2}, 0$	0,0	$0, \frac{1}{3}$	$0, \frac{1}{4}$	\dots	0,0
a_3	$\frac{1}{3}, 0$	$\frac{1}{3}, 0$	0,0	$0, \frac{1}{4}$	\dots	0,0
a_4	$\frac{1}{4}, 0$	$\frac{1}{4}, 0$	$\frac{1}{4}, 0$	0,0	\dots	0,0
\vdots	\vdots	\vdots	\vdots	\vdots	\vdots	\vdots
a_∞	0,0	0,0	0,0	0,0	\dots	0,0

In general, if player 2 chooses action a_m and player 3 chooses action b_ℓ , with $m, \ell \in \mathbf{N}$, then player 2's payoff is $\frac{1}{m}$ if $m > \ell$, and 0 otherwise, and player 3's payoff is $\frac{1}{\ell}$ if $\ell > m$, and 0 otherwise.

We remark that the type and action spaces in this game are all compact. Since the payoff functions of players 2 and 3 are continuous, and player 1 has only finitely many actions, the best reply set $BR_i(t_i, \beta)$ is nonempty for every player i , every $t_i \in T_i$ and every strategy profile β . We claim: (1) there exists an a.e.-pointwise-perfect equilibrium in this game, but (2) this game admits no pointwise-perfect strategy profile.

An a.e.-pointwise-perfect BNE: First we construct an a.e.-pointwise-perfect BNE. Define $p_1(t_1) = U$ for every $t_1 \in T_1$, $p_2(t_2) = a_\infty$ and $p_3(t_3) = b_\infty$. Let $\tilde{\beta}_i$ be the deterministic strategy for each player i corresponding to p_i . Now we prove that $\tilde{\beta} = (\tilde{\beta}_1, \tilde{\beta}_2, \tilde{\beta}_3)$ is an a.e.-pointwise-perfect BNE. Let $S_1 = T_1 \setminus \{(1, 1, \dots)\}$ and $S_2 = S_3 = \emptyset$. Further, take arbitrary completely mixed probability measures σ_2 and σ_3 on (A_2, \mathcal{A}_2) and (A_3, \mathcal{A}_3) , respectively. For every $k \in \mathbf{N}$, define the completely mixed strategies

$$\beta_1^k(t_1, \cdot) = (1 - \frac{1}{k}) \cdot \delta_U(\cdot) + \frac{1}{k} \cdot \delta_D(\cdot) \quad \text{for every } t_1 \in T_1$$

$$\begin{aligned}\beta_2^k(t_2, \cdot) &= \left(1 - \frac{1}{k^2}\right) \cdot \delta_{a_k}(\cdot) + \frac{1}{k^2} \cdot \sigma_2(\cdot) \\ \beta_3^k(t_3, \cdot) &= \left(1 - \frac{1}{k^2}\right) \cdot \delta_{b_k}(\cdot) + \frac{1}{k^2} \cdot \sigma_3(\cdot).\end{aligned}$$

If player 2 plays actions a_{k+1} against $\beta_3^k(t_3, \cdot)$, then he receives at least $(1 - \frac{1}{k^2}) \frac{1}{k+1}$, whereas he receives at most $\frac{1}{k+2}$ by playing an action a_ℓ with $\ell > k+1$ and receives at most $\frac{1}{2k^2}$ by playing an action a_ℓ with $\ell < k+1$. Thus, for every $k \geq 3$, action a_{k+1} is player 2's (unique) best response to $\beta_3^k(t_3, \cdot)$, and for similar reasons, action b_{k+1} is player 3's (unique) best response to $\beta_2^k(t_2, \cdot)$. Based on this observation, one can check easily that S_1, S_2, S_3 and the sequence $\beta^k = (\beta_1^k, \beta_2^k, \beta_3^k)$ satisfy the conditions of Definition 3.3.6 for $\tilde{\beta}$. Thus, $\tilde{\beta}$ is an a.e.-pointwise-perfect BNE indeed.

No pointwise-perfect strategy profile: Now we claim that there is no pointwise-perfect strategy profile in this game. (Note that S_1 above is uncountable, so Proposition 3.3.8 does not apply.) Suppose by way of contradiction that $\beta = (\beta_1, \beta_2, \beta_3)$ is a pointwise-perfect strategy profile, with some sequence $(\beta^k)_{k=1}^\infty$ as required in Definition 3.3.3.

First we prove that $\beta_2(t_2, \cdot)$ and $\beta_3(t_3, \cdot)$ put probability 1 on action a_∞ and b_∞ , respectively, i.e. $\beta_2(t_2, \{a_\infty\}) = \beta_3(t_3, \{b_\infty\}) = 1$. Suppose by way of contradiction that $\beta_2(t_2, \{a_\infty\}) < 1$; the proof is similar if $\beta_3(t_3, \{b_\infty\}) < 1$. Let $m^* = \min\{m \in \mathbf{N} \mid \beta_2(t_2, \{a_m\}) > 0\}$. Since player 3 can get a positive payoff against $\beta_2(t_2, \cdot)$, and $\beta_3(t_3, \cdot)$ is a best response to $\beta_2(t_2, \cdot)$, we must have $\beta_3(t_3, \{b_\infty\}) = 0$. So, also player 2 can get a positive payoff against $\beta_3(t_3, \cdot)$. Let $\ell^* = \min\{\ell \in \mathbf{N} \mid \beta_3(t_3, \{b_\ell\}) > 0\}$. Now, if $m^* \leq \ell^*$, then action a_{m^*} gives payoff zero to player 2, which is a contradiction as $\beta_2(t_2, \{a_{m^*}\}) > 0$. Similarly, if $\ell^* \leq m^*$, then action b_{ℓ^*} gives payoff zero to player 3, which is a contradiction as $\beta_3(t_3, \{b_{\ell^*}\}) > 0$. So, $\beta_2(t_2, \{a_\infty\}) = \beta_3(t_3, \{b_\infty\}) = 1$ must hold indeed.

For every $k \in \mathbf{N}$, let σ^k be the probability measure on (A_2, \mathcal{A}_2) defined by $\sigma^k(a_\infty) = 0$ and

$$\sigma^k(a_m) = \frac{\beta_2^k(t_2, \{a_m\})}{1 - \beta_2^k(t_2, \{a_\infty\})}$$

for every $m \in \mathbf{N}$. So, $\sigma^k(a_m)$ equals the probability that action a_m is chosen with respect to $\beta_2^k(t_2, \cdot)$ conditioned on the event that a_∞ is not chosen. We now claim that for every $m \in \mathbf{N}$

$$\lim_{k \rightarrow \infty} \sigma^k(\{a_1, \dots, a_m\}) = 0. \quad (3.3)$$

Suppose by way of contradiction that for some $m \in \mathbf{N}$ there exists a $Z > 0$ and a subsequence $(k_r)_{r=1}^\infty$ such that $\sigma^{k_r}(\{a_1, \dots, a_m\}) \geq Z$ for every $r \in \mathbf{N}$. Notice that, for every $r \in \mathbf{N}$, action b_{m+1} gives in expectation at least $\frac{Z}{m+1}$ to player 3

against σ^{k_r} , hence at least $(1 - \beta_2^{k_r}(t_2, \{a_\infty\})) \cdot \frac{Z}{m+1}$ against β^{k_r} . Now consider any action b_w with $w > \frac{m+1}{Z}$. Since player 3's highest payoff for action b_w is $\frac{1}{w}$, action b_w gives player 3 in expectation strictly less than $\frac{Z}{m+1}$ against σ^{k_r} , hence strictly less than $(1 - \beta_2^{k_r}(t_2, \{a_\infty\})) \cdot \frac{Z}{m+1}$ against β^{k_r} . Therefore, player 3's best responses are in $\{b_1, \dots, b_{\lfloor \frac{m+1}{Z} \rfloor}\}$ against β^{k_r} for any $r \in \mathbf{N}$. Since player 3's best responses along this subsequence are not approaching b_∞ with respect to the weak metric, the sequence β^k cannot satisfy both conditions (1) and (2) of Definition 3.3.3. Thus, (3.3) holds as claimed.

Let $k_1 = 1$ and $m_1 \in \mathbf{N}$ be such that $\sigma^{k_1}(\{a_1, \dots, a_{m_1}\}) > \frac{1}{2}$. Then, by (3.3), there exists a $k_2 > k_1$ and an $m_2 > m_1$ such that $\sigma^{k_2}(\{a_{m_1+1}, \dots, a_{m_2}\}) > \frac{1}{2}$. By repeating this argument, we obtain in \mathbf{N} two strictly increasing sequences $(m_r)_{r=1}^\infty$ and $(k_r)_{r=1}^\infty$ such that for every $r \in \mathbf{N}$

$$\sigma^{k_r}(\{a_m \mid m \in W_r\}) > \frac{1}{2}, \quad (3.4)$$

where $W_r = \{m_{r-1} + 1, \dots, m_r\}$ and $m_0 = 0$. Note that the sets W_r , $r \in \mathbf{N}$, form a partition of \mathbf{N} .

Now let t_1 be the type in $\{0, 1\}^\mathbf{N}$ such that $f_m(t_1) = 1$ if $m \in W_r$ for an odd $r \in \mathbf{N}$ and $f_m(t_1) = 0$ if $m \in W_r$ for an even $r \in \mathbf{N}$. Take an arbitrary odd $r \in \mathbf{N}$. Then, $f_m(t_1) = 1$ for any $m \in W_r$, and since $\sigma^{k_r}(\{a_m \mid m \in W_r\}) > \frac{1}{2}$ due to (3.4), player 1's unique best response to β^{k_r} is action U . Similarly, when $r \in \mathbf{N}$ is even, player 1's unique best response to β^{k_r} is action D . So, the sequence β^k cannot satisfy both conditions (1) and (2) of Definition 3.3.3 for type t_1 , which is a contradiction. Consequently, there is no pointwise-perfect strategy profile in this game. ■

The following corollary follows easily from Proposition 3.3.8.

Corollary 3.3.10 *Consider a Bayesian game in which the type spaces are countable, the action spaces are compact, and the payoff functions are continuous. Then, for every a.e.-pointwise-perfect BNE β , there exists a pointwise-perfect BNE $\hat{\beta}$ such that, for every player i , we have $\hat{\beta}_i(t_i, \cdot) = \beta_i(t_i, \cdot)$ for μ_i -a.e. type $t_i \in T_i$.*

Now, we examine Bayesian games which satisfy the following two measurability conditions:

- Condition M1: For any player i and any strategies β_i^1, β_i^2 of player i , the map

$$t_i \mapsto \rho^w(\beta_i^1(t_i, \cdot), \beta_i^2(t_i, \cdot))$$

is measurable.

- Condition M2: For any player i , any strategy β_i of player i , and any strategy profile τ , the map

$$t_i \mapsto \rho^w(\beta_i(t_i, \cdot), BR_i(t_i, \tau))$$

is measurable.

Condition M1 is mild, because if the action spaces are σ -compact, then M1 is always satisfied (cf. Lemma 3.6.2). It is not clear if mild conditions are also sufficient to guarantee M2.

Now, we present a number of conditions that are all equivalent to a.e.-pointwise-perfection, under the additional assumptions of M1 and M2.

Proposition 3.3.11 *Consider a Bayesian game which satisfies conditions M1 and M2. Then, for every strategy profile $\beta = (\beta_1, \dots, \beta_n)$, equivalent are:*

- i. *The strategy profile β is a.e.-pointwise-perfect.*
- ii. *There exists a sequence of profiles of completely mixed strategies $(\beta^k)_{k=1}^\infty = (\beta_1^k, \dots, \beta_n^k)_{k=1}^\infty$ such that for every player i and every $\varepsilon > 0$:*

$$(ii.1) \quad \lim_{k \rightarrow \infty} \mu_i \{t_i \in T_i \mid \rho^w(\beta_i^k(t_i, \cdot), \beta_i(t_i, \cdot)) \geq \varepsilon\} = 0,$$

$$(ii.2) \quad \lim_{k \rightarrow \infty} \mu_i \{t_i \in T_i \mid \rho^w(\beta_i^k(t_i, \cdot), BR_i(t_i, \beta^k)) \geq \varepsilon\} = 0.$$

- iii. *There exists a sequence of profiles of completely mixed strategies $(\beta^k)_{k=1}^\infty = (\beta_1^k, \dots, \beta_n^k)_{k=1}^\infty$ such that for every player i :*

$$(iii.1) \quad \lim_{k \rightarrow \infty} \int_{T_i} \rho^w(\beta_i^k(t_i, \cdot), \beta_i(t_i, \cdot)) \mu_i(dt_i) = 0,$$

$$(iii.2) \quad \lim_{k \rightarrow \infty} \int_{T_i} \rho^w(\beta_i^k(t_i, \cdot), BR_i(t_i, \beta^k)) \mu_i(dt_i) = 0.$$

The intuition behind conditions (ii) and (iii) is the following. For every player i and every $k \in \mathbf{N}$, define a function $X_i^k : T_i \rightarrow \mathbf{R}$ by $X_i^k(t_i) = \rho^w(\beta_i^k(t_i, \cdot), \beta_i(t_i, \cdot))$, and a function $Y_i^k : T_i \rightarrow \mathbf{R}$ by $Y_i^k(t_i) = \rho^w(\beta_i^k(t_i, \cdot), BR_i(t_i, \beta^k))$. Due to the assumptions M1 and M2, these functions are measurable, and therefore they are random variables on the measurable space (T_i, \mathcal{T}_i) . Conditions (ii.1) and (ii.2) respectively require that both sequences X_i^k and Y_i^k converge in probability to zero (i.e. to the random variable that is zero everywhere). So, the probability that X_i^k and Y_i^k are far from zero becomes negligible for large k . Conditions (iii.1) and (iii.2) mean that both sequences X_i^k and Y_i^k converge in expectation to zero, with respect

to the distribution μ_i . This makes intuitive sense because the type of player i is drawn from T_i according to μ_i .

Proof. The implication (i)→(ii) follows immediately from the fact that pointwise convergence almost everywhere implies convergence in probability. The implication (ii)→(iii) is also valid, because the sequences X_i^k and Y_i^k are uniformly bounded and hence if they converge in probability to zero, then they also converge to zero in expectation. So as to prove the implication (iii)→(i), we argue that both implications (iii)→(ii) and (ii)→(i) are valid. The implication (iii)→(ii) holds because convergence in expectation implies convergence in probability. Finally, the implication (ii)→(i) follows from the fact that convergence in probability implies the existence of a subsequence that pointwisely converges to the same limit almost everywhere. Hence, if the sequences X_i^k and Y_i^k converge in probability to zero, then there are subsequences $X_i^{k_m}$ and $Y_i^{k_m}$ which satisfy the conditions of Definition 3.3.6. ■

The equivalence of the conditions of Proposition 3.3.11 is remarkable in view of the fact that pointwise convergence almost everywhere, convergence in probability and convergence in expectation are not equivalent in general.

Perfection in finite Bayesian games

In this subsection, we discuss some direct consequences of our previous results on Bayesian games in which there are only finitely many types and actions. A behavioral strategy for player i in such games is a function $\beta_i : T_i \rightarrow \Delta(A_i)$, where $\Delta(A_i)$ is the set of mixed strategies on A_i . Behavioral strategy β_i is called completely mixed if $\beta_i(t_i)$ is a completely mixed strategy for each type $t_i \in T_i$. A direct generalization of Selten's perfect equilibrium to finite Bayesian games is defined as follows:

Definition 3.3.12 A (behavioral) strategy profile $\beta = (\beta_1, \dots, \beta_n)$ is called perfect if there exists a sequence of profiles of completely mixed (behavioral) strategies $(\beta^k)_{k=1}^\infty = (\beta_1^k, \dots, \beta_n^k)_{k=1}^\infty$ with the following properties for every player i and each type $t_i \in T_i$:

- (1) $\lim_{k \rightarrow \infty} d_E(\beta_i^k(t_i), \beta_i(t_i)) = 0,$
- (2) $\lim_{k \rightarrow \infty} d_E(\beta_i^k(t_i), BR_i(t_i, \beta^k)) = 0,$

where d_E is the Euclidean metric.

It is clear that the uniform and the pointwise approaches coincide. The a.e.-pointwise approach can however lead to different results, but only in the - perhaps less interesting - case when certain types occur with probability 0.

Theorem 3.3.13 *Every Bayesian game with finitely many types and actions admits a pointwise-perfect (or equivalently, uniform-perfect) BNE.*

Proof. We only provide a sketch of the proof. First, consider the corresponding game G' with ex-ante probabilities in which each player i has action set $A'_i = \times_{t_i \in T_i} A_i$ and wants to maximize his ex-ante expected payoff, i.e. his expected payoff before he learns his own type. The game G' is a game with complete information and with finite action spaces, so it has a perfect equilibrium σ in the classical sense with a corresponding sequence of completely mixed strategies $(\sigma^k)_{k=1}^\infty$. Let β be the (unique) strategy in the original game G such that, given any type $t_i \in T_i$, the strategies σ and β induce the same probability on every action $a_i \in A_i$, i.e. $\beta(t_i, a_i) = \sigma(A'_i[t_i, a_i])$, where $A'_i[t_i, a_i]$ is the set of all members of A'_i whose coordinate at position t_i is exactly a_i . Define β^k for every $k \in \mathbb{N}$ in a similar way with regard to σ^k . It is not difficult to see that β is an a.e.-pointwise-perfect BNE, with the sequence $(\beta^k)_{k=1}^\infty$ and with S_i being for every player i the set of all types $t_i \in T_i$ that occur with probability 0. The reason is that if a type $t_i \in T_i$ occurs with a positive probability, then this type is also taken into account by the ex-ante approach. Now, Proposition 3.3.8 completes the proof. ■

3.4 A second-price auction with interdependent values

We examine perfect equilibrium in a second price auctions with interdependent values, in which bidders have no dominant strategies. We show that perfect equilibrium is a useful tool to select the more natural BNEs in this auction.

Consider the following sealed-bid second price auction Γ^α for a single indivisible object, where α is a parameter in $(0, 1)$. There are two bidders, whose respective types t_1 and t_2 are drawn independently from $T_1 = T_2 = [0, 1]$ according to the uniform distribution. The evaluations of the bidders are symmetric and are given by $v_1(t_1, t_2) = 5 + t_1 - \alpha t_2$ and $v_2(t_1, t_2) = 5 + t_2 - \alpha t_1$. The set of available bids is $A_1 = A_2 = [5 - \alpha, 6]$. The tie-breaking rule can be arbitrary, and plays no role in our analysis.

We present different types of BNEs in Γ^α and show that perfection eliminates the less natural ones. As the proofs in this section are technical in nature, we only discuss the main results, and defer the formal proofs to the appendix.

A symmetric BNE

For each bidder i , define the pure strategy $B_i(t_i) = 5 + (1 - \alpha)t_i$, and denote by β_i the corresponding deterministic strategy.

Proposition 3.4.1 *The symmetric deterministic strategy profile $\beta = (\beta_1, \beta_2)$ is a BNE.*

It turns out that β is unique within a certain class of strategies. Let \mathfrak{F} be the class of deterministic strategies in which the corresponding pure strategies $p_i : T_i \rightarrow A_i$ for bidders $i = 1, 2$ satisfy the following conditions:

- (i) $p_1(0) = p_2(0)$ and $p_1(1) = p_2(1)$,
- (ii) p_i is differentiable and $\frac{d}{dt_i}p_i(t_i) > 0$ for every $t_i \in T_i$.

Now, we have the following proposition:

Proposition 3.4.2 *The BNE β is the only pure BNE in class \mathfrak{F} .*

Proposition 3.4.3 *The BNE β is not sincere in the sense that for each bidder i , $B_i(t_i)$ does not equal his expected evaluation of the object given t_i , except for $t_i = \frac{1}{2}$.*

Proposition 3.4.4 *Neither bidder has a dominant strategy in the auction Γ^α in the following sense: neither bidder i has a strategy β_i such that for every type t_i , every strategy σ_i of bidder i and every strategy β_{-i} of bidder i 's opponents we have*

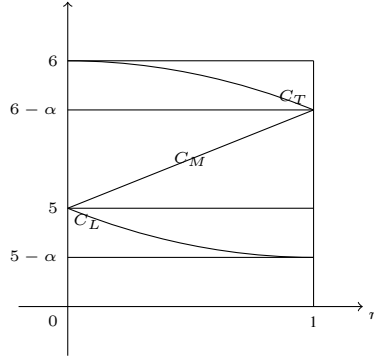
$$\mathbf{E}_{\beta_{-i}}(\Pi_i \mid t_i, \beta_i) \geq \mathbf{E}_{\beta_{-i}}(\Pi_i \mid t_i, \sigma_i).$$

In fact we will prove a stronger statement. Namely, in the above statement we could replace “every type t_i ” by “every type t_i in a subset of types with a strictly positive measure”. In view of the previous proposition, dominance is not a useful criterion to select BNEs in this auction. Nevertheless, as we will show, perfection can be used with great effect.

Proposition 3.4.5 *The BNE β is uniform-perfect.*

We will now describe the idea of the proof. Let $C_M : [0, 1] \rightarrow [5 - \alpha, 6]$ be defined by $C_M(r) = 5 + (1 - \alpha)r$ for all $r \in [0, 1]$ and μ be the uniform distribution on $[5 - \alpha, 6]$. The first idea would be to look at the sequences of completely mixed strategies $\hat{\beta}_i^k$ given by $\hat{\beta}_i^k(t_i, \cdot) = (1 - \varepsilon_k)\delta_{C_M(t_i)}(\cdot) + \varepsilon_k\mu(\cdot)$ for both players $i = 1, 2$ and for every t_i , where δ is the Dirac measure and ε_k is a sequence in $(0, 1)$

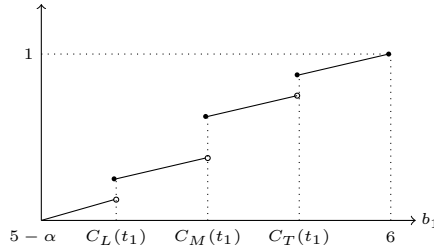
converging to zero. One can verify that the sequence $\hat{\beta}_i^k$ satisfies condition (1) of Definition 3.3.1, and $\lim_{k \rightarrow \infty} \rho^w(\hat{\beta}_i^k(t_i, \cdot), BR_i(t_i, \hat{\beta}^k)) = 0$ for every $t_i \in (0, 1)$. However, the latter does not hold for $t_i = 0, 1$. More precisely, one can easily check that $BR_i(0, \hat{\beta}^k) = \{5 - \frac{1}{2}\alpha\}$ and $BR_i(1, \hat{\beta}^k) = \{6 - \frac{1}{2}\alpha\}$, for every k . However, by defining the completely mixed strategies in a more delicate way, we can prove that (β_1, β_2) is uniform-perfect. We introduce two more curves $C_T, C_L : [0, 1] \rightarrow [5 - \alpha, 6]$ by $C_T(r) = 6 - \alpha r^2$, and $C_L(r) = 5 - \alpha + \alpha(1 - r)^2$. These curves are depicted in the picture below.



The curves C_T and C_L will be used to repair the above mentioned problem for types 0 and 1. For every $k \in \mathbf{N}$, let $\varepsilon_k = \frac{1}{k+3}$ and $\beta_1^k : T_1 \times \mathcal{A}_1 \rightarrow [0, 1]$ be the completely mixed strategy for bidder 1 which is given for every $t_1 \in T_1 = [0, 1]$ by

$$\beta_1^k(t_1, \cdot) = (1 - 2\varepsilon_k - \varepsilon_k^2) \delta_{C_M(t_1)}(\cdot) + \varepsilon_k \delta_{C_T(t_1)}(\cdot) + \varepsilon_k \delta_{C_L(t_1)}(\cdot) + \varepsilon_k^2 \mu(\cdot).$$

The cumulative probability distribution with respect to $\beta_1^k(t_1, \cdot)$ is shown on $A_1 = [5 - \alpha, 6]$ in the picture below.



Similarly, define a completely mixed strategy β_2^k for bidder 2. We will show that the sequence of strategy profiles $(\beta^k)_{k=1}^\infty = (\beta_1^k, \beta_2^k)_{k=1}^\infty$ satisfies conditions 1 and 2 of Definition 3.3.1.

Other BNEs

In this subsection, we present other BNEs for the auction. They are arguably less intuitive and, as we show, perfection eliminates all of them. We start with Wolf and Sheep BNEs.

Proposition 3.4.6 *The deterministic strategy profile $\sigma = (\sigma_1, \sigma_2)$, given by $\sigma_1(t_1, \cdot) = \delta_6(\cdot)$ for every $t_1 \in T_1$ and $\sigma_2(t_2, \cdot) = \delta_{5-\alpha}(\cdot)$ for every $t_2 \in T_2$, is a BNE. However, σ is not pointwise-perfect, and hence not uniform-perfect either.*

It is worthwhile to note that the BNE introduced in Proposition 3.4.6 is just one of the many other BNEs of the same type. In all of this type of BNEs, the lowest bid of Wolf player is strictly larger than the highest bid of Sheep player.

The following proposition considers a deterministic BNE in which the corresponding pure strategies, as functions of the types, are not continuous.

Proposition 3.4.7 *The deterministic strategy profile $\eta = (\eta_1, \eta_2)$ is a BNE, where η_1 and η_2 correspond to the pure strategies b_1 and b_2 given by*

$$b_1(t_1) = \begin{cases} 5 & \text{if } t_1 \in [0, x(\alpha)] \\ 6 & \text{if } t_1 \in (x(\alpha), 1] \end{cases} \quad \text{and} \quad b_2(t_2) = \begin{cases} 5 - \alpha & \text{if } t_2 \in [0, y(\alpha)] \\ 5.1 & \text{if } t_2 \in (y(\alpha), 1] \end{cases},$$

with $x(\alpha) = \frac{0.4+2\alpha}{4-\alpha^2}$ and $y(\alpha) = \frac{\alpha(0.2+\alpha)}{4-\alpha^2}$.

However, η is not pointwise-perfect, and hence not uniform-perfect either.

3.5 Appendix I: Proofs for the auction in Section 3.4

Throughout the Appendix.2, we will use the notion $\mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, b_2)$ for bidder 2's expected profit given his type t_2 and bid b_2 against a strategy τ_1 of bidder 1. If bidder 1 makes a bid $b_1 > b_2$, then bidder 2 does not win the object and has zero profit. Therefore, if bidding b_2 against τ_1 leads to a tie with zero ex-ante probability, then we have

$$\mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, b_2) = \int_0^1 \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \tau_1(t_1, db_1) dt_1. \quad (3.5)$$

Since the function $5 + t_2 - \alpha t_1 - b_1$ is bounded on $[0, 1] \times [5 - \alpha, 6]$ and measurable with respect to $\mathcal{T} \times \mathcal{A}$, then according to Theorem 4.6.5, $\mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, b_2)$ is well-defined.

In the special case when τ_1 is a deterministic strategy, i.e. when $\tau_1(t_1, \cdot) = \delta_{p_1(t_1)}(\cdot)$ for a pure strategy p_1 , we have

$$\int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \tau_1(t_1, db_1) =$$

$$\begin{cases} 5 + t_2 - \alpha t_1 - p_1(t_1) & \text{if } p_1(t_1) \in [5 - \alpha, b_2] \\ 0 & \text{if } p_1(t_1) \in (b_2, 6]. \end{cases}$$

Hence, if p_1 is increasing and $b_2 \in p_1(T_1)$, then we have

$$\mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, b_2) = \int_0^{p_1^{-1}(b_2)} (5 + t_2 - \alpha t_1 - p_1(t_1)) dt_1. \quad (3.6)$$

Proof of Proposition 3.4.1

We prove that the deterministic strategy profile $\beta = (\beta_1, \beta_2)$ in which β_i corresponds to the pure strategy $B_i(t_i) = 5 + (1 - \alpha)t_i$ for each bidder i , is a BNE. For this purpose, we prove that β_2 is a best response against β_1 . Then, due to symmetry, β_1 is also a best response against β_2 , and the proof will be complete.

According to (3.6), if $b_2 \in [5, 6 - \alpha]$ then we have

$$\begin{aligned} \mathbf{E}_{\beta_1}(\Pi_2 \mid t_2, b_2) &= \int_0^{B_1^{-1}(b_2)} (5 + t_2 - \alpha t_1 - B_1(t_1)) dt_1 \\ &= \int_0^{\frac{b_2 - 5}{1 - \alpha}} (5 + t_2 - \alpha t_1 - 5 - (1 - \alpha)t_1) dt_1 \\ &= \int_0^{\frac{b_2 - 5}{1 - \alpha}} (t_2 - t_1) dt_1 \\ &= t_2 \left(\frac{b_2 - 5}{1 - \alpha} \right) - \frac{1}{2} \left(\frac{b_2 - 5}{1 - \alpha} \right)^2. \end{aligned}$$

By taking the first derivative with respect to b_2

$$\frac{d}{db_2} \mathbf{E}_{\beta_1}(\Pi_2 \mid t_2, b_2) = \frac{t_2}{1 - \alpha} - \frac{1}{1 - \alpha} \left(\frac{b_2 - 5}{1 - \alpha} \right).$$

It is clear that

$$\frac{d}{db_2} \mathbf{E}_{\beta_1}(\Pi_2 \mid t_2, 5) \geq 0 \quad \text{and} \quad \frac{d}{db_2} \mathbf{E}_{\beta_1}(\Pi_2 \mid t_2, 6 - \alpha) \leq 0,$$

which implies that the maximum of $\mathbf{E}_{\beta_1}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [5, 6 - \alpha]$ is attained where $\frac{d}{db_2} \mathbf{E}_{\beta_1}(\Pi_2 \mid t_2, b_2) = 0$. This happens exactly when

$$b_2 = 5 + (1 - \alpha)t_2 = B_2(t_2).$$

Notice that, for bidder 2, bidding less than 5 is never better than bidding 5 exactly, because all bids less than or equal to 5 win against β_1 with probability 0. Similarly, bidding more than $6 - \alpha$ is never better than bidding $6 - \alpha$ exactly, because all bids larger than or equal to $6 - \alpha$ win against β_1 with probability 1. Therefore, β_2 is a best response to β_1 as claimed.

Proof of Proposition 3.4.2

Consider two pure strategies p_1 and p_2 that satisfy conditions (i), (ii) of Proposition 3.4.2, and the corresponding deterministic strategies τ_1 and τ_2 . Suppose that (τ_1, τ_2) is a BNE. Our goal is to show that $p_1(t_1) = 5 + (1 - \alpha)t_1$ and $p_2(t_2) = 5 + (1 - \alpha)t_2$.

Notice that $p_1 : T_1 \rightarrow A_1$ and $p_2 : T_2 \rightarrow A_2$ are continuous and invertible, and therefore they have a continuous inverse. Thus, because $p_1(T_1) = p_2(T_2)$, the function $\hat{p} = p_1^{-1} \circ p_2$ is well defined and it is a continuous bijection from T_2 to T_1 .

First we argue that $p_2(0) \leq 5$. Suppose by way of contradiction that $p_2(0) > 5$. According to (3.6) we have

$$\mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, p_2(t_2)) = \int_0^{\hat{p}(t_2)} (5 + t_2 - \alpha t_1 - p_1(t_1)) dt_1.$$

Notice that if $t_2 > 0$ then $\hat{p}(t_2) > 0$ due to conditions (i) and (ii), and moreover, for every type $t_2 < p_2(0) - 5$ we have

$$5 + t_2 - \alpha t_1 - p_1(t_1) \leq 5 + t_2 - p_1(t_1) \leq 5 + t_2 - p_1(0) = 5 + t_2 - p_2(0) < 0.$$

Therefore, $\mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, p_2(t_2))$ is strictly negative. However, as $p_1(0) = p_2(0) > 5$, bidder 2 can get zero by bidding 5 for instance, which never wins. This is a contradiction with the assumption that τ_2 is a best response to τ_1 , so $p_2(0) \leq 5$ holds indeed.

Now we prove that $p_2(1) \geq 6 - \alpha$. Write $c := 6 - \alpha - p_2(1)$ and suppose by way of contradiction that $c > 0$. According to (3.6), if we compare bids $p_2(1)$ and $p_2(t_2)$ for bidder 2 when his type is t_2 , we obtain

$$\mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, p_2(1)) - \mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, p_2(t_2)) = \int_{\hat{p}(t_2)}^1 (5 + t_2 - \alpha t_1 - p_1(t_1)) dt_1.$$

Notice that if $t_2 \in (1 - c, 1)$, then $\hat{p}(t_2) < 1$ due to conditions (i) and (ii), and moreover, for every $t_1 \in [0, 1]$ we have

$$\begin{aligned} 5 + t_2 - \alpha t_1 - p_1(t_1) &\geq 5 + t_2 - \alpha - p_1(1) \\ &= 5 + t_2 - \alpha - p_2(1) \\ &= 5 + t_2 - \alpha + c - 6 + \alpha \\ &= -1 + t_2 + c \\ &> 0. \end{aligned}$$

Therefore, for every $t_2 \in (1 - c, 1)$

$$\mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, p_2(1)) - \mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, p_2(t_2)) > 0,$$

which is in contradiction with the assumption that τ_2 is a best response to τ_1 . Hence, $p_2(1) \geq 6 - \alpha$ holds indeed.

Now, we calculate bidder 2's best response bids against τ_1 , given his type t_2 . It is clear that, for any type t_2 , bidding $p_2(0)$ is not worse than any bid in $[5 - \alpha, p_2(0)]$, because all these bids win with probability zero against τ_1 . Similarly, bidding $p_2(1)$ is not worse than any bid in $[p_2(1), 6]$, because all these bids win with probability 1 against τ_1 . It remains to determine the best bids in the interval $[p_2(0), p_2(1)]$, which we do by examining the derivative of $\mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, b_2)$ with respect to b_2 . By (3.6), we have for every bid $b_2 \in [p_2(0), p_2(1)]$ that

$$\begin{aligned} \mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, b_2) &= \int_0^{p_1^{-1}(b_2)} (5 + t_2 - \alpha t_1 - p_1(t_1)) dt_1 \\ &= \left[(5 + t_2)t_1 - \frac{\alpha}{2} t_1^2 \right]_0^{p_1^{-1}(b_2)} - \int_0^{p_1^{-1}(b_2)} p_1(t_1) dt_1 \\ &= (5 + t_2)p_1^{-1}(b_2) - \frac{\alpha}{2} (p_1^{-1}(b_2))^2 - \int_0^{p_1^{-1}(b_2)} p_1(t_1) dt_1. \end{aligned}$$

Therefore, the first derivative with respect to b_2 is

$$\begin{aligned} \frac{d}{db_2} \mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, b_2) &= \frac{1}{p_1'(p_1^{-1}(b_2))} \cdot (5 + t_2 - \alpha p_1^{-1}(b_2)) \\ &\quad - \frac{1}{p_1'(p_1^{-1}(b_2))} p_1(p_1^{-1}(b_2)) \\ &= \frac{1}{p_1'(p_1^{-1}(b_2))} \cdot (5 + t_2 - \alpha p_1^{-1}(b_2) - b_2). \end{aligned}$$

Because $\hat{p}(0) = p_1^{-1}(p_2(0)) = p_1^{-1}(p_1(0)) = 0$ and $p_1'(p_1^{-1}(b_2)) > 0$ by conditions (i) and (ii), and because $p_2(0) \leq 5$ we have for every $t_2 > 0$ that

$$\frac{d}{db_2} \mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, p_2(0)) > 0. \quad (3.7)$$

Similarly, because $\hat{p}(1) = p_1^{-1}(p_2(1)) = p_1^{-1}(p_1(1)) = 1$ and $p_1'(p_1^{-1}(b_2)) > 0$ by conditions (i) and (ii), and because $p_2(1) \geq 6 - \alpha$ we have for every $t_2 < 1$ that

$$\frac{d}{db_2} \mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, p_2(1)) < 0. \quad (3.8)$$

In view of (3.7) and (3.8), for all $t_2 \in (0, 1)$, each best response bid b_2 in $[p_2(0), p_2(1)]$ has to satisfy

$$\frac{d}{db_2} \mathbf{E}_{\tau_1}(\Pi_2 \mid t_2, b_2) = 0,$$

which is equivalent to

$$b_2 = 5 + t_2 - \alpha p_1^{-1}(b_2).$$

Because τ_2 is a best response against τ_1 , we must have for every $t_2 \in (0, 1)$ that

$$p_2(t_2) = 5 + t_2 - \alpha p_1^{-1}(p_2(t_2)) = 5 + t_2 - \alpha \hat{p}(t_2).$$

By continuity of p_2 and \hat{p} , we obtain for all $t_2 \in [0, 1]$ that

$$p_2(t_2) = 5 + t_2 - \alpha \hat{p}(t_2). \quad (3.9)$$

With a similar argument for bidder 1, we have for all $t_1 \in [0, 1]$ that

$$p_1(t_1) = 5 + t_1 - \alpha \hat{p}^{-1}(t_1). \quad (3.10)$$

By equation (3.10) we have for all $t_2 \in [0, 1]$ that

$$p_1(\hat{p}(t_2)) = 5 + \hat{p}(t_2) - \alpha \hat{p}^{-1}(\hat{p}(t_2)),$$

which yields $p_2(t_2) = 5 + \hat{p}(t_2) - \alpha t_2$. Thus, by equation (3.9) we have

$$5 + \hat{p}(t_2) - \alpha t_2 = 5 + t_2 - \alpha \hat{p}(t_2),$$

which implies $\hat{p}(t_2) = t_2$. Hence, from (3.9) we derive that

$$p_2(t_2) = 5 + (1 - \alpha)t_2,$$

and because of symmetry also that

$$p_1(t_1) = 5 + (1 - \alpha)t_1,$$

so the proof of Proposition 3.4.2 is complete.

Proof of Proposition 3.4.3

Due to symmetry, it suffices to prove the statement only for bidder 1. Notice that bidder 1's expected evaluation of the object given his type t_1 is

$$\mathbf{E}(v_1(t_1, t_2) \mid t_1) = \mathbf{E}(5 + t_1 - \alpha t_2 \mid t_1) = 5 + t_1 - \frac{\alpha}{2},$$

which differs from $B_1(t_1) = 5 + (1 - \alpha)t_1$ for every type $t_1 \in [0, 1] \setminus \{\frac{1}{2}\}$, as claimed. It is worthwhile to mention that even if we look at the situation in which bidder 1 knows that he is winning, still his expected evaluation of the object given his type t_1 is not equal to his bid almost everywhere :

$$\begin{aligned} \mathbf{E}(v_1(t_1, t_2) \mid b_1(t_1) > b_2(t_2)) &= \mathbf{E}(5 + t_1 - \alpha t_2 \mid t_1 > t_2) \\ &= 5 + t_1 - \alpha \mathbf{E}(t_2 \mid t_1 > t_2) = 5 + t_1 - \frac{\alpha}{2}t_1, \end{aligned}$$

which is strictly larger than $B_1(t_1) = 5 + (1 - \alpha)t_1$ for every type $t_1 \in (0, 1]$.

Proof of Proposition 3.4.4

We prove that neither bidder has a dominant strategy. To this end we prove that every strategy σ_i of player $i = 1, 2$ is not dominant. Suppose σ_2 is a dominant strategy for bidder 2. Notice that if bidder 1 chooses strategy β_1 and if bidder 2 is given type $t_2 \in (0, 1)$, then bidding β_2 is bidder 2's unique best response (see the proof of Proposition 3.4.1). This implies that $\sigma_2 = \beta_2$. Now we show that the strategies β_2 is not in dominant strategies. To this end we show that β_2 is not a best response against all strategies of bidder 1. Suppose that bidder 1's strategy is given by $\lambda_1(t_1, \cdot) = \delta_{b_1(t_1)}(\cdot)$ for every $t_1 \in T_1$, where

$$b_1(t_1) = \begin{cases} \frac{11}{2} & \text{if } t_1 \in [0, \frac{1}{2}] \\ 6 & \text{if } t_1 \in (\frac{1}{2}, 1]. \end{cases}$$

We prove that if $t_2 = \frac{1+\alpha}{2}$, then β_2 is not a best response for bidder 2 against λ_1 . Notice that bidder 2 gets zero by bidding $B_2(\frac{1+\alpha}{2})$, because it never wins against λ_1 due to $B_2(\frac{1+\alpha}{2}) = 5 + (1 - \alpha)(\frac{1+\alpha}{2}) < \frac{11}{2}$. However, by (3.6), bidder 2's expected profit given type $t_2 = \frac{1+\alpha}{2}$ and $b_2 \in (\frac{11}{2}, 6)$ is

$$\mathbf{E}_{\lambda_1}(\Pi_2 \mid \frac{1+\alpha}{2}, b_2) = \int_0^{\frac{1}{2}} \left(5 + \frac{1+\alpha}{2} - \alpha t_1 - \frac{11}{2} \right) dt_1 = \frac{\alpha}{8} > 0.$$

This shows that if $t_2 = \frac{1+\alpha}{2}$ then bidding $b_2 \in (\frac{11}{2}, 6)$ is strictly better than bidding $B_2(\frac{1+\alpha}{2})$. Hence, β_2 is not in dominant strategies. This proves that bidder 2 does not have a dominant strategy at all, and by symmetry the same is true for bidder 1. The proof is complete.

Proof of Proposition 3.4.5

We prove that the BNE $\beta = (\beta_1, \beta_2)$ is uniform-perfect. For this purpose, define the curves $C_M, C_T, C_L : [0, 1] \rightarrow [5 - \alpha, 6]$ by

$$C_M(t_1) = 5 + (1 - \alpha)t_1,$$

$$C_T(t_1) = 6 - \alpha t_1^2,$$

$$C_L(t_1) = 5 - \alpha + \alpha(1 - t_1)^2.$$

Let μ be the uniform distribution on $A_1 = [5 - \alpha, 6]$. For every $k \in \mathbf{N}$, let $\varepsilon_k = \frac{1}{k+3}$ and $\beta_1^k : T_1 \times \mathcal{A}_1 \rightarrow [0, 1]$ be the completely mixed strategy for bidder 1 which is given for every $t_1 \in T_1 = [0, 1]$ by

$$\beta_1^k(t_1, \cdot) = (1 - 2\varepsilon_k - \varepsilon_k^2) \delta_{C_M(t_1)}(\cdot) + \varepsilon_k \delta_{C_T(t_1)}(\cdot) + \varepsilon_k \delta_{C_L(t_1)}(\cdot) + \varepsilon_k^2 \mu(\cdot).$$

Similarly, define a completely mixed strategy β_2^k for bidder 2. We show that the sequence of strategy profiles $(\beta^k)_{k=1}^\infty = (\beta_1^k, \beta_2^k)_{k=1}^\infty$ satisfies conditions 1 and 2 of Definition 3.3.1.

It is clear from the definition of $\beta_i(t_i, \cdot)$ and $\beta_i^k(t_i, \cdot)$, for each bidder i , that

$$\sup_{t_i \in T_i} \rho^w(\beta_i^k(t_i, \cdot), \beta_i(t_i, \cdot)) = 2\varepsilon_k + \varepsilon_k^2.$$

Hence, condition 1 of Definition 3.3.1 is satisfied. Condition 2 of Definition 3.3.1 follows from the claim below.

Claim: For every $\xi \in (0, \alpha)$, there is a $K_\xi \in \mathbf{N}$ such that for every $k > K_\xi$ we have:

1. For every $t_2 \in [0, \xi]$, the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [5 - \alpha, 6]$ can only be attained within $b_2 \in [5 - \xi, 5 + 2\xi(1 - \alpha)]$.
2. For every $t_2 \in [\xi, 1 - \xi]$, the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [5 - \alpha, 6]$ can only be attained within $b_2 \in [C_M(t_2) - \xi(1 - \alpha), C_M(t_2) + \xi(1 - \alpha)]$.
3. For every $t_2 \in (1 - \xi, 1]$ the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [5 - \alpha, 6]$ can only be attained within $b_2 \in [6 - \alpha - 2\xi(1 - \alpha), 6 - \alpha + \xi]$.

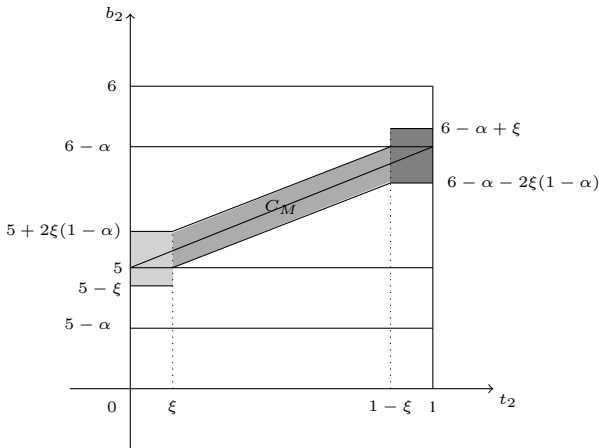


Figure 3.1: bidder 2's best response bids

The above claim is illustrated in Figure 3.1. According to the claim, the gray area includes all best response bids for bidder 2 if $k > K_\xi$.

Take an arbitrary $\xi \in (0, \min\{\alpha, \frac{1}{2}\})$. To prove this claim, it is enough to show that the following claims 1, 2 and 3 are valid. These claims corresponds to three cases, i.e., $6 - \alpha \leq b_2 \leq 6$, $5 - \alpha \leq b_2 \leq 5$ and $5 \leq b_2 \leq 6 - \alpha$.

Claim 1: for the case $6 - \alpha \leq b_2 \leq 6$

There is an $M_\xi^1 \in \mathbf{N}$ such that for every $k > M_\xi^1$ we have:

1. For every $t_2 \in [0, 1 - \xi]$, the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [6 - \alpha, 6]$ is attained at $b_2 = 6 - \alpha$.
2. For every $t_2 \in (1 - \xi, 1]$, the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [6 - \alpha, 6]$ can only be attained within $b_2 \in [6 - \alpha, 6 - \alpha + \xi]$.

Claim 2: for the case $5 - \alpha \leq b_2 \leq 5$

There is an $M_\xi^2 \in \mathbf{N}$ such that for every $k > M_\xi^2$ we have:

1. For every $t_2 \in [\xi, 1]$, the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [5 - \alpha, 5]$ is attained at $b_2 = 5$.
2. For every $t_2 \in [0, \xi]$, the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [5 - \alpha, 5]$ can only be attained within $b_2 \in [5 - \xi, 5]$.

Claim 3: for case $5 \leq b_2 \leq 6 - \alpha$

There is an $M_\xi^3 \in \mathbf{N}$ such that for every $k > M_\xi^3$ we have:

1. For every $t_2 \in [\xi, 1 - \xi]$, the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [5, 6 - \alpha]$ can only be attained within $b_2 \in [C_M(t_2) - \xi(1 - \alpha), C_M(t_2) + \xi(1 - \alpha)]$.
2. For every $t_2 \in [0, \xi]$, the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [5, 6 - \alpha]$ can only be attained within $b_2 \in [5, 5 + 2\xi(1 - \alpha)]$.
3. For every $t_2 \in (1 - \xi, 1]$ the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [5, 6 - \alpha]$ can only be attained within $b_2 \in [6 - \alpha - 2\xi(1 - \alpha), 6 - \alpha]$.

It is important to note that Part (1) of Claim 1 shows that for every $t_2 \in [0, 1 - \xi]$, the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [6 - \alpha, 6]$ is not more than the maximum over $b_2 \in [5, 6 - \alpha]$, which is verified in Claim 3. Similarly, Part (1) of Claim 2 indicates that for every $t_2 \in [\xi, 1]$, the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ over $b_2 \in [5 - \alpha, 5]$ is not more than the maximum over $b_2 \in [5, 6 - \alpha]$.

Proof of Claim 1: We compute $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ for every $b_2 \in [6 - \alpha, 6]$. Note that $C_T^{-1}(b_2) \in [0, 1]$ is the unique type t_1 for bidder 1 such that $C_T(t_1) = b_2$. By

the definition of C_T , we have $C_T^{-1}(b_2) = \sqrt{\frac{6-b_2}{\alpha}}$. Therefore, by (3.5)

$$\begin{aligned} \mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2) &= \int_0^1 \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \beta_1^k(t_1, db_1) dt_1 \\ &= \int_0^{C_T^{-1}(b_2)} \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \beta_1^k(t_1, db_1) dt_1 \quad \text{I} \\ &\quad + \int_{C_T^{-1}(b_2)}^1 \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \beta_1^k(t_1, db_1) dt_1. \quad \text{II} \end{aligned}$$

From the definition of $\beta_1^k(t_1, \cdot)$ we obtain

$$\begin{aligned} \text{I} &= (1 - 2\varepsilon_k - \varepsilon_k^2) \int_0^{C_T^{-1}(b_2)} (5 + t_2 - \alpha t_1 - C_M(t_1)) dt_1 \\ &\quad + \varepsilon_k \int_0^{C_T^{-1}(b_2)} (5 + t_2 - \alpha t_1 - C_L(t_1)) dt_1 \\ &\quad + \varepsilon_k^2 \int_0^{C_T^{-1}(b_2)} \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \mu(db_1) dt_1. \end{aligned}$$

Similarly, we have

$$\begin{aligned} \text{II} &= (1 - 2\varepsilon_k - \varepsilon_k^2) \int_{C_T^{-1}(b_2)}^1 (5 + t_2 - \alpha t_1 - C_M(t_1)) dt_1 \\ &\quad + \varepsilon_k \int_{C_T^{-1}(b_2)}^1 (5 + t_2 - \alpha t_1 - C_L(t_1)) dt_1 \\ &\quad + \varepsilon_k^2 \int_{C_T^{-1}(b_2)}^1 \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \mu(db_1) dt_1 \\ &\quad + \varepsilon_k \int_{C_T^{-1}(b_2)}^1 (5 + t_2 - \alpha t_1 - C_T(t_1)) dt_1. \end{aligned}$$

Hence, by the definition of the curves C_M , C_T , and C_L we obtain

$$\begin{aligned} \mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2) = \text{I} + \text{II} &= (1 - 2\varepsilon_k - \varepsilon_k^2) \int_0^1 (5 + t_2 - \alpha t_1 - 5 - (1 - \alpha)t_1) dt_1 \\ &\quad + \varepsilon_k \int_0^1 (5 + t_2 - \alpha t_1 - 5 + \alpha - \alpha(1 - t_1)^2) dt_1 \\ &\quad + \varepsilon_k^2 \int_0^1 \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \mu(db_1) dt_1 \\ &\quad + \varepsilon_k \int_{C_T^{-1}(b_2)}^1 (5 + t_2 - \alpha t_1 - 6 + \alpha t_1^2) dt_1. \end{aligned}$$

Thus,

$$\begin{aligned}
\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2) &= (1 - 2\varepsilon_k - \varepsilon_k^2)(t_2 - \frac{1}{2}) + \varepsilon_k(t_2 + \frac{\alpha}{6}) \\
&+ \frac{\varepsilon_k^2}{1 + \alpha} \int_{5-\alpha}^{b_2} (5 + t_2 - \frac{\alpha}{2} - b_1) db_1 \\
&+ \varepsilon_k \int_{C_T^{-1}(b_2)}^1 (-1 + t_2 - \alpha t_1 + \alpha t_1^2) dt_1.
\end{aligned}$$

Note that for every $t_2 \in [0, 1]$

$$\begin{aligned}
\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, 6 - \alpha) - \mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, 6) &= -\frac{\varepsilon_k^2}{1 + \alpha} \int_{6-\alpha}^6 (5 + t_2 - \frac{\alpha}{2} - b_1) db_1 \\
&- \varepsilon_k \int_0^1 (-1 + t_2 - \alpha t_1 + \alpha t_1^2) dt_1 \\
&= \left(\frac{\alpha}{1 + \alpha} \right) \varepsilon_k^2 (1 - t_2) + \varepsilon_k (1 - t_2 + \frac{\alpha}{6}),
\end{aligned}$$

which is strictly positive and also that $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ is continuous on the compact set $(t_2, b_2) \in [0, 1] \times [5 - \alpha, 6]$. Therefore, there is a $y > 0$ (without loss of generality we can assume that $y \in (0, \alpha - \xi)$, in order to make the analysis easier) such that for every $t_2 \in [0, 1]$ and $b_2 \in (6 - y, 6]$

$$\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, 6 - \alpha) > \mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2).$$

This means that for every $t_2 \in [0, 1]$, bidding $6 - \alpha$ is strictly better than any bid in the interval $(6 - y, 6]$. Hence, it suffices to prove Claim 1 over $b_2 \in [6 - \alpha, 6 - y]$. We do so by examining the first derivative of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ with respect to b_2 , which equals to

$$\frac{d}{db_2} \mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2) = \varepsilon_k^2 \cdot q_1(t_2, b_2) + \varepsilon_k \cdot q_2(t_2, b_2),$$

where

$$\begin{aligned}
q_1(t_2, b_2) &= \frac{1}{1 + \alpha} \cdot (5 + t_2 - \frac{\alpha}{2} - b_2) \\
q_2(t_2, b_2) &= \frac{1}{2\alpha \cdot C_T^{-1}(b_2)} \cdot (-1 + t_2 - \alpha C_T^{-1}(b_2) + \alpha (C_T^{-1}(b_2))^2).
\end{aligned}$$

Note that $q_2(t_2, b_2)$ is strictly negative for all $(t_2, b_2) \in [0, 1] \times [6 - \alpha, 6 - y] \setminus \{(1, 6 - \alpha)\}$, and $q_2(1, 6 - \alpha) = 0$.

Because q_2 is strictly negative on the compact set $[0, 1 - \xi] \times [6 - \alpha, 6 - y]$, it has a strictly negative upper-bound on $[0, 1 - \xi] \times [6 - \alpha, 6 - y]$. Therefore, since

ε_k^2 is relatively much smaller than ε_k for sufficiently large k , then $\frac{d}{db_2} \mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, b_2) < 0$ for all $(t_2, b_2) \in [0, 1 - \xi] \times [6 - \alpha, 6 - y]$. This proves that there exists an $N_\xi^1 \in \mathbf{N}$ such that for every $k > N_\xi^1$ we have $\frac{d}{db_2} \mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, b_2) < 0$ for all $(t_2, b_2) \in [0, 1 - \xi] \times [6 - \alpha, 6 - y]$. Hence, part (1) of Claim 1 holds for all $k > N_\xi^1$.

Because q_2 is strictly negative on the compact set $[1 - \xi, 1] \times [6 - \alpha + \xi, 6 - y]$, we can apply a similar argument and find an $L_\xi^1 \in \mathbf{N}$ such that part (2) of Claim 1 holds for every $k > L_\xi^1$. Therefore, by choosing $M_\xi^1 = \max\{N_\xi^1, L_\xi^1\}$, Claim 1 is valid for every $k > M_\xi^1$.

Proof of Claim 2: We compute $\mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, b_2)$ for every $b_2 \in [5 - \alpha, 5]$. Note that type $C_L^{-1}(b_2) \in [0, 1]$ is the unique type t_1 for bidder 1 such that $C_L(t_1) = b_2$. By the definition of C_L , we have $C_L^{-1}(b_2) = 1 - \sqrt{\frac{b_2 - 5}{\alpha} + 1}$. Hence, by (3.5)

$$\begin{aligned} \mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, b_2) &= \int_0^1 \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \beta_1^k(t_1, db_1) dt_1 \\ &= \int_0^{C_L^{-1}(b_2)} \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \beta_1^k(t_1, db_1) dt_1 \quad \text{III} \\ &+ \int_{C_L^{-1}(b_2)}^1 \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \beta_1^k(t_1, db_1) dt_1. \quad \text{IV} \end{aligned}$$

Therefore, we have

$$\begin{aligned} \text{III} &= \varepsilon_k^2 \int_0^{C_L^{-1}(b_2)} \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \mu(db_1) dt_1, \\ \text{IV} &= \varepsilon_k \int_{C_L^{-1}(b_2)}^1 (5 + t_2 - \alpha t_1 - C_L(t_1)) dt_1 \\ &+ \varepsilon_k^2 \int_{C_L^{-1}(b_2)}^1 \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \mu(db_1) dt_1. \end{aligned}$$

Hence, by the definition of the curve C_L we obtain

$$\begin{aligned} \mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, b_2) = \text{III} + \text{IV} &= \varepsilon_k^2 \int_0^1 \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \mu(db_1) dt_1 \\ &+ \varepsilon_k \int_{C_L^{-1}(b_2)}^1 (5 + t_2 - \alpha t_1 - 5 + \alpha - \alpha(1 - t_1)^2) dt_1 \\ &= \frac{\varepsilon_k^2}{1 + \alpha} \int_{5-\alpha}^{b_2} (5 + t_2 - \frac{\alpha}{2} - b_1) db_1 \\ &+ \varepsilon_k \int_{C_L^{-1}(b_2)}^1 (t_2 + \alpha t_1 - \alpha t_1^2) dt_1. \end{aligned}$$

Note that for every $t_2 \in [0, 1]$

$$\begin{aligned}
\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, 5) - \mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, 5 - \alpha) &= \frac{\varepsilon_k^2}{1 + \alpha} \int_{5-\alpha}^5 (5 + t_2 - \frac{\alpha}{2} - b_1) db_1 \\
&+ \varepsilon_k \int_0^1 (t_2 + \alpha t_1 - \alpha t_1^2) dt_1 \\
&= \left(\frac{\alpha}{1 + \alpha} \right) \varepsilon_k^2 t_2 + \varepsilon_k (t_2 + \frac{\alpha}{6}) > 0,
\end{aligned}$$

and also that $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ is continuous on the compact set $(t_2, b_2) \in [0, 1] \times [5 - \alpha, 5]$. Therefore, there is a $y > 0$ (similar to the previous case assume that $y \in (0, \alpha - \xi)$) such that for every $t_2 \in [0, 1]$ and $b_2 \in [5 - \alpha, 5 - \alpha + y)$

$$\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, 5) > \mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2).$$

This means that for every $t_2 \in [0, 1]$, bidding 5 is strictly better than any bid in the interval $[5 - \alpha, 5 - \alpha + y)$. Hence, it suffices to prove Claim 2 over the interval $[5 - \alpha + y, 5]$. We do so by examining the first derivative of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ with respect to b_2 , which equals to

$$\frac{d}{db_2} \mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2) = \varepsilon_k^2 p_1(t_2, b_2) + \varepsilon_k p_2(t_2, b_2),$$

where

$$\begin{aligned}
p_1(t_2, b_2) &= \frac{1}{1 + \alpha} \cdot (5 + t_2 - \frac{\alpha}{2} - b_2), \\
p_2(t_2, b_2) &= \frac{1}{2\alpha \cdot (1 - C_L^{-1}(b_2))} \cdot (t_2 + \alpha C_L^{-1}(b_2) - \alpha C_L^{-1}(b_2)^2).
\end{aligned}$$

Note that $p_2(t_2, b_2)$ is strictly positive for all $(t_2, b_2) \in [0, 1] \times [5 - \alpha + y, 5] \setminus \{(0, 5)\}$, and $p_2(0, 5) = 0$. With an argument similar to that of the previous case, we can find an M_ξ^2 such that for every $k > M_\xi^2$ Claim 2 is valid.

Proof of Claim 3: We compute $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$ for every $b_2 \in [5, 6 - \alpha]$. Note that $C_M^{-1}(b_2) = \frac{b_2 - 5}{1 - \alpha}$ for every $b_2 \in [5, 6 - \alpha]$. With a similar argument as before we have

$$\begin{aligned}
\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2) &= (1 - 2\varepsilon_k - \varepsilon_k^2) \int_0^{\frac{b_2 - 5}{1 - \alpha}} (5 + t_2 - \alpha t_1 - C_M(t_1)) dt_1 \\
&+ \varepsilon_k \int_0^1 (5 + t_2 - \alpha t_1 - C_L(t_1)) dt_1 \\
&+ \varepsilon_k^2 \int_0^1 \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \mu(db_1) dt_1.
\end{aligned}$$

Hence, by the definition of the curves C_M and C_L we obtain

$$\begin{aligned} \mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, b_2) &= (1 - 2\varepsilon_k - \varepsilon_k^2) \int_0^{\frac{b_2-5}{1-\alpha}} (5 + t_2 - \alpha t_1 - 5 - (1 - \alpha)t_1) dt_1 \\ &+ \varepsilon_k \int_0^1 (5 + t_2 - \alpha t_1 - 5 + \alpha - \alpha(1 - t_1)^2) dt_1 \\ &+ \varepsilon_k^2 \int_0^1 \int_{5-\alpha}^{b_2} (5 + t_2 - \alpha t_1 - b_1) \mu(db_1) dt_1. \end{aligned}$$

Thus,

$$\begin{aligned} \mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, b_2) &= (1 - 2\varepsilon_k - \varepsilon_k^2) \int_0^{\frac{b_2-5}{1-\alpha}} (t_2 - t_1) dt_1 \\ &+ \varepsilon_k \int_0^1 (t_2 + \alpha t_1 - \alpha t_1^2) dt_1 \\ &+ \frac{\varepsilon_k^2}{1 + \alpha} \int_{5-\alpha}^{b_2} (5 + t_2 - \frac{\alpha}{2} - b_1) db_1 \\ &= (1 - 2\varepsilon_k - \varepsilon_k^2) \left(t_2 \left(\frac{b_2 - 5}{1 - \alpha} \right) - \frac{1}{2} \left(\frac{b_2 - 5}{1 - \alpha} \right)^2 \right) \\ &+ \varepsilon_k \left(t_2 + \frac{\alpha}{6} \right) \\ &+ \frac{\varepsilon_k^2}{2(1 + \alpha)} (b_2 - 5 + \alpha)(5 + 2t_2 - b_2). \end{aligned}$$

So, the first derivative of $\mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, b_2)$ with respect to b_2 is

$$\begin{aligned} &\frac{d}{db_2} \mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, b_2) \\ &= \frac{1 - 2\varepsilon_k - \varepsilon_k^2}{1 - \alpha} \cdot \left(t_2 - \frac{b_2 - 5}{1 - \alpha} \right) + \frac{\varepsilon_k^2}{1 + \alpha} \left(5 + t_2 - \frac{\alpha}{2} - b_2 \right). \quad (3.11) \end{aligned}$$

First, we prove that for every $t_2 \in [\xi, 1 - \xi]$ the maximum of $\mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, b_2)$ cannot be attained on the boundary of interval $[5, 6 - \alpha]$. Observe that

$$\frac{d}{db_2} \mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, 5) = \frac{1 - 2\varepsilon_k - \varepsilon_k^2}{1 - \alpha} \cdot t_2 + \frac{\varepsilon_k^2}{1 + \alpha} \left(t_2 - \frac{\alpha}{2} \right),$$

and

$$\frac{d}{db_2} \mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, 6 - \alpha) = \frac{1 - 2\varepsilon_k - \varepsilon_k^2}{1 - \alpha} \cdot (t_2 - 1) + \frac{\varepsilon_k^2}{1 + \alpha} \left(t_2 - 1 + \frac{\alpha}{2} \right).$$

Hence, there is an $N_\xi^3 \in \mathbf{N}$ such that if $k > N_\xi^3$ then for every $t_2 \in [\xi, 1 - \xi]$ we have

$$\frac{d}{db_2} \mathbf{E}_{\beta_1^k}(\Pi_2 | t_2, 5) > 0$$

and

$$\frac{d}{db_2} \mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, 6 - \alpha) < 0.$$

Therefore, by the continuity of $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$, we can conclude for every $t_2 \in [\xi, 1 - \xi]$ that if b_2 maximizes $\mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2)$, then

$$\frac{d}{db_2} \mathbf{E}_{\beta_1^k}(\Pi_2 \mid t_2, b_2) = 0. \quad (3.12)$$

One can check with the help of (3.11) that the unique solution of (3.12), for every $t_2 \in [0, 1]$, is

$$b_2(t_2) = \frac{(1 - 2\varepsilon_k - \varepsilon_k^2)(1 + \alpha)}{v(\varepsilon_k)} \cdot (5 + (1 - \alpha)t_2) + \frac{\varepsilon_k^2(1 - \alpha)^2}{v(\varepsilon_k)} \left(5 + t_2 - \frac{\alpha}{2}\right),$$

where

$$v(\varepsilon_k) = (1 - 2\varepsilon_k - \varepsilon_k^2)(1 + \alpha) + \varepsilon_k^2(1 - \alpha)^2.$$

One can verify that

$$|b_2(t_2) - C_M(t_2)| = \frac{\alpha\varepsilon_k^2(1 - \alpha)^2}{v(\varepsilon_k)} \left| t_2 - \frac{1}{2} \right| \leq \frac{\alpha\varepsilon_k^2(1 - \alpha)^2}{2v(\varepsilon_k)}.$$

Therefore, there is an $L_\xi^3 \in \mathbf{N}$ such that for every $k > L_\xi^3$ and every $t_2 \in [0, 1]$ we have

$$|b_2(t_2) - C_M(t_2)| \leq \xi(1 - \alpha).$$

By choosing $M_\xi^3 = \max\{N_\xi^3, L_\xi^3\}$, for every $k > M_\xi^3$, part (1) of Claim 3 is valid.

Since at $t_2 = 0$, for every $b_2 \in [5, 6 - \alpha]$ we have

$$\frac{d}{db_2} \mathbf{E}_{\beta_1^k}(\Pi_2 \mid 0, b_2) = \frac{1 - 2\varepsilon_k - \varepsilon_k^2}{1 - \alpha} \cdot \left(-\frac{b_2 - 5}{1 - \alpha}\right) + \frac{\varepsilon_k^2}{1 + \alpha} \left(5 - \frac{\alpha}{2} - b_2\right) < 0,$$

the maximum at $t_2 = 0$ is obtained at $b_2 = 5$. Moreover, by part (1) of Claim 3 we have that if $k > \max\{N_\xi^3, L_\xi^3\}$, then for $t_2 = \xi$ the maximum is obtained within $b_2 \in [5, 5 + 2(1 - \alpha)\xi]$. One can verify that in (3.11), the first derivative of unique solution $b_2(t_2)$ is strictly positive, then we can conclude that for every $t_2 \in [0, \xi]$ the maximum is obtained within $b_2 \in [5, 5 + 2(1 - \alpha)\xi]$, for large k .

With a similar argument, since at $t_2 = 1$ for every $b_2 \in [5, 6 - \alpha]$ we have

$$\frac{d}{db_2} \mathbf{E}_{\beta_1^k}(\Pi_2 \mid 1, b_2) = \frac{1 - 2\varepsilon_k - \varepsilon_k^2}{1 - \alpha} \cdot \left(1 - \frac{b_2 - 5}{1 - \alpha}\right) + \frac{\varepsilon_k^2}{1 + \alpha} \left(6 - \frac{\alpha}{2} - b_2\right) > 0,$$

the maximum at $t_2 = 1$ is obtained in $b_2 = 6 - \alpha$. Moreover, if $k > \max\{N_\xi^3, L_\xi^3\}$, then for $t_2 = 1 - \xi$ the maximum is obtained within $b_2 \in [6 - \alpha - 2(1 - \alpha)\xi, 6 - \alpha]$. Similarly, since $b_2'(t_2)$ is strictly positive, we conclude that for every $t_2 \in (1 - \xi, 1]$ the maximum is obtained within $b_2 \in [6 - \alpha - 2(1 - \alpha)\xi, 6 - \alpha]$ for large k . This completes the proof of Claim 3, for every $k > M_\xi^3$.

Proofs of Propositions 3.4.6 and 3.4.7

It is easy to check that strategy profiles σ and η are BNEs.

We now prove that the BNE $\sigma = (\sigma_1, \sigma_2)$, in which $\sigma_1(t_1, \cdot) = \delta_6(\cdot)$ and $\sigma_2(t_2, \cdot) = \delta_{5-\alpha}(\cdot)$, is not pointwise-perfect, consequently is not uniform-perfect. Let $(\sigma_1^k)_{k=1}^\infty$ be a sequence of completely mixed strategies for bidder 1 such that $\rho^w(\sigma_1^k, \sigma_1) \rightarrow 0$ as $k \rightarrow \infty$. We show that bidder's 2 best response against σ_1^k does not converge to σ_2 when $k \rightarrow \infty$.

Suppose that bidder 1 plays σ_1^k , for some $k \in \mathbf{N}$. We prove that for $t_2 = 1$, the best response of bidder 2 is far from $\sigma_2(t_2, \cdot) = \delta_{5-\alpha}(\cdot)$. Note that bidder 2 gets always zero by choosing σ_2 , because he never wins. So, it is enough to show that his expected profit is strictly positive by bidding $6 - \alpha$, when $t_2 = 1$. We compute bidder 2's expected profit given type $t_2 = 1$ and bid $b_2 = 6 - \alpha$.

$$\mathbf{E}_{\sigma_1^k}(\Pi_2 \mid 1, 6 - \alpha) = \int_0^1 \int_{5-\alpha}^{6-\alpha} (5 + 1 - \alpha t_1 - b_1) \sigma_1^k(t_1, db_1) dt_1.$$

Since σ_1^k is a completely mixed strategy we have $\sigma_1^k(t_1, (5 - \alpha, 6 - \alpha)) > 0$, therefore by using the fact that $b_1 \in (5 - \alpha, 6 - \alpha)$ we have

$$\begin{aligned} \mathbf{E}_{\sigma_1^k}(\Pi_2 \mid 1, 6 - \alpha) &> \int_0^1 \int_{5-\alpha}^{6-\alpha} (5 + 1 - \alpha t_1 - 6 + \alpha) \sigma_1^k(t_1, db_1) dt_1 \\ &= \alpha \int_0^1 \int_{5-\alpha}^{6-\alpha} (1 - t_1) \sigma_1^k(t_1, db_1) dt_1 \geq 0. \end{aligned}$$

This implies that $\mathbf{E}_{\sigma_1^k}(\Pi_2 \mid 1, 6 - \alpha) > 0$, hence σ_2 is not pointwise-perfect.

With a similar argument, one can prove that the discontinuous BNE η is not pointwise-perfect, and hence not uniform-perfect either.

3.6 Appendix II: A measurability result for the weak distance

A metric space (X, d) is called σ -compact, if X is a countable union of compact subsets of X .

A strategy β_i for some player i is called simple if there exists a finite set $B \subseteq A_i$ such that $\beta_i(t_i, B) = 1$ for every $t_i \in T_i$.

Lemma 3.6.1 *Assume that the action space A_i is σ -compact for a player $i \in N$. Then, for every strategy β_i for player i , there exists a sequence $(\tau_i^k)_{k=1}^\infty$ of simple strategies such that*

$$\lim_{k \rightarrow \infty} \rho^w(\tau_i^k(t_i, \cdot), \beta_i(t_i, \cdot)) = 0 \quad (3.13)$$

for every type $t_i \in T_i$.

Proof. First we define the sequence $(\tau_i^k)_{k=1}^\infty$ and then we prove that this sequence satisfies equality (3.13).

Part 1: The definition of the sequence $(\tau_i^k)_{k=1}^\infty$: Since A_i is σ -compact, $A_i = \cup_{j=1}^\infty K_j$ for some compact sets $K_j \subseteq A_i$. Let $A_i^k = \cup_{j=1}^k K_j$ for every $k \in \mathbb{N}$. Note that A_i^k is compact for every $k \in \mathbb{N}$, the sequence $(A_i^k)_{k=1}^\infty$ is increasing and $A_i = \cup_{k=1}^\infty A_i^k$.

Take a $k \in \mathbb{N}$. For every $a \in A_i^k$, let $U^k(a) = \{a' \in A_i \mid d_{A_i}(a, a') < \frac{1}{k}\}$. Since A_i^k is compact, there exist actions $a_1^k, \dots, a_{J^k}^k \in A_i^k$ such that

$$A_i^k \subseteq \bigcup_{j=1}^{J^k} U^k(a_j^k).$$

Define $B_1^k = U^k(a_1^k) \cap A_i^k$, and $B_j^k = [U^k(a_j^k) \cap A_i^k] \setminus \cup_{\ell=1}^{j-1} U^k(a_\ell^k)$ for every $j = 2, \dots, J^k$. Without loss of generality we can assume, for every j , that B_j^k is non-empty; otherwise we could leave out a_j^k from the list $a_1^k, \dots, a_{J^k}^k$. Thus, $\{B_1^k, \dots, B_{J^k}^k\}$ forms a partition of A_i^k . Moreover, by construction, $B_j^k \in \mathcal{A}_i$ for every $j = 1, \dots, J^k$. Take an arbitrary $b_j^k \in B_j^k$ for every $j = 1, \dots, J^k$.

Now define the simple strategy τ_i^k for player i by

$$\tau_i^k(t_i, \cdot) = \beta_i(t_i, B_1^k) \cdot \delta_{b_1^k}(\cdot) + \dots + \beta_i(t_i, B_{J^k}^k) \cdot \delta_{b_{J^k}^k}(\cdot) + (1 - \beta_i(t_i, A_i^k)) \cdot \delta_{b_1^k}(\cdot)$$

for every $t_i \in T_i$, where as usual, δ stands for the Dirac measure. Note that τ_i^k satisfies condition (2) of the definition of behavioral strategies. The last term in the definition of $\tau_i^k(t_i, \cdot)$ will not play an important role, but it is needed so that $\tau_i^k(t_i, \cdot)$ is a probability measure.

Part 2: The proof that the sequence $(\tau_i^k)_{k=1}^\infty$ satisfies equality (3.13): Fix a type $t_i \in T_i$. Consider a bounded Lipschitz function $f : A_i \rightarrow \mathbb{R}$. Then, there exist $C_1, C_2 \geq 0$ such that $|f(a)| \leq C_1$ and $|f(a) - f(a')| \leq C_2 \cdot d_{A_i}(a, a')$ for every $a, a' \in A_i$. Let

$$D^k = \left| \int_{A_i} f(a) \tau_i^k(t_i, da) - \int_{A_i} f(a) \beta_i(t_i, da) \right|.$$

Since

$$\int_{A_i} f(a) \tau_i^k(t_i, da) = \sum_{j=1}^{J^k} f(b_j^k) \cdot \beta_i(t_i, B_j^k) + f(b_1^k) \cdot (1 - \beta_i(t_i, A_i^k))$$

and

$$\int_{A_i} f(a) \beta_i(t_i, da) = \sum_{j=1}^{J^k} \int_{B_j^k} f(a) \beta_i(t_i, da) + \int_{A_i \setminus A_i^k} f(a) \beta_i(t_i, da),$$

we have

$$\begin{aligned} D^k &\leq \sum_{j=1}^{J^k} \left| f(b_j^k) \cdot \beta_i(t_i, B_j^k) - \int_{B_j^k} f(a) \beta_i(t_i, da) \right| + 2C_1 \cdot (1 - \beta_i(t_i, A_i^k)) \\ &\leq \sum_{j=1}^{J^k} \left| \int_{B_j^k} [f(b_j^k) - f(a)] \beta_i(t_i, da) \right| + 2C_1 \cdot (1 - \beta_i(t_i, A_i^k)) \\ &\leq \sum_{j=1}^{J^k} \sup_{a \in B_j^k} |f(b_j^k) - f(a)| \cdot \beta_i(t_i, B_j^k) + 2C_1 \cdot (1 - \beta_i(t_i, A_i^k)). \end{aligned}$$

Since the diameter of B_j^k , for each $j = 1, \dots, J^k$, is at most $\frac{2}{k}$, it follows that

$$\begin{aligned} D^k &\leq \sum_{j=1}^{J^k} \frac{2}{k} \cdot C_2 \cdot \beta_i(t_i, B_j^k) + 2C_1 \cdot (1 - \beta_i(t_i, A_i^k)) \\ &= \frac{2}{k} \cdot C_2 \cdot \beta_i(t_i, A_i^k) + 2C_1 \cdot (1 - \beta_i(t_i, A_i^k)). \end{aligned}$$

By the continuity of the measure, $\beta_i(t_i, A_i^k)$ converges to $\beta_i(t_i, A_i) = 1$ as $k \rightarrow \infty$, and hence D^k converges to zero as $k \rightarrow \infty$. As f was an arbitrary bounded Lipschitz function from A_i to \mathbf{R} , the proof of (3.13) is complete.

Lemma 3.6.2 *Assume that the action space A_i is σ -compact for a player $i \in N$, and let β_i^1 and β_i^2 be two strategies for player i . Then, the function $f : T_i \rightarrow \mathbb{R}$ defined by $f(t_i) = \rho^w(\beta_i^1(t_i, \cdot), \beta_i^2(t_i, \cdot))$ is measurable.*

Proof. It suffices to prove that the set $\{t_i \in T_i \mid f(t_i) > r\}$ is measurable for every $r \in \mathbb{R}$. So, fix an arbitrary $r \in \mathbf{R}$.

Part 1: when β_i^1 and β_i^2 are simple strategies.

First assume that β_i^1 and β_i^2 are simple strategies. Then, there are finite sets $B^1, B^2 \subseteq$

A_i such that $\beta_i^1(t_i, B^1) = 1$ and $\beta_i^2(t_i, B^2) = 1$ for every $t_i \in T_i$. Let $B = B^1 \cup B^2$. We have

$$f(t_i) = \inf\{\varepsilon > 0 \mid \beta_i^1(t_i, C) \leq \beta_i^2(t_i, C^\varepsilon) + \varepsilon \text{ and} \\ \beta_i^2(t_i, C) \leq \beta_i^1(t_i, C^\varepsilon) + \varepsilon \ \forall C \in \mathcal{A}_i\}.$$

Notice that if $\beta_i^1(t_i, C) \leq \beta_i^2(t_i, C^\varepsilon) + \varepsilon$ for some $C \subseteq B$, then for any $\tilde{C} \in \mathcal{A}_i$ satisfying $\tilde{C} \cap B = C$, we obtain

$$\beta_i^1(t_i, \tilde{C}) = \beta_i^1(t_i, C) \leq \beta_i^2(t_i, C^\varepsilon) + \varepsilon \leq \beta_i^2(t_i, \tilde{C}^\varepsilon) + \varepsilon.$$

Similarly, if $\beta_i^2(t_i, C) \leq \beta_i^1(t_i, C^\varepsilon) + \varepsilon$ then

$$\beta_i^2(t_i, \tilde{C}) \leq \beta_i^1(t_i, \tilde{C}^\varepsilon) + \varepsilon.$$

Hence,

$$f(t_i) = \inf\{\varepsilon > 0 \mid \beta_i^1(t_i, C) \leq \beta_i^2(t_i, C^\varepsilon) + \varepsilon \text{ and} \\ \beta_i^2(t_i, C) \leq \beta_i^1(t_i, C^\varepsilon) + \varepsilon \ \forall C \subseteq B\}.$$

Notice that $f(t_i) > r$ holds if and only if there exists an $m \in \mathbf{N}$ and a set $C \subseteq B$ such that for $\varepsilon = r + \frac{1}{m}$ we have either $\beta_i^1(t_i, C) > \beta_i^2(t_i, C^\varepsilon) + \varepsilon$ or $\beta_i^2(t_i, C) > \beta_i^1(t_i, C^\varepsilon) + \varepsilon$. Indeed, the “only if”-part is immediate, whereas the “if”-part follows from the fact that $\beta_i^2(t_i, C^\varepsilon) + \varepsilon$ and $\beta_i^1(t_i, C^\varepsilon) + \varepsilon$ are increasing in ε .

For every $m \in \mathbf{N}$ and $C \subseteq B$, define

$$U_{m,C}^1 = \left\{ t_i \in T_i \mid \beta_i^1(t_i, C) > \beta_i^2(t_i, C^{r+\frac{1}{m}}) + r + \frac{1}{m} \right\} \\ U_{m,C}^2 = \left\{ t_i \in T_i \mid \beta_i^2(t_i, C) > \beta_i^1(t_i, C^{r+\frac{1}{m}}) + r + \frac{1}{m} \right\}.$$

Since by condition (2) of the definition of behavioral strategies, the section functions $\beta_i^1(\cdot, C) : T_i \rightarrow \mathbb{R}$ and $\beta_i^2(\cdot, C^{r+\frac{1}{m}}) : T_i \rightarrow \mathbb{R}$ are measurable, the sets $U_{m,C}^1$ are measurable. For a similar reason, the sets $U_{m,C}^2$ are measurable too. Now we have

$$\{t_i \in T_i \mid f(t_i) > r\} = \bigcup_{m=1}^{\infty} \bigcup_{C \subseteq B} \left[U_{m,C}^1 \cup U_{m,C}^2 \right].$$

Because the right hand side is a countable union of measurable sets, the set $\{t_i \in T_i \mid f(t_i) > r\}$ is measurable as well. So, the claim of the lemma holds for simple strategies.

Part 2: when β_i^1 and β_i^2 are arbitrary strategies.

Now we prove the lemma for arbitrary strategies β_i^1 and β_i^2 . By Lemma 3.6.1, there are two sequences of simple strategies $(\tau_i^{k,1})_{k=1}^\infty$ and $(\tau_i^{k,2})_{k=1}^\infty$ such that

$$\lim_{k \rightarrow \infty} \rho^w(\tau_i^{k,1}(t_i, \cdot), \beta_i^1(t_i, \cdot)) = 0, \quad \text{and} \quad \lim_{k \rightarrow \infty} \rho^w(\tau_i^{k,2}(t_i, \cdot), \beta_i^2(t_i, \cdot)) = 0$$

for every type $t_i \in T_i$. By the definition of f , we have

$$\{t_i \in T_i \mid f(t_i) > r\} = \{t_i \in T_i \mid \lim_{k \rightarrow \infty} \rho^w(\tau_i^{k,1}(t_i, \cdot), \tau_i^{k,2}(t_i, \cdot)) > r\}.$$

Notice that, for some $t_i \in T_i$, the inequality

$$\lim_{k \rightarrow \infty} \rho^w(\tau_i^{k,1}(t_i, \cdot), \tau_i^{k,2}(t_i, \cdot)) > r$$

holds if and only if there exists an $m \in \mathbb{N}$ such that $\rho^w(\tau_i^{k,1}(t_i, \cdot), \tau_i^{k,2}(t_i, \cdot)) > r + \frac{1}{m}$ holds for sufficiently large k . Therefore,

$$\{t_i \in T_i \mid f(t_i) > r\} = \bigcup_{m=1}^\infty \bigcup_{\ell=1}^\infty \bigcap_{k=\ell}^\infty \left\{ t_i \in T_i \mid \rho^w(\tau_i^{k,1}(t_i, \cdot), \tau_i^{k,2}(t_i, \cdot)) > r + \frac{1}{m} \right\}.$$

For each $k \in \mathbb{N}$, because the strategies $\tau_i^{k,1}$ and $\tau_i^{k,2}$ are simple, part 1 of the proof implies that set

$$\left\{ t_i \in T_i \mid \rho^w(\tau_i^{k,1}(t_i, \cdot), \tau_i^{k,2}(t_i, \cdot)) > r + \frac{1}{m} \right\}$$

is measurable. Therefore, the set $\{t_i \in T_i \mid f(t_i) > r\}$ is measurable as well.

Chapter 4

Distributional perfect equilibrium in Bayesian games

4.1 Introduction

In private value second-price auctions each bidder has a dominant strategy in which he bids his own valuation of the object. However, in second-price auctions with interdependent values bidders might not have any dominant strategy while there may exist many equilibria. Therefore, a selection tool is needed in such Bayesian games to rule out the less intuitive equilibria. In this chapter we develop the concept of trembling hand perfect equilibrium for Bayesian games with infinite type and action spaces as a refinement of Bayesian Nash equilibrium.

We consider a Bayesian game with n players, where each player's type space is a separable metric space. After receiving the types, players simultaneously choose an action from a compact metric action space, then each player gets a payoff that may depend on all the types and all the actions chosen by the players. Following Milgrom and Weber [33], we assume that the prior probability measure on the product of the type spaces is absolutely continuous with respect to the product measure of its marginal probabilities, also we assume that the payoffs are equicontinuous. Milgrom and Weber in [33] prove the existence of an equilibrium in distributional strategies for such Bayesian games.¹ As it is not clear how players would play the game when using their distributional strategies, we define a similar equilibrium concept in behavioral strategies. A behavioral strategy profile is called "distributional equilibrium" if its induced distributional strategy profile is an equilibrium.

¹There are many other studies on the existence of equilibrium in Bayesian games, for example: Athey [3], Mcadams [25], Reny [40], Jackson et. al. [16],[17], Mertens [31], Meiwowitz [26], Mallozzi et. al. [24], Kim and Yannelis [20], Zandt and Vives [45], Balder [5].

To extend the concept of trembling hand perfect equilibrium to Bayesian games with infinite action and type spaces, we define “distributional perfect equilibrium” as a behavioral strategy profile such that for its induced distributional strategy profile the conditions of trembling hand perfect equilibrium are satisfied. We prove that in the Bayesian game described above distributional perfection is a refinement of distributional equilibrium. Furthermore, we show the existence of distributional perfect equilibrium and that the set of distributional perfect equilibria is sequentially closed in the Tychonoff topology when taking the strong topology on the set of probability measures on action spaces.

Note that in finite games perfect equilibrium assigns no mass to weakly dominated strategies. However, this property is not compatible for infinite games, as Example 2.1 by Simon and Stinchcombe in [42] presents a game with infinite action spaces in which the unique equilibrium of the game is in weakly dominated strategies. Instead, the weaker property of limit undominatedness² is used for strategies in infinite games which is somewhat stronger than limit admissibility introduced in Simon and Stinchcombe [42]. We show that a distributional perfect equilibrium is in limit undominated strategies. We also discuss perfection in finite Bayesian games, to see that distributional perfection is equivalent to perfect equilibrium in finite Bayesian games defined in chapter 3 if every player receives each type from his type space with strictly positive probability.

As we mentioned before, one of the applications of distributional perfection is in auctions with interdependent values, because such auctions may have many equilibria, even in undominated strategies. We study symmetric second-price auctions with interdependent values for two bidders where the valuation function of each bidder is strictly increasing in his own type. We use distributional perfection to get a smaller set of equilibria and rule out the strange and the less intuitive ones. To explain this idea consider the following example.

Example 4.1.1 Consider a 2-bidder second-price auction with interdependent values $v_1 = t_1 + \frac{1}{2}t_2$ and $v_2 = \frac{1}{2}t_1 + t_2$, where the types t_1, t_2 for bidder 1 and 2 respectively, are drawn independently from $[0, 1]$ according to the uniform distribution. Then, each bidder simultaneously submits a bid from the set $[0, \frac{3}{2}]$. The strategy profile (b_1, b_2) in which $b_i = \frac{3}{2}t_i$, for every bidder $i = 1, 2$, is a Bayesian Nash equilibrium. However, there are many other equilibria in this auction. As an example consider the following class of equilibria. For every $s_1, s_2 \in [0, 1]$ where $s_1 < s_2$:

$$\hat{b}_1(t_1) = \begin{cases} s_2 + \frac{1}{2}t_1 & \text{if } t_1 \in [s_1, s_2] \\ \frac{3}{2}t_1 & \text{otherwise,} \end{cases}$$

$$\hat{b}_2(t_2) = \begin{cases} s_1 + \frac{1}{2}t_2 & \text{if } t_2 \in [s_1, s_2] \\ \frac{3}{2}t_2 & \text{otherwise.} \end{cases}$$

This class of equilibria is depicted in Figure 4.1. In this strategy profile, in the case both types are drawn from the set $[s_1, s_2]$, bidder 1 wins the auction and pays the amount $\hat{b}_2(t_2) = s_1 + \frac{1}{2}t_2$, which is his minimum ex post valuation in this case. Note that in this case bidder 1 overbids, while bidder 2 underbids. This class of equilibria leads to an inefficient outcome, hence we would like to be able to rule them out by the help of some kind of refinement.

In Proposition 4.5.1, we will show that the strategy profile (b_1, b_2) is distributional perfect. Moreover, in Proposition 4.5.3 we will see that a large subclass of strategy profiles (\hat{b}_1, \hat{b}_2) are not distributional perfect. The reason for this observation is that in the latter equilibria, bidder 1 might bid even higher than his maximum valuation and bidder 2 might bid even lower than his minimum valuation. Now, if each bidder takes making mistakes by his opponent serious, then he knows any bid from the set $[0, \frac{3}{2}]$ is possible. This prevents bidder 1 from overbidding, since by overbidding he may get a negative payoff at the end of the day. Similarly, by taking mistakes into account by bidder 2, he would not underbid anymore, as he can increase his chance of winning and getting a strictly positive payoff.

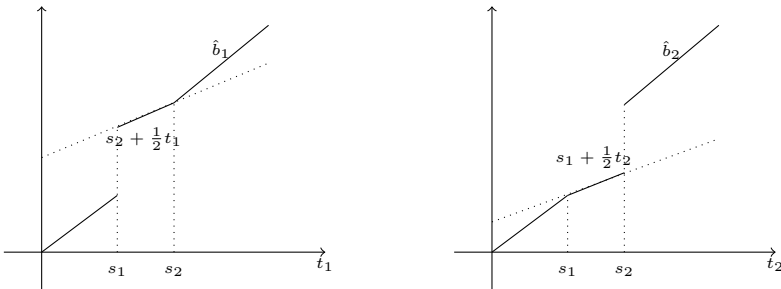

By taking a different approach in chapter 3, we define perfect equilibrium for Bayesian games only based on behavioral strategies and without making use of distributional strategies so called behavioral perfection. Behavioral perfection is a more

straightforward way of defining perfect equilibrium in Bayesian games than distributional perfection and it is conceptually preferable. Moreover, it has the advantage that perfection can be verified for every type of each player. However, in developing the theory, particularly in proving the existence, distributional strategies are easier to work with.

The remainder of this chapter is structured as follows. Section 4.2 describes the model in detail. In section 4.3 distributional perfect equilibrium is introduced and the results related to this concept are provided, which the most important one is the existence result in Theorem 4.3.3 Section 4.4 discusses the relation between distributional perfection and the approach taken in chapter 3. In section 4.5 the concept of distributional perfection is applied to a class of second-price auctions with interdependent values.

4.2 The model

Let Γ denote the following Bayesian game: There are n players. The set T_i of player i 's types is a complete, separable metric space with a metric d_{T_i} and the set A_i of player i 's actions is a compact metric space with a metric d_{A_i} . Let \mathcal{T}_i and \mathcal{A}_i be the induced Borel σ -fields on T_i and A_i respectively. Moreover, let $T = \times_{i=1}^n T_i$ and $A = \times_{i=1}^n A_i$. Suppose μ is a probability measure on the product σ -field $\mathcal{T} = \otimes_{i=1}^n \mathcal{T}_i$ with marginal probability μ_i on \mathcal{T}_i for every player i . We assume that each μ_i is a completely mixed probability measure. Recall that a probability measure is completely mixed if it assigns strictly positive weight to every nonempty open set. Player i 's payoff function $\pi_i : T \times A \rightarrow \mathbf{R}$ is bounded and jointly measurable.

We impose two more assumptions on Bayesian game Γ , following Milgrom and Weber [33]. First, the measure μ is absolutely continuous³ with respect to $\hat{\mu} = \times_{i=1}^n \mu_i$. This property is called Absolutely Continuous Information. Second, the payoffs are equicontinuous, that is for every player i and every $\varepsilon > 0$, there is a set $E \in \mathcal{T}$ such that $\mu(E^c) < \varepsilon$ and the family $\{\pi_i(t, \cdot) \mid t \in E\}$ is equicontinuous.⁴ Milgrom and Weber in [33] give detailed explanation of these two assumptions. Absolutely continuous information is a rather weak assumption and it is satisfied when the type spaces are finite or when each player's type is drawn independently from his type space. As an example this assumption rules out the case of a uniform distribution on the diagonal of the unit square. Although the equicontinuity of payoffs is

³Let μ and ν be two measures on a σ -field Σ . The measure μ is absolutely continuous with respect to ν if for every $G \in \Sigma$, $\nu(G) = 0$ implies $\mu(G) = 0$.

truly restrictive, it is needed for the existence of distributional equilibrium. However, in the case of finite action spaces the equicontinuity of payoffs holds.

Behavioral and distributional strategy

A pure strategy for player i in Γ is a measurable function $p_i : T_i \rightarrow A_i$ and a behavioral strategy for him is a function $\beta_i : T_i \times \mathcal{A}_i \rightarrow [0, 1]$ such that (1) the section function $\beta_i(t_i, \cdot) : \mathcal{A}_i \rightarrow [0, 1]$ is a probability measure for every $t_i \in T_i$, (2) the section function $\beta_i(\cdot, B) : T_i \rightarrow [0, 1]$ is measurable for every $B \in \mathcal{A}_i$. When player i plays according to the behavioral strategy β_i , for each type $t_i \in T_i$, he chooses his action according to the probability measure $\beta_i(t_i, \cdot)$. A behavioral strategy β_i for player i is called pure if there is a pure strategy p_i for player i such that $\beta_i(t_i, \cdot) = D_{p_i(t_i)}(\cdot)$ for every type $t_i \in T_i$ in which D denotes Dirac measure. For simplicity, we denote this pure behavioral strategy by p_i .

According to Milgrom and Weber [33], a distributional strategy for player i in a Bayesian game is a probability measure γ_i on $T_i \times A_i$ such that the marginal distribution of γ_i on T_i equals the probability measure μ_i , i.e., $\gamma_i(U \times A_i) = \mu_i(U)$ for every $U \in \mathcal{T}_i$. Given a behavioral strategy β_i , the induced distributional strategy γ_i is uniquely determined by

$$\gamma_i(U \times B) = \int_U \beta_i(t_i, B) \mu_i(dt_i)$$

for every rectangle $U \times B \in \mathcal{T}_i \otimes \mathcal{A}_i$. Conversely, the behavioral strategies corresponding to a distributional strategy γ_i are exactly the regular conditional probabilities. Hence, there is a many-to-one mapping from behavioral strategies to distributional strategies that preserves the players' ex ante expected payoffs. Notice that in games with finite action and type spaces, if player i receives each type from his type space with strictly positive probability, then the mapping from behavioral strategies to distributional strategies is one to one.

Let Δ_i be the set of all distributional strategies for player i and $\Delta = \times_{i=1}^n \Delta_i$. Also, let $\Pi_i : \Delta \rightarrow \mathbf{R}$ be the expected payoff of player i playing distributional strategy γ_i against a distributional strategy profile γ_{-i} , i.e.

$$\Pi_i(\gamma_i, \gamma_{-i}) = \int \pi_i(t, a) \gamma_i(da_i | t_i) \gamma_{-i}(da_{-i} | t_{-i}) \mu(dt),$$

where $t = (t_1, \dots, t_n) \in T$ and $a = (a_1, \dots, a_n) \in A$, $\gamma_i(da_i | t_i)$ is a version of conditional probability on A_i given t_i , and by integrals with respect to $\gamma_{-i}(da_{-i} | t_{-i})$ we mean the iterated integrals with respect to $\gamma_j(da_j | t_j)$ for all $j \neq i$. As the measure μ is absolutely continuous with respect to $\hat{\mu}$, the Radon-Nikodym theorem

implies the existence of a measurable function $f : T \rightarrow \mathbf{R}$ such that for every measurable set $G \in \mathcal{T}$ we have $\mu(G) = \int_G f d\hat{\mu}$. Therefore, the expected payoff Π_i can be expressed in an easier form as

$$\Pi_i(\gamma_i, \gamma_{-i}) = \int \pi_i(t, a) f(t) d\gamma_i d\gamma_{-i}.$$

Let β_i be a behavioral strategy corresponding to the distributional strategy γ_i , for every player i . Then, by Theorem 10.2.1 in Dudley [11]⁵ we conclude that

$$\Pi_i(\gamma_i, \gamma_{-i}) = \int \pi_i(t, a) f(t) \beta_i(t_i, da_i) \mu_i(dt_i) \beta_{-i}(t_{-i}, da_{-i}) \mu_{-i}(dt_{-i}).$$

We use $\Pi_i^b(\beta_i, \beta_{-i} \mid t_i)$ to denote player i 's expected payoff given his behavioral strategy β_i and his type t_i against a behavioral strategy profile β_{-i} . Thus,

$$\Pi_i^b(\beta_i, \beta_{-i} \mid t_i) = \int \pi_i(t, a) f(t) \beta_i(t_i, da_i) \beta_{-i}(t_{-i}, da_{-i}) \mu_{-i}(dt_{-i}).$$

One can also define $\Pi_i^b(\sigma_i, \beta_{-i} \mid t_i)$ and $\Pi_i^b(a_i, \beta_{-i} \mid t_i)$ respectively for every probability measure σ_i on \mathcal{A}_i and every action $a_i \in A_i$. Furthermore, notice that

$$\Pi_i(\gamma_1, \dots, \gamma_n) = \int \Pi_i^b(\beta_i, \beta_{-i} \mid t_i) \mu_i(dt_i).$$

In the special case where player i chooses a pure behavioral strategy p_i , his expected payoff is

$$\Pi_i^b(p_i, \beta_{-i} \mid t_i) = \int \pi_i(t, (p_i(t_i), a_{-i})) f(t) \beta_{-i}(t_{-i}, da_{-i}) \mu_{-i}(dt_{-i}).$$

BNE and distributional equilibrium

A probability measure σ_i on \mathcal{A}_i is called a best response of player i for type $t_i \in T_i$ against a behavioral strategy profile τ_{-i} , if for every probability measure σ'_i on \mathcal{A}_i we have

$$\Pi_i^b(\sigma_i, \tau_{-i} \mid t_i) \geq \Pi_i^b(\sigma'_i, \tau_{-i} \mid t_i).$$

The set of such best responses is denoted by $BR_i(t_i, \tau)$. A behavioral strategy β_i is called a best response of player i against the behavioral strategy profile τ_{-i} ,

⁵Dudley's notation and terminology in [11] differs from ours. Part (II) of Theorem 10.2.1. in our terminology can be expressed as follows: For every measurable function $g : T_i \times A_i \rightarrow \mathbf{R}$ we have

$$\int g d\gamma_i = \int \int g(t_i, a_i) \beta_i(t_i, da_i) \mu_i(dt_i).$$

if $\beta_i(t_i, \cdot) \in BR_i(t_i, \tau)$ for every $t_i \in T_i$. A behavioral strategy profile $\beta = (\beta_1, \dots, \beta_n)$ is a *Bayesian Nash Equilibrium (BNE)* if β_i is a best response to β_{-i} for every player i .

Distributional strategy γ_i of player i is a best response against a distributional strategy profile η_{-i} , if $\Pi_i(\gamma_i, \eta_{-i}) \geq \Pi_i(\tilde{\gamma}_i, \eta_{-i})$, for every distributional strategy $\tilde{\gamma}_i$ of player i . Define the correspondence $BR_i : \Delta \rightarrow \Delta_i$ to be the best response correspondence for player i on the set of distributional strategies. Moreover, define $BR : \Delta \rightarrow \Delta$, for every $\gamma \in \Delta$, as $BR(\gamma) = \times_{i=1}^n BR_i(\gamma)$.

The equilibrium concept in Bayesian games can be defined in a weaker form where each player maximizes his payoff in ex ante probabilities, in other words, by using distributional strategies. This equilibrium concept is used by Milgrom and Weber in [33] and they prove that the Bayesian game Γ described above, contains at least one of them. However, it is not clear how players would play the game if they are given their distributional strategies, while behavioral strategies do not have this problem. Hence, we define a behavioral strategy profile $\beta = (\beta_1, \dots, \beta_n)$ to be a *distributional equilibrium*, if for the induced distributional strategy profile $\gamma = (\gamma_1, \dots, \gamma_n)$ we have $\gamma_i \in BR_i(\gamma)$, for every player i .

Next proposition proves that BNE and distributional equilibrium are equal up to a μ_i -measure 1 set of types for every player i .

Proposition 4.2.1 *For every distributional equilibrium β , assume that the set of the best responses of player i against behavioral strategy profile β_{-i} is not empty.⁶ Then, there is a BNE $\hat{\beta}$ such that for every player i we have $\beta_i(t_i, \cdot) = \hat{\beta}_i(t_i, \cdot)$, for μ_i -a.e. $t_i \in T_i$.*

Proof. Let $\beta = (\beta_1, \dots, \beta_n)$ be a distributional equilibrium. Then, for the induced distributional strategy profile $\gamma = (\gamma_1, \dots, \gamma_n)$ we have $\gamma_i \in BR_i(\gamma)$. Now, by Lemma 4.6.1 we have $\beta_i(t_i, \cdot) \in BR_i(t_i, \beta)$ for μ_i -a.e. $t_i \in T_i$. In other words, for every i there exists a set $S_i \in \mathcal{T}_i$ with $\mu_i(S_i) = 0$ such that for every $t_i \in T_i \setminus S_i$ we have $\beta_i(t_i, \cdot) \in BR_i(t_i, \beta)$. Now, define $\hat{\beta} = (\hat{\beta}_1, \dots, \hat{\beta}_n)$, for every $t_i \in T_i \setminus S_i$, by letting $\hat{\beta}_i(t_i, \cdot) = \beta_i(t_i, \cdot)$ and for every $t_i \in S_i$ selecting any $\hat{\beta}_i(t_i, \cdot) \in BR_i(t_i, \beta)$. It is clear that $\hat{\beta}$ is a BNE. This completes the proof. ■

We say a behavioral strategy β_i (weakly) dominates $\hat{\beta}_i$ if for their induced distributional strategies γ_i and $\hat{\gamma}_i$ respectively, we have

$$\Pi_i(\gamma_i, \gamma_{-i}) \geq \Pi_i(\hat{\gamma}_i, \gamma_{-i}),$$

⁶The existence of such behavioral strategy might be derived from measurable selection theorems for example in [1] and [46].

for all $\gamma_{-i} \in \Delta_{-i}$, with a strict inequality for some γ_{-i} . The behavioral strategy β_i is called (weakly) dominant if it dominates every other behavioral strategy of player i . The behavioral strategy β_i is undominated if there is no other behavioral strategy that dominates β_i .

4.3 Distributional perfection

We define perfect equilibrium for Bayesian games in behavioral strategies, because a player given a behavioral strategy knows how to play the game, but this is not clear if he is given a distributional strategy. Nevertheless, we use distributional strategies as a tool to verify whether the behavioral strategy profile satisfies the conditions of trembling hand perfect equilibrium or not. This concept is called distributional perfect equilibrium. Throughout this chapter the weak metric (also called Prohorov metric) on a set of probability measures is denoted by ρ^w .

Definition 4.3.1 A behavioral strategy profile $\beta = (\beta_1, \dots, \beta_n)$ is called *distributional perfect* if for the induced distributional strategy profile $\gamma = (\gamma_1, \dots, \gamma_n)$ there exists a sequence of completely mixed distributional strategy profiles $(\gamma^k)_{k=1}^\infty = (\gamma_1^k, \dots, \gamma_n^k)_{k=1}^\infty$ such that for every player i :

- (i) $\lim_{k \rightarrow \infty} \rho^w(\gamma_i^k, \gamma_i) = 0$,
- (ii) $\lim_{k \rightarrow \infty} \rho^w(\gamma_i^k, BR_i(\gamma^k)) = 0$.

Distributional perfection in Bayesian game Γ is a refinement of distributional equilibrium. This is proved in the following theorem.

Theorem 4.3.2 *Every distributional perfect strategy profile in Bayesian game Γ , is a distributional equilibrium.*

Proof. Let $\beta = (\beta_1, \dots, \beta_n)$ be a distributional perfect strategy profile. By Definition 4.3.1, for the induced distributional strategy profile $\gamma = (\gamma_1, \dots, \gamma_n)$ there exists a sequence of completely mixed distributional strategy profiles $(\gamma^k)_{k=1}^\infty = (\gamma_1^k, \dots, \gamma_n^k)_{k=1}^\infty$ such that for every player i we have $\lim_{k \rightarrow \infty} \rho^w(\gamma_i^k, \gamma_i) = 0$ and $\lim_{k \rightarrow \infty} \rho^w(\gamma_i^k, BR_i(\gamma^k)) = 0$. Therefore, for every i , there exists a sequence $(\hat{\gamma}_i^k)_{k=1}^\infty$ such that $\hat{\gamma}_i^k \in BR_i(\gamma^k)$ for every $k \in \mathbf{N}$ and $\rho^w(\gamma_i^k, \hat{\gamma}_i^k) \rightarrow 0$ as $k \rightarrow \infty$. By the triangle inequality for ρ^w this implies for every i that $\rho^w(\gamma_i, \hat{\gamma}_i^k) \rightarrow 0$ as $k \rightarrow \infty$. Now, by Lemma 4.6.3 we conclude the upper hemicontinuity of the correspondence BR_i , for every player i . Hence, $\gamma_i \in BR_i(\gamma)$, which implies that behavioral strategy β is distributional perfect. ■

As we just proved, distributional perfection is a refinement of distributional equilibrium, but it may not be a refinement of BNE. In other words, distributional perfection does not guarantee that player i , for every type $t_i \in T_i$, selects a best response against the opponents' strategies. However, by Proposition 4.2.1, given the distributional perfect equilibrium, we can construct a BNE that satisfies conditions (i) and (ii) of Definition 4.3.1 as follows. Let β be a distributional perfect strategy profile. Then, if for any type t_i of player i , $\beta_i(t_i, \cdot)$ is not a best response against β_{-i} , he moves to one of his best responses, while this does not change the expected payoffs of the opponents, since it happens only on a measure zero set.

In addition, we prove the existence of distributional perfect BNE in Bayesian game Γ and that the set of distributional perfect equilibria is sequentially closed in the topology ω , where ω is the Tychonoff topology on the set $\times_{t_i \in T_i} \Delta(A_i)$ when taking the strong topology on each $\Delta(A_i)$.

Theorem 4.3.3 *In Bayesian game Γ , the set of distributional perfect equilibria is nonempty and sequentially closed in the topology ω .*

Proof. First we prove that the set of distributional strategy profiles satisfying conditions (i) and (ii) of Definition 4.3.1 is not empty. For every player i , let ν_i be a completely mixed distributional strategy. Note that such a ν_i exists, because $T_i \times A_i$ is separable. Define for every $k \in \mathbf{N}$

$$\Delta_i(k) = \{\gamma_i \in \Delta_i \mid \gamma_i(B_i) \geq \frac{1}{k} \cdot \nu_i(B_i), \quad \forall B_i \in \mathcal{T}_i \otimes \mathcal{A}_i\}.$$

Moreover, let $\Delta(k) = \times_{i=1}^n \Delta_i(k)$ and $BR_i^k : \Delta(k) \rightarrow \Delta_i(k)$ be the best response correspondence for player i restricted to $\Delta_i(k)$ ⁷ and define the correspondence $BR^k : \Delta(k) \rightarrow \Delta(k)$ to be

$$BR^k(\gamma) = \times_{i=1}^n BR_i^k(\gamma),$$

for every $\gamma \in \Delta(k)$. We verify the conditions of Theorem 4.6.7 for the correspondence BR^k .

Since T is a complete and separable metric space, by Theorem 1.4 in [6] μ is a tight measure.⁸ This fact together with the compactness of the set A , implies that Δ_i

⁷Distributional strategy γ_i of player i is a best response restricted to $\Delta_i(k)$ against a distributional strategy profile $\eta_{-i} \in \Delta_{-i}(k)$, if $\Pi_i(\gamma_i, \eta_{-i}) \geq \Pi_i(\tilde{\gamma}_i, \eta_{-i})$, for every distributional strategy $\tilde{\gamma}_i \in \Delta_i(k)$ of player i .

⁸Let X be a metric space with the Borel σ -field Σ . A measure μ on Σ is tight if for every $G \in \Sigma$, $\mu(G) = \sup\{\mu(K) \mid K \subset G, \text{ and } K \text{ compact}\}$. Moreover, Theorem 1.4 in [6] states that if X is separable and complete, then each probability measure on Σ is tight.

is a tight set of probability measures.⁹ Now, by Prohorov's Theorem we conclude that Δ_i is a compact metric space with respect to the weak metric. It is easy to see that $\Delta_i(k)$ is a closed subset of Δ_i with respect to the strong metric. Consequently, by Theorem V.3.13 in [12], it is closed with respect to the weak metric. Hence, $\Delta_i(k)$ is compact with respect to the weak metric. Also, one can easily check that $\Delta_i(k)$ is convex. Moreover, upper hemicontinuity of BR^k follows by Lemma 4.6.3. Now, we apply Theorem 4.6.7, which leads us to the existence of an equilibrium point $\gamma^k \in \Delta(k)$, for every k .

Now, define¹⁰

$$PBR_i(\gamma) = \{(t_i, a_i) \in T_i \times A_i \mid (t_i, a_i) \in \text{supp}(\gamma_i) \text{ and } \gamma_i \in BR_i(\gamma)\}.$$

It is clear that $\gamma_i^k(PBR_i(\gamma^k)) \geq 1 - \frac{1}{k}\nu_i(T_i \times A_i) = 1 - \frac{1}{k}$. This implies that $\rho^w(\gamma_i^k, BR_i(\gamma^k)) \leq \frac{1}{k}$. Furthermore, as Δ_i is compact with respect to the weak metric, without loss of generality we can assume that there is a distributional strategy profile γ such that $\rho^w(\gamma^k, \gamma) \rightarrow 0$ when $k \rightarrow \infty$. Let β be a behavioral strategy profile corresponding to γ . Obviously, β is a distributional perfect equilibrium. Hence, the set of distributional perfect equilibria is nonempty.

Now, we prove that the set of distributional perfect equilibria is sequentially closed in ω . Let $(\beta_\ell)_{\ell=1}^\infty$ be a sequence of distributional perfect equilibria in which $\beta_\ell = (\beta_{\ell,1}, \dots, \beta_{\ell,n})$ and suppose that for every player i , the behavioral strategy $\beta_{\ell,i}$ converges to $\beta_i \in \times_{t_i \in T_i} \Delta(A_i)$ in the topology ω as $\ell \rightarrow \infty$. Then, for every $B \in \mathcal{A}_i$ the function $\beta_{\ell,i}(\cdot, B)$ on T_i converges pointwisely to $\beta_i(\cdot, B)$ as $\ell \rightarrow \infty$. This implies that $\beta_i(\cdot, B)$ is measurable for every $B \in \mathcal{A}_i$, hence β_i is a behavior strategy. Let $\beta = (\beta_1, \dots, \beta_n)$. We show that β is distributional perfect. Let $\gamma_\ell = (\gamma_{\ell,1}, \dots, \gamma_{\ell,n})$ and $\gamma = (\gamma_1, \dots, \gamma_n)$ be the induced distributional strategy profiles by β_ℓ and β respectively. It is clear that $\rho^w(\gamma_{\ell,i}, \gamma_i) \rightarrow 0$ as $\ell \rightarrow \infty$, for every i . Since for every ℓ the strategy profile β_ℓ is distributional perfect, there exists a sequence of completely mixed distributional strategies $(\gamma_{\ell,i}^k)_{k=1}^\infty$, for every player i , satisfying the conditions of Definition 4.3.1. Hence, there is a $K_{\ell,i}^1$ such that for every $k \geq K_{\ell,i}^1$ we have $\rho^w(\gamma_{\ell,i}^k, \gamma_{\ell,i}) < \frac{1}{\ell}$. Similarly, there is a $K_{\ell,i}^2$ such that for every $k \geq K_{\ell,i}^2$ we have $\rho^w(\gamma_{\ell,i}^k, BR_i(\gamma_\ell^k)) < \frac{1}{\ell}$. Let $K_{\ell,i} = \max\{K_{\ell,i}^1, K_{\ell,i}^2\}$. Now, the sequence $(\gamma_{\ell,i}^{K_{\ell,i}})_{\ell=1}^\infty$ of completely mixed distributional strategies satisfies the conditions of Definition 4.3.1 for the strategy profile γ when $\ell \rightarrow \infty$. Namely,

⁹A family of probability measures on a metric space is tight if for every $\varepsilon > 0$ there is a compact set K satisfying $\mu(K) > 1 - \varepsilon$, for every μ in the family.

¹⁰Recall that $\text{supp}(\mu) = \{x \in X \mid \text{for every open set } G \text{ if } x \in G \text{ then } \mu(G) > 0\}$.

for every player i we have

$$\rho^w(\gamma_{\ell,i}^{K_{\ell,i}}, \gamma_i) \leq \rho^w(\gamma_{\ell,i}^{K_{\ell,i}}, \gamma_{\ell,i}) + \rho^w(\gamma_{\ell,i}, \gamma_i) < \frac{1}{\ell} + \rho^w(\gamma_{\ell,i}, \gamma_i),$$

and

$$\rho^w(\gamma_{\ell,i}^{K_{\ell,i}}, BR_i(\gamma_{\ell,i}^{K_{\ell,i}})) < \frac{1}{\ell}.$$

Clearly, both $\rho^w(\gamma_{\ell,i}^{K_{\ell,i}}, \gamma_i)$ and $\rho^w(\gamma_{\ell,i}^{K_{\ell,i}}, BR_i(\gamma_{\ell,i}^{K_{\ell,i}}))$ converge to zero when $\ell \rightarrow \infty$. Hence, β is a distributional perfect equilibrium. ■

In the theorem above, to define ω we use the strong topology on each $\Delta(A_i)$, but not the weak topology. In the weak topology the limit β_i of a sequence of behavioral strategies $(\beta_{\ell,i})_{\ell=1}^{\infty}$ may not be a behavioral strategy, as we encounter difficulties to show that $\beta_i(\cdot, B) : T_i \rightarrow [0, 1]$ is measurable for every $B \in A_i$.

As we explained in the introduction, for finite games perfect equilibrium puts weight zero on dominated strategies. However, this property is not compatible for infinite games, since Simon and Stinchcombe [42] in Example 2.1 presents a game with infinite action spaces in which the unique equilibrium of the game is in weakly dominated strategies. Hence, a weaker property of limit undominatedness is used for strategies in infinite games that is defined as follows: Behavioral strategy β_i is limit undominated if for the induced distributional strategy γ_i , there is a sequence of undominated¹¹ distributional strategies $(\gamma_i^k)_{k=1}^{\infty}$ such that $\rho^w(\gamma_i^k, \gamma_i) \rightarrow 0$ as $k \rightarrow \infty$. The following result shows that a distributional perfect strategy profile is in limit undominated strategies. The proof is simple and similar to the proof of Theorem 2.4.1 in chapter 2.

Theorem 4.3.4 *Let β be a distributional perfect equilibrium in Bayesian game Γ . Then, β_i is limit undominated, for every player i .*

In the remark below we see that distributional perfection is equivalent to trembling hand perfect equilibrium in games with finite action and type spaces.

Remark. Consider a Bayesian game in which every player's action space and type space are finite and every player receives each type from his type space with strictly positive probability. This game satisfies all the assumptions of the game Γ described above, so it is an special case of this class of Bayesian games. A behavioral strategy for player i in finite games is a function $\beta_i : T_i \rightarrow \Delta(A_i)$, where $\Delta(A_i)$ is

¹¹ Undominated distributional strategies are defined similarly to undominated strategies for normal form games, since distributional strategies are simply probability measures on the product space of types and actions.

the set of mixed strategies on A_i . Behavioral strategy β_i is called completely mixed if $\beta_i(t_i)$ is a completely mixed strategy for each type $t_i \in T_i$. A direct generalization of Selten's perfect equilibrium to finite Bayesian games in chapter 3 is defined as a behavioral strategy profile $\beta = (\beta_1, \dots, \beta_n)$ for which there exists a sequence of completely mixed behavioral strategy profiles $(\beta^k)_{k=1}^\infty = (\beta_1^k, \dots, \beta_n^k)_{k=1}^\infty$ with the following properties for every player i and each type $t_i \in T_i$:

- (i) $\lim_{k \rightarrow \infty} d_E(\beta_i^k(t_i), \beta_i(t_i)) = 0$,
- (ii) $\lim_{k \rightarrow \infty} d_E(\beta_i^k(t_i), BR_i(t_i, \beta^k)) = 0$,

where d_E is the Euclidean metric.

Now, define $A'_i = T_i \times A_i$ and $\Delta(A'_i)$ to be the set of mixed strategies on A'_i . Let $\Delta_d(A'_i) \subseteq \Delta(A'_i)$ to be the set of all player i 's distributional strategies. Moreover, the player i 's payoff is his ex ante expected payoff, i.e. his expected payoff before he learns his own type. The equivalent definition of distributional perfection in finite Bayesian games is:

A behavioral strategy profile $\beta = (\beta_1, \dots, \beta_n)$ is called perfect if for the induced distributional strategy profile $\sigma = (\sigma_1, \dots, \sigma_n)$, there exists a sequence of completely mixed distributional strategy profiles $(\sigma^k)_{k=1}^\infty = (\sigma_1^k, \dots, \sigma_n^k)_{k=1}^\infty$ such that for every player i we have:

- (i) $\lim_{k \rightarrow \infty} d_E(\sigma_i^k, \sigma_i) = 0$,
- (ii) $\lim_{k \rightarrow \infty} d_E(\sigma_i^k, BR_i(\sigma^k)) = 0$,

In this finite game, for every distributional strategy there is a unique behavioral strategy and vice versa. Also, for a behavioral strategy profile $\beta = (\beta_1, \dots, \beta_n)$ if we have $\beta_i(t_i) \in BR_i(t_i, \beta)$ for every $t_i \in T_i$, then obviously for the induced distributional strategy $\gamma = (\gamma_1, \dots, \gamma_n)$ we have $\gamma_i \in BR_i(\gamma)$, for every player i . Conversely, it is easy to see that if $\gamma_i \in BR_i(\gamma)$, then $\beta_i(t_i, \cdot) \in BR_i(t_i, \beta)$, for every $t_i \in T_i$ and every player i . Therefore, the latter definition is equivalent to the perfection defined in chapter 3 for finite games.

4.4 A.e. pointwise perfection

In chapter 3 we introduced a definition of perfect equilibrium in Bayesian games without using distributional strategies. It is called a.e.-pointwise perfection and it has a close relation with distributional perfection. Recall that a behavioral strategy β_i is

completely mixed if the probability measure $\beta_i(t_i, \cdot) : \mathcal{A}_i \rightarrow [0, 1]$ is completely mixed, for every $t_i \in T_i$. A behavioral strategy profile $\beta = (\beta_1, \dots, \beta_n)$ is a.e.-pointwise perfect if for every player i there exists a set $S_i \in \mathcal{T}_i$ of μ_i -measure 0 and a sequence of profiles of completely mixed behavioral strategies $(\beta^k)_{k=1}^\infty = (\beta_1^k, \dots, \beta_n^k)_{k=1}^\infty$ with the following properties for every player i and every type $t_i \in T_i \setminus S_i$:

- (i) $\lim_{k \rightarrow \infty} \rho^w(\beta_i^k(t_i, \cdot), \beta_i(t_i, \cdot)) = 0$,
- (ii) $\lim_{k \rightarrow \infty} \rho^w(\beta_i^k(t_i, \cdot), BR_i(t_i, \beta^k)) = 0$.

In the next proposition we show that a.e.-pointwise perfection is a stronger concept than distributional perfect equilibrium. The opposite direction remains an open question.

Proposition 4.4.1 *Every a.e.-pointwise perfect strategy profile is distributional perfect.*

Proof. Let $\beta = (\beta_1, \dots, \beta_n)$ be an a.e.-pointwise perfect strategy profile. Then, by the definition, there is a set $S_i \in \mathcal{T}_i$ of μ_i -measure 0 and a sequence of completely mixed profiles of behavioral strategies $(\beta^k)_{k=1}^\infty = (\beta_1^k, \dots, \beta_n^k)_{k=1}^\infty$ such that for every player i and every type $t_i \in T_i \setminus S_i$ conditions (i) and (ii) of this definition are satisfied. For every player i , let γ_i and γ_i^k be the distributional strategies induced by β_i and β_i^k respectively. We prove that conditions (i) and (ii) of Definition 4.3.1 are satisfied. Take a player i . For condition (i), we show that for any bounded and continuous function $h : T_i \times A_i \rightarrow \mathbf{R}$, we have

$$\int_{T_i \times A_i} h d\gamma_i^k \longrightarrow \int_{T_i \times A_i} h d\gamma_i \text{ as } k \rightarrow \infty.$$

As h is bounded and continuous on $T_i \times A_i$, the function $h_{t_i}(a_i) = h(t_i, a_i)$ on A_i is also bounded and continuous for every $t_i \in T_i$. Let

$$g^k(t_i) = \int_{A_i} h_{t_i} \beta_i^k(t_i, da_i) \text{ , } g(t_i) = \int_{A_i} h_{t_i} \beta_i(t_i, da_i).$$

By Theorem 10.2.1 in [11], the functions g^k and g are measurable. Moreover, because for every type $t_i \in T_i \setminus S_i$, $\lim_{k \rightarrow \infty} \rho^w(\beta_i^k(t_i, \cdot), \beta_i(t_i, \cdot)) = 0$, we have $g^k(t_i) \longrightarrow g(t_i)$ as $k \rightarrow \infty$, for μ_i -a.e. $t_i \in T_i$. Therefore, by Dominated Convergence Theorem

$$\int_{T_i} g^k(t_i) \mu_i(dt_i) \longrightarrow \int_{T_i} g(t_i) \mu_i(dt_i) \text{ as } k \rightarrow \infty.$$

This implies that

$$\int_{T_i \times A_i} h d\gamma_i^k \longrightarrow \int_{T_i \times A_i} h d\gamma_i \text{ as } k \rightarrow \infty.$$

Now, we prove that condition (ii) of Definition 4.3.1 is satisfied. We know that for every $t_i \in T_i \setminus S_i$ we have $\rho^w(\beta_i^k(t_i, \cdot), BR_i(t_i, \beta^k)) \rightarrow 0$ as $k \rightarrow \infty$. Hence, for every $t_i \in T_i \setminus S_i$, there exists a sequence $\hat{\beta}_i^k(t_i, \cdot) \in BR_i(t_i, \beta^k)$ such that $\rho^w(\beta_i^k(t_i, \cdot), \hat{\beta}_i^k(t_i, \cdot)) \rightarrow 0$ as $k \rightarrow \infty$. Define $\hat{\gamma}_i^k$ to be the distributional strategies induced by $\hat{\beta}_i^k$ for every $k \in \mathbf{N}$. With the same argument as in the previous part, we conclude that $\rho^w(\gamma_i^k, \hat{\gamma}_i^k) \rightarrow 0$ as $k \rightarrow \infty$. Since

$$\Pi_i(\gamma_i, \gamma_{-i}) = \int_{T_i} \Pi_i^b(\beta_i, \beta_{-i} \mid t_i) \mu_i(dt_i),$$

one can easily verify that if $\hat{\beta}_i^k(t_i, \cdot) \in BR_i(t_i, \beta^k)$ for every $t_i \in T_i \setminus S_i$, then $\hat{\gamma}_i^k \in BR_i(\gamma^k)$. Hence, we have $\lim_{k \rightarrow \infty} \rho^w(\gamma_i^k, BR_i(\gamma_i^k)) = 0$. So, condition (ii) holds. \blacksquare

4.5 Second-price auctions with interdependent values

In this section we study symmetric second-price auctions with interdependent values for two bidders and apply distributional perfection in this context. Let Λ be the following sealed-bid second-price auction for a single indivisible object. There are 2 bidders. Prior to bidding, each bidder i receives a private signal $t_i \in T_i = [\underline{t}, \bar{t}]$, which is called the type of bidder i . Signals are drawn independently according to a distribution μ_i . Bidder i 's valuation of the object may depend on both types and is denoted by $v_i(t_1, t_2)$. Each bidder i , after observing his own type, submits a bid from a set A_i independently of his opponent, where A_i is sufficiently large in the sense that it contains the range of v_i . Given the bids submitted by the bidders, the highest bid wins the auction for the price equal to the second highest bid.¹² Suppose the following assumptions in this auction:

- (1) $v_1(t_1, t_2) = v_2(t_2, t_1)$.
- (2) v_i is continuously differentiable.
- (3) v_i is strictly increasing in t_i and increasing in t_j for $j \neq i$.

In Λ the set of available bids for bidder i is an interval $A_i = [\underline{a}, \bar{a}]$, where $v_i(\underline{t}, \underline{t}) = \underline{a}$ and $v_i(\bar{t}, \bar{t}) = \bar{a}$, for $i = 1, 2$. In such auctions bidders do not necessarily have any dominant strategy, however it may contain many equilibria. Hence, a

¹²In the event of a tie for the highest bid, the winner is chosen according to a probability distribution which may depend on the identity of the highest bidder and his type as well. In our setting, a tie will only occur with probability 0, even given the type of one bidder, which makes the specification of this tie-breaking rule irrelevant for the expected profits.

refinement is needed in order to rule out the less intuitive equilibria and get a smaller set of solutions. We use distributional perfection for this purpose. In Proposition 4.5.1 we show that a class of BNEs that was discovered by Milgrom in [32] are distributional perfect and in Proposition 4.5.3 we prove that distributional perfection rules out another class of equilibria introduced by Krishna in [23].

Proposition 4.5.1 *Let $\phi : [\underline{t}, \bar{t}] \rightarrow [\underline{t}, \bar{t}]$ be an increasing bijection. Consider the strategy profile (b_1, b_2) in which $b_1(t_1) = v_1(t_1, \phi(t_1))$ and $b_2(t_2) = v_2(\phi^{-1}(t_2), t_2)$. If $v_i(t, \phi(t)) = v_i(\phi(t), t)$, for $i = 1, 2$, then (b_1, b_2) is a distributional perfect BNE. Moreover, b_i is undominated for every bidder i .*

Proof. First we show that (b_1, b_2) is a BNE. Define $w(t) = v_1(t, \phi(t)) = v_2(\phi(t), t)$ for every $t \in [\underline{t}, \bar{t}]$. One can easily see that $w : [\underline{t}, \bar{t}] \rightarrow [a, \bar{a}]$ is an increasing bijection. Suppose that bidder 1 bids $b_1(t_1) = v_1(t_1, \phi(t_1))$. The expected payoff of bidder 2 having type t_2 and bidding p_2 is:

$$\Pi_2^b(b_1, p_2 \mid t_2) = \int_{\underline{t}}^{w^{-1}(p_2)} (v_2(t_1, t_2) - v_1(t_1, \phi(t_1))) \mu_1(dt_1).$$

As v_2 is strictly increasing in the second argument and we know

$$v_2(t_1, t_2) - v_1(t_1, \phi(t_1)) = v_2(t_1, t_2) - v_2(\phi(t_1), t_1) = v_2(t_1, t_2) - v_2(t_1, \phi(t_1)),$$

it is clear that if $\phi(t_1) \leq t_2$, then $v_2(t_1, t_2) - v_1(t_1, \phi(t_1)) \geq 0$ and negative otherwise. Hence, the maximum of $\Pi_2^b(b_1, p_2 \mid t_2)$ is obtained by choosing p_2 such that $w^{-1}(p_2) = t_1 = \phi^{-1}(t_2)$ which means $p_2 = w(\phi^{-1}(t_2)) = v_2(t_2, \phi^{-1}(t_2)) = b_2(t_2)$. Furthermore, $\Pi_2^b(b_1, p_2 \mid t_2)$ is maximized over p_2 if and only if $p_2 = b_2(t_2)$, which implies that bidding b_2 is the unique best response against b_1 for bidder 2.

Next, we prove that the strategy profile (b_1, b_2) is distributional perfect. Let γ_1 be the distributional strategy induced by b_1 and for every $k \in \mathbf{N}$ define $\gamma_1^k = (1 - \varepsilon_k)\gamma_1 + \varepsilon_k\eta_1$, where $\varepsilon_k \in (0, 1)$, $\varepsilon_k \rightarrow 0$ as $k \rightarrow \infty$, and η_1 is the normalized uniform distributional strategy¹³ on the product space $T_1 \times A_1$. Let p_2 be a pure behavioral strategy for bidder 2 and σ_2 be the induced distributional strategy by p_2 . Then, the expected payoff of bidder 2 choosing σ_2 against γ_1^k is:

$$\begin{aligned} \Pi_2(\gamma_1^k, \sigma_2) &= \int \int_{p_2 > a_1} (v_2(t_1, t_2) - a_1) d\gamma_1^k d\sigma_2 \\ &= \int_{T_2} \int_{p_2 > a_1} (v_2(t_1, t_2) - a_1) d\gamma_1^k \mu_2(dt_2) \\ &= \int_{T_2} \Pi_2^b(\beta_1^k, p_2 \mid t_2) \mu_2(dt_2), \end{aligned}$$

¹³ That is $\eta_1(S_1 \times A_1) = \mu_1(S_1)$ for every $S_1 \in \mathcal{T}_1$ and for a behavioral strategy λ_1 corresponding to η_1 we have $\lambda_1(t_1, \cdot)$ is the uniform distribution on A_1 for every $t_1 \in T_1$.

where β_1^k is a behavioral strategy corresponding to γ_1^k for every $k \in \mathbf{N}$. To maximize $\Pi_2(\gamma_1^k, \sigma_2)$ it is enough to maximize $\Pi_2^b(\beta_1^k, p_2 | t_2)$ over p_2 . We have

$$\begin{aligned}
\Pi_2^b(\beta_1^k, p_2 | t_2) &= (1 - \varepsilon_k) \int_{p_2 > a_1} (v_2(t_1, t_2) - a_1) d\gamma_1 \\
&+ \varepsilon_k \int_{p_2 > a_1} (v_2(t_1, t_2) - a_1) d\eta_1 \\
&= (1 - \varepsilon_k) \int_{\underline{t}}^{w^{-1}(p_2)} (v_2(t_1, t_2) - v_1(t_1, \phi(t_1))) \mu_1(dt_1) \\
&+ \varepsilon_k \int_{p_2 > a_1} (v_2(t_1, t_2) - a_1) d\eta_1 \\
&= (1 - \varepsilon_k) \Pi_2^b(b_1, p_2 | t_2) + \varepsilon_k \int_{p_2 > a_1} (v_2(t_1, t_2) - a_1) d\eta_1.
\end{aligned}$$

Suppose that $p_2 = b_2^k(t_2)$ maximizes $\Pi_2^b(\beta_1^k, p_2 | t_2)$ for every k . Also, we know that $p_2 = b_2$ is the unique maximizer of $\Pi_2^b(b_1, p_2 | t_2)$. Then, clearly we have that b_2^k converges to b_2 when $k \rightarrow \infty$. With a similar argument for bidder 2, we can conclude that (b_1, b_2) is distributional perfect.

Finally, the fact that bidding b_2 is the unique best response for bidder 2 against b_1 , implies that b_2 is undominated. A similar argument holds for b_1 . ■

Remark that if for the class of strategy profiles (b_1, b_2) in Proposition 4.5.1 one can find more than one map ϕ that satisfies the condition $v_i(t, \phi(t)) = v_i(\phi(t), t)$, for $i = 1, 2$, then obviously these strategy profiles are not in dominant strategies. Because, for each ϕ , b_i the unique best response for bidder i against b_j where $j \neq i$. In the case that this class of equilibria only contains one strategy profile, that would be the equilibrium in which $b_i = v_i(t_i, t_i)$ for every $i = 1, 2$. In the next proposition we prove that this strategy profile is not in dominant strategies.

Proposition 4.5.2 *Suppose that there is a $y \in T_j$ such that $\frac{\partial v_i(\bar{t}_i, t_j)}{\partial t_j}(y) > 0$, where $j \neq i$. Then, $b_i = v_i(t_i, t_i)$ is not a dominant strategy for bidder $i = 1, 2$.*

Proof. We prove that $b_1 = v_1(t_1, t_1)$ is not a dominant strategy for bidder 1. First, we show that there is a set of types $I \in \mathcal{T}_1$ with $\mu_1(I) > 0$, such that for every $t_1 \in I$ bidding according $b_1(t_1) = v_1(t_1, t_1)$ has strictly negative payoff for bidder 1. By assumption we conclude that there is a set $B \in \mathcal{T}_2$ with $\mu_2(B) > 0$ such that the map $v_1(\bar{t}, \cdot) : T_2 \rightarrow [\underline{a}, \bar{a}]$ is strictly increasing on B . Therefore, for every $t_2 \in B \setminus \{\bar{t}\}$ we have

$$v_1(\bar{t}, t_2) < v_1(\bar{t}, \bar{t}),$$

also for every $t_2 \in T_2$ we know that

$$v_1(\bar{t}, t_2) \leq v_1(\bar{t}, \bar{t}).$$

Therefore,

$$\int_{T_2} v_1(\bar{t}, t_2) \mu_2(dt_2) < v_1(\bar{t}, \bar{t}) = b_1(\bar{t}).$$

Let $y(t_1) = \int_{T_2} v_1(t_1, t_2) \mu_2(dt_2)$. Choose any $\tilde{b}_2 \in (y(\bar{t}), b_1(\bar{t}))$. Note that the maps y and b_1 are strictly increasing, hence invertible. Therefore, $b_1^{-1}(\tilde{b}_2) < \bar{t} < y^{-1}(\tilde{b}_2)$. Let $I = (b_1^{-1}(\tilde{b}_2), \bar{t}]$, which is a nonempty interval of T_1 with $\mu_1(I) > 0$. One can easily verify that for every $t_1 \in I$ we have $y(t_1) < \tilde{b}_2 < b_1(t_1)$.

Suppose bidder 2 bids \tilde{b}_2 for every $t_2 \in T_2$ and bidder 1 bids according to $b_1(t_1)$. If $t_1 \in I$, then bidder 1 wins the auction, since $\tilde{b}_2 < b_1(t_1)$ and his expected payoff for every $t_1 \in I$ is

$$\int_{T_2} (v_1(t_1, t_2) - \tilde{b}_2) \mu_2(dt_2) = y(t_1) - \tilde{b}_2 < 0.$$

In the case that $t_1 \notin I$, the value of the map $y(t_1)$ strictly decreases when compared to the case $t_1 \in I$. Consequently, even if bidder 1 wins the auction $y(t_1) - \tilde{b}_2$ remains strictly negative. Hence, we have

$$\int_{b_1(t_1) > \tilde{b}_2} (v_1(t_1, t_2) - \tilde{b}_2) \mu_2(dt_2) \mu_1(dt_1) < 0.$$

Now, let $\tilde{b}_1(t_1) = \underline{a}$ and $\tilde{b}_2(t_2) = \tilde{b}_2$. Moreover, let $\gamma_1, \tilde{\gamma}_1$, and $\tilde{\gamma}_2$ be the induced distributional strategies respectively by b_1, \tilde{b}_1 , and \tilde{b}_2 . Then, we have

$$\Pi_1(\gamma_1, \tilde{\gamma}_2) < \Pi_1(\tilde{\gamma}_1, \tilde{\gamma}_2),$$

in which $\Pi_1(\tilde{\gamma}_1, \tilde{\gamma}_2) = 0$ as bidder 1 always loses the auction by bidding $\tilde{b}_1(t_1) = \underline{a}$. This shows that $b_1 = v_1(t_1, t_1)$ is not a dominant strategy for every bidder 1. The argument for bidder 2 is similar. ■

Notice that in the case when $\phi(t) = t$, for every $t \in [\underline{t}, \bar{t}]$, the distributional perfect BNE in which each player i bids $b_i(t_i) = v_i(t_i, t_i)$ is a symmetric BNE. Moreover, if we assume that

$$\frac{\partial v_i}{\partial t_i}(t_1, t_2) > \frac{\partial v_j}{\partial t_i}(t_1, t_2),$$

for $j \neq i$, then (b_1, b_2) , in which $b_i = v_i(t_i, t_i)$ for every bidder i , is an efficient equilibrium.¹⁴ According to Krishna [23], this condition is called single crossing condition and ensures that the bidder with higher type has higher ex post valuation. Another interesting case of Proposition 4.5.1 is when Λ is a common value auction, i.e. when $v_1(t_1, t_2) = v_2(t_1, t_2)$. In this case, the condition $v_i(t, \phi(t)) = v_i(\phi(t), t)$, for $i = 1, 2$, holds for every increasing bijection ϕ . Therefore, in common value auctions for every increasing bijection ϕ , the strategy profile (b_1, b_2) is distributional perfect.

In private value Vickrey auctions, each bidder has a dominant strategy that forms a distributional perfect BNE and leads to an efficient outcome. This observation motivates us to study the relation between distributional perfection and efficiency in our setting:

Remark. In the auction Λ with single crossing condition, if $\phi(t) \geq \phi^{-1}(t)$, for every $t \in [\underline{t}, \bar{t}]$, then the strategy profile (b_1, b_2) is efficient. The argument is as follows: Suppose that x, y are the actual types that bidders 1 and 2 receive respectively and $x > y$. Then, the single crossing condition implies that bidder 1's ex post valuation is strictly larger than bidder 2's, that is $v_1(x, y) > v_2(x, y)$. Now, if $\phi(y) \geq \phi^{-1}(y)$, then we have

$$b_1(x) = v_1(x, \phi(x)) > v_1(y, \phi(y)) \geq v_1(y, \phi^{-1}(y)) = v_2(\phi^{-1}(y), y) = b_2(y).$$

This means that bidder 1 who had a higher ex post valuation for the object, wins the auction and is awarded the object.

Example 8.4 in Krishna [23] introduces the following class of discontinuous asymmetric strategy profiles for every $s_1, s_2 \in [\underline{t}, \bar{t}]$ with $s_1 < s_2$ ¹⁵:

$$\hat{b}_1(t_1) = \begin{cases} v_1(s_2, t_1) & \text{if } t_1 \in [s_1, s_2] \\ v_1(t_1, t_1) & \text{otherwise,} \end{cases}$$

$$\hat{b}_2(t_2) = \begin{cases} v_2(t_2, s_1) & \text{if } t_2 \in [s_1, s_2] \\ v_2(t_2, t_2) & \text{otherwise.} \end{cases}$$

He shows that if we assume the single crossing condition for the auction Λ , then (\hat{b}_1, \hat{b}_2) is an ex post equilibrium in undominated strategies, moreover this equilibrium allocates the object inefficiently. In Proposition 4.5.3 we prove that distributional perfection at least rules out a subclass of these equilibria.

¹⁴ An outcome in any auction is called efficient if the winner is the one with the highest ex post valuation.

¹⁵ Krishna presents the bid functions in terms of the opponent's valuations. We do this for each bidder in terms of his own valuations.

Proposition 4.5.3 *Suppose the auction Λ satisfies the single crossing condition such that one of the followings holds:*

- (1) $v_2(s_2, s_1) < v_2(\underline{t}, s_2)$,
- (2) $v_1(s_2, s_1) > v_1(s_1, \bar{t})$.

Then, the ex post equilibrium (\hat{b}_1, \hat{b}_2) is not distributional perfect.

Proof. First we discuss the case $v_2(s_2, s_1) < v_2(\underline{t}, s_2)$. Suppose by way of contradiction that (\hat{b}_1, \hat{b}_2) is distributional perfect. Let $\hat{\gamma}_i$ be the distributional strategy induced by \hat{b}_i and $(\gamma_i^k)_{k=1}^\infty$ be a sequence of completely mixed distributional strategies for each bidder $i = 1, 2$ that satisfies condition (i) and (ii) of Definition 4.3.1. Therefore, for bidder 2 and every k , there is a distributional strategy $\tilde{\gamma}_2^k \in BR_2(\gamma^k)$ such that $\rho^w(\gamma_2^k, \tilde{\gamma}_2^k) \rightarrow 0$ as $k \rightarrow \infty$. Hence, by triangle inequality we conclude that $\rho^w(\tilde{\gamma}_2^k, \hat{\gamma}_2) \rightarrow 0$ as $k \rightarrow \infty$. For every k , let β_1^k , β_2^k , and $\tilde{\beta}_2^k$ be a corresponding behavioral strategy to γ_1^k , γ_2^k , and $\tilde{\gamma}_2^k$ respectively. Also, let $\beta^k = (\beta_1^k, \beta_2^k)$. Then, by Lemma 4.6.1 we have $\tilde{\beta}_2^k(t_2, \cdot) \in BR_2(t_2, \beta^k)$ for μ_2 -a.e. $t_2 \in T_2$. By redefining $\tilde{\beta}_2^k$, without loss of generality, we can assume that $\tilde{\beta}_2^k(t_2, \cdot) \in BR_2(t_2, \beta^k)$ for every $t_2 \in T_2$.

As $v_2(s_2, s_1) < v_2(\underline{t}, s_2)$, then there is a $\delta > 0$ such that for every $t_2 \in (s_2 - \delta, s_2]$, we have $v_2(t_2, s_1) < v_2(\underline{t}, t_2)$. Let bidder 2's type be $t_2 \in (s_2 - \delta, s_2]$. It is obvious that bidder 2's valuation is at least $v_2(\underline{t}, t_2)$. Since for every k , γ_1^k is completely mixed, for every nonempty open set $B \subseteq A_1$, there is a type $t_1 \in T_1$ such that $\beta_1^k(t_1, B) > 0$. Therefore, bidder 1 might bid any bid $a_1 \in A_1$ according to β_1^k . If $a_1 < v_2(\underline{t}, t_2)$, then bidding $v_2(\underline{t}, t_2)$ is better than bidding $p_2 < v_2(\underline{t}, t_2)$, since it increases the chance of winning. If $a_1 \geq v_2(\underline{t}, t_2)$, then bidder 2 is indifferent between bidding any bid $p_2 \leq v_2(\underline{t}, t_2)$. Therefore, bidder 2's best response against β_1^k , for every k , can not be any bid below $v_2(\underline{t}, t_2)$. Moreover, for every $t_2 \in (s_2 - \delta, s_2]$, we have $\hat{b}_2(t_2) = v_2(t_2, s_1) < v_2(\underline{t}, t_2)$. Hence, if bidder 2 is given a type $t_2 \in (s_2 - \delta, s_2]$, then any of his best responses against β_1^k , for every k , is far from $\hat{b}_2(t_2)$. In particular, as for every $t_2 \in T_2$ we have $\tilde{\beta}_2^k(t_2, \cdot) \in BR_2(t_2, \beta^k)$, for every k , then for every $t_2 \in (s_2 - \delta, s_2]$ we have that $\rho^w(\hat{b}_2(t_2), \tilde{\beta}_2^k(t_2, \cdot))$ does not converge to zero when $k \rightarrow \infty$. Notice that $\hat{b}_2(t_2)$ is interpreted as a behavioral strategy that assigns probability 1 on $\hat{b}_2(t_2)$ for every $t_2 \in T_2$.

Now, we show that there is $\varepsilon > 0$ such that $\rho^w(\tilde{\gamma}_2^k, \hat{\gamma}_2) > \varepsilon$ for every k . One can find $\varepsilon > 0$ and $\lambda > 0$ such that if for every $t_2 \in (s_2 - \delta, s_2]$ we define

$$B_{t_2} = \left(\hat{b}_2(t_2) - \lambda, \hat{b}_2(t_2) + \lambda \right),$$

then we have

1. $s_2 - \delta + \varepsilon < s_2 - \varepsilon$,
2. $\mu_2(s_2 - \delta + \varepsilon, s_2 - \varepsilon) > \varepsilon$,
3. $\tilde{\beta}_2^k(t_2, (B_{t_2})^\varepsilon) = 0$.

Now, define $B = \{(t_2, a_2) \mid t_2 \in (s_2 - \delta + \varepsilon, s_2 - \varepsilon], a_2 \in B_{t_2}\}$. Clearly, B is measurable. As $\hat{b}_2(t_2)(B_{t_2}) = 1$ and $\hat{\beta}_2^k(t_2, (B_{t_2})^\varepsilon) = 0$, we have

$$\hat{\gamma}_2(B) = \int_{s_2 - \delta + \varepsilon}^{s_2 - \varepsilon} \hat{b}_2(t_2)(B_{t_2}) \mu_2(dt_2) = \mu_2(s_2 - \delta + \varepsilon, s_2 - \varepsilon),$$

and

$$\tilde{\gamma}_2^k(B^\varepsilon) = \int_{s_2 - \delta}^{s_2} \hat{\beta}_2^k(t_2, (B_{t_2})^\varepsilon) \mu_2(dt_2) = 0.$$

Consequently,

$$\hat{\gamma}_2(B) > \tilde{\gamma}_2^k(B^\varepsilon) + \varepsilon,$$

then $\rho^w(\tilde{\gamma}_2^k, \hat{\gamma}_2) > \varepsilon$ for every k . This contradicts with the assumption $\rho^w(\tilde{\gamma}_2^k, \hat{\gamma}_2) \rightarrow 0$ as $k \rightarrow \infty$. Therefore, (\hat{b}_1, \hat{b}_2) is not distributional perfect.

With an analogous argument for the case $v_1(s_2, s_1) > v_1(s_1, \bar{t})$, the proof of the proposition is complete. ■

Conditions (1) and (2) in the above proposition are not very restrictive. For example, all auctions in which either $s_1 = \underline{t}$ or $s_2 = \bar{t}$, satisfy conditions (1) and (2) respectively. As an extreme case of this type of equilibria, we see that the BNE in which one bidder always bids \bar{a} and the other bidder always bids \underline{a} is not distributional perfect. This kind of equilibrium is called wolf and sheep equilibrium and is considered as a less intuitive one.

In the auction Λ , we change the condition (3) to be “ v_i is strictly increasing at t_i and decreasing at t_j for $j \neq i$ ” and we call it (3'). Let Λ' be the auction that satisfies conditions (1), (2), (3'), and single crossing condition. In this auction $v_1(\underline{t}, \bar{t}) = v_2(\bar{t}, \underline{t}) = \underline{a}$ and $v_1(\bar{t}, \underline{t}) = v_2(\underline{t}, \bar{t}) = \bar{a}$. Moreover, the class of BNEs corresponding to ϕ in Proposition 4.5.1 reduces to the single equilibrium where $\phi(t) = t$, that is $b_1(t_1) = v_1(t_1, t_1)$ and $b_2(t_2) = v_2(t_2, t_2)$. In the next proposition we show that this equilibrium is distributional perfect. To prove perfection in the following proposition we encounter more difficulties as compare to the proposition 4.5.1. The reason is that the bid functions of the bidders are not surjective which together with the possibility of making mistakes from the opponent, give the opportunity to the

bidder to bid strictly higher than $b_i(1) = v_i(1, 1)$ when he is from high type. The similar argument is valid if the bidder is from low type, i.e. he can bid strictly less than $b_i(0) = v_i(0, 0)$.

Proposition 4.5.4 *In the auction Λ' , the strategy profile (b_1, b_2) in which $b_1(t_1) = v_1(t_1, t_1)$ and $b_2(t_2) = v_2(t_2, t_2)$ is a distributional perfect BNE.*

Proof. Let $w(t) = v_1(t, t) = v_2(t, t)$, then the function $w : [\underline{t}, \bar{t}] \rightarrow [\underline{a}, \bar{a}]$ is strictly increasing but not surjective. It is easy to check that (b_1, b_2) is a BNE. Now, we prove that it is distributional perfect. Let γ_1 be the distributional strategy induced by $b_1(t_1)$ and for every $k \in \mathbf{N}$ define γ_1^k and β_1^k as in the proposition 4.5.1. Let p_2 be a pure behavioral strategy for bidder 2 and σ_2 be the induced distributional strategy by p_2 . Then, the expected payoff of bidder 2 choosing σ_2 against γ_1^k conditioning on winning is:

$$\Pi_2(\gamma_1^k, \sigma_2) = \int_{T_2} \Pi_2^b(\beta_1^k, p_2 \mid t_2) \mu_2(dt_2),$$

To maximize $\Pi_2(\gamma_1^k, \sigma_2)$, we maximize $\Pi_2^b(\beta_1^k, p_2 \mid t_2)$ in the following three cases:

(1) $\underline{a} \leq p_2 \leq w(\underline{t})$:

$$\Pi_2^b(\beta_1^k, p_2 \mid t_2) = 0 + \varepsilon_k \int_{p_2 > a_1} (v_2(t_1, t_2) - a_1) d\eta_1$$

(2) $w(\underline{t}) \leq p_2 \leq w(\bar{t})$:

$$\begin{aligned} \Pi_2^b(\beta_1^k, p_2 \mid t_2) = \\ (1 - \varepsilon_k) \int_{\underline{t}}^{w^{-1}(p_2)} (v_2(t_1, t_2) - w(t_1)) \mu_1(dt_1) + \varepsilon_k \int_{p_2 > a_1} (v_2(t_1, t_2) - a_1) d\eta_1 \end{aligned}$$

(3) $w(\bar{t}) \leq p_2 \leq \bar{a}$:

$$\begin{aligned} \Pi_2^b(\beta_1^k, p_2 \mid t_2) = \\ (1 - \varepsilon_k) \int_{\underline{t}}^{\bar{t}} (v_2(t_1, t_2) - w(t_1)) \mu_1(dt_1) + \varepsilon_k \int_{p_2 > a_1} (v_2(t_1, t_2) - a_1) d\eta_1 \end{aligned}$$

Let p_{21}^k, p_{22}^k and p_{23}^k be the bid functions for bidder 2 that maximizes $\Pi_2^b(\beta_1^k, p_2 \mid t_2)$ in the cases 1, 2 and 3 respectively for every t_2 . With a similar argument as in the proposition 4.5.1, we can see that p_{22}^k converges to $b_2(t_2) = v_2(t_2, t_2) = w(t_2)$, as $k \rightarrow \infty$. Moreover, let

$$M_1^k = \{t_2 \in T_2 \mid \Pi_2^b(\beta_1^k, p_{21}^k \mid t_2) \geq \Pi_2^b(\beta_1^k, p_{22}^k \mid t_2)\},$$

for every $k \in \mathbf{N}$. It is obvious that $\mu_2(M_1^k) \rightarrow 0$ when $k \rightarrow \infty$. Also, let

$$M_2^k = \{t_2 \in T_2 \mid \Pi_2^b(\beta_1^k, p_{23}^k \mid t_2) \geq \Pi_2^b(\beta_1^k, p_{22}^k \mid t_2)\}.$$

Notice that $v_2(t_1, t_2) - w(t_1) \geq 0$ for every $t_1 \leq t_2$ and negative otherwise, also we know that $w^{-1}(p_{22}^k) \rightarrow t_2$, as $k \rightarrow \infty$. Hence, for μ_2 -a.e. $t_2 \in T_2$ and enough large k ,

$$\Pi_2^b(\beta_1^k, p_{23}^k \mid t_2) \leq \Pi_2^b(\beta_1^k, p_{22}^k \mid t_2).$$

This means that $\mu_2(M_2^k) \rightarrow 0$ when $k \rightarrow \infty$. Therefore, for μ_2 -a.e. $t_2 \in T_2$, $\Pi_2^b(\beta_1^k, p_2 \mid t_2)$ is maximized when $p_2 = b_2(t_2) = v_2(t_2, t_2)$ as $k \rightarrow \infty$. By a similar argument for bidder 2 the proof is complete. ■

In the auction Λ' , there are many equilibria similar to (\hat{b}_1, \hat{b}_2) in auction Λ that can be rule out by distributional perfection. The examples of such equilibria can be found in Proposition 3.4.6 and Proposition 3.4.7 in chapter 3.

4.6 Appendix

Lemma 4.6.1 *Let $\beta = (\beta_1, \dots, \beta_n)$ be a behavioral strategy profile and $\gamma = (\gamma_1, \dots, \gamma_n)$ be the induced distributional strategy profile. Assume that the set of the best responses of player i against behavioral strategy profile β_{-i} is not empty. Then, if $\gamma_i \in BR_i(\gamma)$, then $\beta_i(t_i, \cdot) \in BR_i(t_i, \beta)$ for μ_i -a.e. $t_i \in T_i$.*

Proof. Suppose for every player i that $\gamma_i \in BR_i(\gamma)$. Then, we have

$$\Pi_i(\gamma_i, \gamma_{-i}) \geq \Pi_i(\tilde{\gamma}_i, \gamma_{-i}),$$

for every player i 's distributional strategy $\tilde{\gamma}_i$. Therefore, for every player i 's behavioral strategy $\tilde{\beta}_i$ we have

$$\int_{T_i} \Pi_i^b(\beta_i, \beta_{-i} \mid t_i) \mu_i(dt_i) \geq \int_{T_i} \Pi_i^b(\tilde{\beta}_i, \beta_{-i} \mid t_i) \mu_i(dt_i). \quad (4.1)$$

Moreover, by assumption, for every player i there is a behavioral strategy ζ_i such that $\zeta_i(t_i, \cdot) \in BR_i(t_i, \beta)$ for every $t_i \in T_i$, which means having type $t_i \in T_i$

$$\Pi_i^b(\zeta_i, \beta_{-i} \mid t_i) \geq \Pi_i^b(a_i, \beta_{-i} \mid t_i),$$

for every $a_i \in A_i$. To prove that $\beta_i(t_i, \cdot)$ for μ_i -a.e. $t_i \in T_i$ is a best response for every player i against β_{-i} , we show that $\Pi_i^b(\zeta_i, \beta_{-i} \mid t_i) = \Pi_i^b(\beta_i, \beta_{-i} \mid t_i)$ for μ_i -a.e. $t_i \in T_i$. Suppose the opposite. First, let

$$S_i = \{t_i \in T_i \mid \Pi_i^b(\zeta_i, \beta_{-i} \mid t_i) < \Pi_i^b(\beta_i, \beta_{-i} \mid t_i)\}.$$

Clearly, S_i is μ_i -measurable. Suppose $\mu_i(S_i) > 0$. Notice that given $t_i \in T_i$, for $\beta_i(t_i, \cdot)$ -a.e. $a_i \in A_i$ we have

$$\Pi_i^b(\beta_i, \beta_{-i} \mid t_i) = \Pi_i^b(a_i, \beta_{-i} \mid t_i).$$

Then, given $t_i \in S_i$, for $\beta_i(t_i, \cdot)$ -a.e. $a_i \in A_i$ we conclude that

$$\Pi_i^b(\zeta_i, \beta_{-i} \mid t_i) < \Pi_i^b(a_i, \beta_{-i} \mid t_i),$$

which is a contradiction with optimality of ζ_i for every type. Second, let

$$S_i = \{t_i \in T_i \mid \Pi_i^b(\zeta_i, \beta_{-i} \mid t_i) > \Pi_i^b(\beta_i, \beta_{-i} \mid t_i)\}$$

and suppose $\mu_i(S_i) > 0$. Therefore, we have

$$\int_{S_i} \Pi_i^b(\zeta_i, \beta_{-i} \mid t_i) \mu_i(dt_i) > \int_{S_i} \Pi_i^b(\beta_i, \beta_{-i} \mid t_i) \mu_i(dt_i).$$

Since $\zeta_i(t_i, \cdot)$ is a best response for every type $t_i \in T_i$ against β_{-i} , for every $a_i \in A_i$ we have

$$\Pi_i^b(\zeta_i, \beta_{-i} \mid t_i) \geq \Pi_i^b(a_i, \beta_{-i} \mid t_i),$$

thus

$$\int_{T_i \setminus S_i} \Pi_i^b(\zeta_i, \beta_{-i} \mid t_i) \mu_i(dt_i) \geq \int_{T_i \setminus S_i} \Pi_i^b(\beta_i, \beta_{-i} \mid t_i) \mu_i(dt_i).$$

Consequently,

$$\int_{T_i} \Pi_i^b(\zeta_i, \beta_{-i} \mid t_i) \mu_i(dt_i) > \int_{T_i} \Pi_i^b(\beta_i, \beta_{-i} \mid t_i) \mu_i(dt_i).$$

This is a contradiction with (4.1). Overall, we showed that if there is a subset of T_i on which the expected payoff of player i , playing according to ζ_i is different from playing according to β_i , the measure of that subset is zero. In other words, for every i there exists a set $S_i \in \mathcal{T}_i$ with $\mu_i(S_i) = 0$ such that for every $t_i \in T_i \setminus S_i$ we have $\beta_i(t_i, \cdot) \in BR_i(t_i, \beta)$. This completes the proof. ■

In the lemma 4.6.2, we use the following metrics: Take $t, s \in T$ and $a, b \in A$. Define

$$d_T(t, s) = \left(\sum_{i=1}^n d_{T_i}^2(t_i, s_i) \right)^{\frac{1}{2}}, \quad d_A(a, b) = \left(\sum_{i=1}^n d_{A_i}^2(a_i, b_i) \right)^{\frac{1}{2}}.$$

Moreover, let $d_{T \times A}((t, a), (s, b)) = (d_T^2(t, s) + d_A^2(a, b))^{\frac{1}{2}}$.

Lemma 4.6.2 *In Bayesian game Γ , for every player i and every $\varepsilon > 0$, there is a set $K \in \mathcal{T}$ with $\mu(K^c) < \varepsilon$ such that π_i is continuous on $K \times A$ for every i .*

Proof. Take $\varepsilon > 0$ and $a \in A$. First we prove that there is a set $K \in \mathcal{T}$ with $\mu(K^c) < \varepsilon$ such that the function $\pi_i(\cdot, a) : K \rightarrow \mathbf{R}$ is continuous. As A is separable, it has a countable dense subset, say B . Hence, there exists a sequence $(a_k)_{k=1}^{\infty}$ in B such that $a_k \neq a$, for every k , and $d_A(a_k, a) \rightarrow 0$ as $k \rightarrow \infty$. According to Lusin's Theorem for the collection of the functions $\{\pi_i(\cdot, a_k) \mid k = 1, 2, \dots\}$ there is a compact set $E \in \mathcal{T}$ with $\mu(E^c) < \frac{\varepsilon}{2}$ such that $\pi_i(\cdot, a_k)$ is continuous on E for every $k \in \mathbf{N}$. Moreover, by equicontinuity of payoffs there is a set $F \in \mathcal{T}$ with $\mu(F^c) < \frac{\varepsilon}{2}$ such that the collection of the functions $\{\pi_i(t, \cdot) : A \rightarrow \mathbf{R} \mid t \in F\}$ is equicontinuous. Let $K = E \cap F$. It is clear that $\mu(K^c) < \varepsilon$. Moreover, because $\pi_i(t, \cdot)$ is continuous in actions for every $t \in K$, the sequence of the functions $(\pi_i(\cdot, a_k))_{k=1}^{\infty}$ converges pointwisely to $\pi_i(\cdot, a)$ as $k \rightarrow \infty$. It is easy to check that equicontinuity of payoffs and the fact that $d_A(a_k, a) \rightarrow 0$ as $k \rightarrow \infty$, implies that the sequence of functions $(\pi_i(\cdot, a_k))_{k=1}^{\infty}$ uniformly converges to $\pi_i(\cdot, a)$ on K as $k \rightarrow \infty$. Hence, $\pi_i(\cdot, a) : K \rightarrow \mathbf{R}$ is continuous too.

Now, we prove that π_i is continuous at $(t, a) \in K \times A$. We know that $\{\pi_i(t, \cdot) \mid t \in K\}$ is equicontinuous, then there is a $\delta_1 > 0$ such that if $d_A(a, b) < \delta_1$, we have $|\pi_i(t, a) - \pi_i(t, b)| < \frac{\varepsilon}{2}$ for every $t \in K$. Also, we know $\pi_i(\cdot, a)$ is continuous at $t \in K$, so there is a $\delta_2 > 0$ such that if $d_T(t, s) < \delta_2$, we have $|\pi_i(t, a) - \pi_i(s, a)| < \frac{\varepsilon}{2}$. Let $\delta = \min\{\delta_1, \delta_2\}$. Then, for every $(s, b) \in K \times A$ with $d_{T \times A}((t, a), (s, b)) < \delta$ we have $d_A(a, b) < \delta_1$ and $d_T(t, s) < \delta_2$. Consequently, we have

$$|\pi_i(t, a) - \pi_i(s, b)| < |\pi_i(t, a) - \pi_i(s, a)| + |\pi_i(s, a) - \pi_i(s, b)| < \frac{\varepsilon}{2} + \frac{\varepsilon}{2} = \varepsilon.$$

This proves that π_i is continuous on $K \times A$. ■

Lemma 4.6.3 *In Bayesian game Γ , for every player i the function $\Pi_i : \Delta \rightarrow \mathbf{R}$ is continuous with respect to the weak metric on Δ .*

Proof. To prove that Π_i is continuous at a distributional strategy profile γ , let $(\gamma^k)_{k=1}^{\infty}$ be a sequence of distributional strategy profiles converging to γ with respect to the weak metric as $k \rightarrow \infty$. Now, by Lemma 4.6.2 we have the following:

For every i and every $\delta > 0$, there are a continuous and bounded function $v_\delta : T \times A \rightarrow \mathbf{R}$ and a set $K \in \mathcal{T}$ such that $\mu(K^c) < \delta$, and $v_\delta = \pi_i$ on $K \times A$.

As $\mu(K^c) < \delta$, we have $\gamma^k(K^c \times A) < \delta$, for every k . Similarly, $\gamma(K^c \times A) < \delta$. Moreover, because v_δ and π_i are bounded, there is an $M > 0$ such that $|\pi_i - v_\delta| \leq$

M . Hence, for every k we have

$$\int_{T \times A} |\pi_i - v_\delta| f(t) d\gamma^k = \int_{K^c \times A} |\pi_i - v_\delta| f(t) d\gamma^k \leq M \cdot \delta.$$

Similarly,

$$\int_{T \times A} |\pi_i - v_\delta| f(t) d\gamma = \int_{K^c \times A} |\pi_i - v_\delta| f(t) d\gamma \leq M \cdot \delta.$$

Furthermore, as f is $\hat{\mu}$ -integrable, there is a sequence $(f_\ell)_{\ell=1}^\infty$ of bounded and continuous functions such that $\int_T |f(t) - f_\ell(t)| \hat{\mu}(dt) \rightarrow 0$, as $\ell \rightarrow \infty$. Now, we have

$$\begin{aligned} |\Pi_i(\gamma^k) - \Pi_i(\gamma)| &= \left| \int \pi_i f(t) d\gamma^k - \int \pi_i f(t) d\gamma \right| \\ &\leq \int |\pi_i - v_\delta| f(t) d\gamma^k + \int |f(t) - f_\ell(t)| v_\delta d\gamma^k \\ &\quad + \left| \int v_\delta f_\ell(t) d\gamma^k - \int v_\delta f_\ell(t) d\gamma \right| \\ &\quad + \int |f(t) - f_\ell(t)| v_\delta d\gamma + \int |\pi_i - v_\delta| f(t) d\gamma \\ &\leq M\delta + \int |f(t) - f_\ell(t)| v_\delta d\gamma^k \\ &\quad + \left| \int v_\delta f_\ell d\gamma^k - \int v_\delta f_\ell d\gamma \right| \\ &\quad + \int |f(t) - f_\ell(t)| v_\delta d\gamma + M\delta. \end{aligned}$$

Hence, $|\Pi_i(\gamma^k) - \Pi_i(\gamma)|$ converges to zero when $k \rightarrow \infty$, $\ell \rightarrow \infty$, and $\delta \rightarrow 0$. This proves that Π_i is continuous at γ . ■

Mathematical tools

Basic concepts of measure theory

A semi-ring \mathcal{S} is a collection of subsets of a set X satisfying

1. $\emptyset \in \mathcal{S}$,
2. If $E, F \in \mathcal{S}$ then $E \cap F \in \mathcal{S}$,
3. If $E, F \in \mathcal{S}$ then there exists a countable collection $(G_i)_{i \in I}$ of pairwise disjoint sets in \mathcal{S} such that $E \setminus F = \bigcup_{i \in I} G_i$.

A measure on a semi-ring \mathcal{S} is a function $\mu : \mathcal{S} \rightarrow [0, \infty)$ such that

1. $\mu(\emptyset) = 0$,
2. (σ -additivity) For every countable collection $(A_i)_{i \in I}$ of pairwise disjoint sets in \mathcal{S} with $\bigcup_{i \in I} A_i \in \mathcal{S}$ we have

$$\mu\left(\bigcup_{i \in I} A_i\right) = \sum_{i \in I} \mu(A_i).$$

A σ -field Σ is a collection of subsets of a set X satisfying

1. $X \in \Sigma$,
2. If $E \in \Sigma$ then $X \setminus E \in \Sigma$,
3. If $(E_i)_{i \in I}$ is a countable collection of sets in Σ then $\bigcup_{i \in I} E_i \in \Sigma$.

The pair (X, Σ) is called a measurable space.

A metric on a nonempty set X is a function $d : X \times X \rightarrow [0, \infty)$ such that for all $x, y, z \in X$ we have

1. $d(x, y) = 0 \Leftrightarrow x = y$ (identity of indiscernibles)
2. $d(x, y) = d(y, x)$ (symmetry)
3. $d(x, z) \leq d(x, y) + d(y, z)$ (triangle inequality).

The ordered pair (X, d) is called a metric space. For $X \subseteq \mathbf{R}$ we always consider the standard Euclidean metric given by $d(x, y) = |x - y|$. The distance $d(x, B)$ between a point $x \in X$ and a nonempty set $B \subseteq X$ is defined as

$$d(x, B) = \inf\{d(x, y) \mid y \in B\},$$

and if $B = \emptyset$, then $d(x, B) = \infty$. The ε -neighborhood of B is denoted by $B^\varepsilon = \{x \in X \mid d(x, B) < \varepsilon\}$. A set $U \subseteq X$ is called open if for every $x \in U$ there is an $\varepsilon > 0$ such that

$$\{y \in X \mid d(x, y) < \varepsilon\} \subseteq U.$$

A set $F \subseteq X$ is called closed if its complement $X \setminus F$ is open, and a set $C \subseteq X$ is called compact if, for every collection $\{U_\alpha \mid \alpha \in A\}$ of open sets such that $C \subseteq \cup_{\alpha \in A} U_\alpha$, it holds that A has a finite subset A' such that $C \subseteq \cup_{\alpha \in A'} U_\alpha$. Every compact set in a metric space is closed as well. The topology on X induced by metric d is the collection of all open sets, and the Borel σ -field Σ on X is the smallest σ -field that contains all open sets. A measure on (X, Σ) is a function $\mu : \Sigma \rightarrow [0, \infty)$ such that $\mu(\emptyset) = 0$ and μ is σ -additive. A measure μ is called a probability measure if $\mu(X) = 1$. A probability measure is called completely mixed if it assigns strictly positive weight to every nonempty open set. For a metric space (X, d) , the set of probability measures on the Borel σ -field on X is denoted by $\Delta(X)$. A probability measure $\mu \in \Delta(X)$ is completely mixed if $\mu(U) > 0$ for every nonempty open subset U of X . Moreover, define

$$\text{supp}(\mu) = \{x \in X \mid \text{for every open set } G \text{ if } x \in G \text{ then } \mu(G) > 0\}.$$

Therefore, for every completely mixed probability measure, we have $\text{supp}(\mu) = X$.

The weak (Prokhorov) metric ρ^w on $\Delta(X)$ is defined for every $\mu, \nu \in \Delta(X)$ by

$$\rho^w(\mu, \nu) = \inf\{\varepsilon > 0 \mid \forall B \in \Sigma : \mu(B) \leq \nu(B^\varepsilon) + \varepsilon \text{ and } \nu(B) \leq \mu(B^\varepsilon) + \varepsilon\}$$

and the strong metric by

$$\rho^s(\mu, \nu) = \sup\{|\mu(B) - \nu(B)| \mid B \in \Sigma\}.$$

Note that for every μ and ν , $\rho^w(\mu, \nu) \leq \rho^s(\mu, \nu)$. This easily follows from the observation that for every $B \in \Sigma$, both $\mu(B) - \nu(B^\varepsilon)$ and $\nu(B) - \mu(B^\varepsilon)$ are smaller

than or equal to $|\mu(B) - \nu(B)|$ and therefore smaller than or equal to $\rho^s(\mu, \nu)$ as well.

The weak (strong) topology on $\Delta(X)$ is the topology induced by the weak (strong) metric. The inequality $\rho^w(\mu, \nu) \leq \rho^s(\mu, \nu)$ implies that the weak topology is included in the strong topology. If X is compact, then so is $\Delta(X)$ with respect to ρ^w (cf. Prokhorov [39] and Parthasarathy [38]). Further, compactness and sequential compactness are equivalent for metric spaces.¹⁶

Let $\mu_n \in \Delta(X)$ for every $n \in \mathbb{N}$ and let $\mu \in \Delta(X)$. It is known that if the sequence μ_n converges to μ with respect to ρ^w , then $\int_X f(x)\mu_n(dx)$ converges to $\int_X f(x)\mu(dx)$ for every bounded and continuous function $f : X \rightarrow \mathbb{R}$. Conversely, if X is separable and $\int_X f(x)\mu_n(dx)$ converges to $\int_X f(x)\mu(dx)$ for every bounded and Lipschitz function $f : X \rightarrow \mathbb{R}$, then μ_n converges to μ with respect to ρ^w .

Let $(X_1, \Sigma_1), (X_2, \Sigma_2), \dots, (X_n, \Sigma_n)$ be measurable spaces. The product σ -field $\otimes_{i=1}^n \Sigma_i$ on $\times_{i=1}^n X_i$ is defined to be the smallest σ -field that contains all the sets in $\times_{i=1}^n \Sigma_i$. Let μ_i be a measure on (X_i, Σ_i) , for every $1 \leq i \leq n$, and μ be a measure on the semi-ring $\times_{i=1}^n \Sigma_i$ defined by

$$\mu(A_1 \times \dots \times A_n) = \prod_{i=1}^n \mu_i(A_i),$$

for every $A_i \in \Sigma_i$, $1 \leq i \leq n$. The product measure μ^* is the extension of the measure μ to the measurable space $(\times_{i=1}^n X_i, \otimes_{i=1}^n \Sigma_i)$ via the formula

$$\mu^*(E) = \inf \left\{ \sum_{k=1}^{\infty} \mu(\times_{i=1}^n A_i^k) \mid E \subseteq \bigcup_{k=1}^{\infty} (\times_{i=1}^n A_i^k), A_i^k \in \Sigma_i, 1 \leq i \leq n, \forall k \in \mathbf{N} \right\} \quad (4.2)$$

According to Carathéodory's theorem, this extension is unique.

Let $(X, \Sigma_1), (Y, \Sigma_2)$ be two measurable spaces. A function $f : X \rightarrow Y$ is called measurable if $f^{-1}(B) \in \Sigma_1$ for every $B \in \Sigma_2$.

Semi-product measures

Definition 4.6.4 Let (X, Σ_1) and (Y, Σ_2) be two measurable spaces, μ be a measure on (X, Σ_1) and $\tau : X \times \Sigma_2 \rightarrow [0, \infty)$ be a bounded function with the following properties :

1. the section function $\tau(x, \cdot) : \Sigma_2 \rightarrow [0, \infty)$ is a measure on (Y, Σ_2) for every $x \in X$,
2. the section function $\tau(\cdot, B) : X \rightarrow [0, \infty)$ is a measurable function for every $B \in \Sigma_2$.

Let λ be a measure on the semi-ring $\Sigma_1 \times \Sigma_2$ defined by

$$\lambda(A \times B) = \int_A \tau(x, B) \mu(dx),$$

for every $A \times B \in \Sigma_1 \times \Sigma_2$. The unique extension of the measure λ by the formula (4.2) to the product σ -field $\Sigma_1 \otimes \Sigma_2$ is denoted by λ^* and is called the *semi-product measure* corresponding to τ and μ .

Note that λ is well-defined, because the section function $\tau(\cdot, B)$ is bounded and measurable for every $B \in \Sigma_2$. The following theorem states the integral respect to λ^* as iterated integrals respect to τ and μ . Dudley states a sketch of the proof in [11].

Theorem 4.6.5 *Let (X, Σ_1) and (Y, Σ_2) be two measurable spaces and let λ^* be the semi-product measure corresponding to τ and μ . Then, for every function $f : X \times Y \rightarrow \mathbf{R}$ bounded and measurable with respect to the σ -field $\Sigma_1 \otimes \Sigma_2$ we have*

$$\int_{X \times Y} f d\lambda^* = \int_X \int_Y f \tau(x, dy) \mu(dx).$$

In particular, $\lambda^(E) = \int_X \tau(x, E_x) \mu(dx)$ for every $E \in \Sigma_1 \otimes \Sigma_2$ where $E_x = \{y \in Y \mid (x, y) \in E\}$.*

Proof. Let $E \in \Sigma_1 \otimes \Sigma_2$. We first show that $\lambda^*(E) = \int_X \tau(x, E_x) \mu(dx)$. Let \mathcal{N} be the collection of all sets $E \in \Sigma_1 \otimes \Sigma_2$ such that

- (i). $x \mapsto \tau(x, E_x)$ is a measurable function, and
- (ii). $\lambda^*(E) = \int_X \tau(x, E_x) \mu(dx)$.

We prove that \mathcal{N} is a σ -field.

1. It is clear that $X \times Y \in \mathcal{N}$. Indeed, $x \mapsto \tau(x, Y)$ is measurable according to condition (2) of Definition 4.6.4, and $\lambda^*(X \times Y) = \lambda(X \times Y) = \int_X \tau(x, Y) \mu(dx)$.

2. We show that if $E \in \mathcal{N}$, then $E^c \in \mathcal{N}$.

- (i). Since $x \mapsto \tau(x, E_x)$ is measurable and $\tau(x, Y) - \tau(x, E_x) = \tau(x, E_x^c)$, the map $x \mapsto \tau(x, E_x^c)$ is also measurable.

$$\begin{aligned}
(ii). \lambda^*(E^c) = \lambda^*(X \times Y) - \lambda^*(E) &= \int_X \tau(x, Y) \mu(dx) - \int_X \tau(x, E_x) \mu(dx) \\
&= \int_X (\tau(x, Y) - \tau(x, E_x)) \mu(dx) \\
&= \int_X \tau(x, Y \setminus E_x) \mu(dx) \\
&= \int_X \tau(x, E_x^c) \mu(dx).
\end{aligned}$$

3. We show that if $(E^i)_{i=1}^\infty$ is a countable collection of sets in \mathcal{N} , then $\bigcup_{i=1}^\infty E^i \in \mathcal{N}$:

Without loss of generality we assume that E_1, E_2, \dots are pairwise disjoint, because otherwise we can consider the pairwise disjoint sets $E_1, E_2 \setminus E_1, E_3 \setminus (E_1 \cup E_2), \dots$

(i). Since $x \mapsto \tau(x, E_x^i)$ is measurable for every $i \in \mathbf{N}$, by the Monotone Convergence Theorem the map that assigns to x the real number $\lim_{n \rightarrow \infty} \sum_{i=1}^n \tau(x, E_x^i) =$

$$\sum_{i=1}^\infty \tau(x, E_x^i) = \tau(x, \bigcup_{i=1}^\infty E_x^i)$$

is also measurable.

(ii). According to the Monotone Convergence Theorem we have

$$\begin{aligned}
\lambda^*\left(\bigcup_{i=1}^\infty E^i\right) &= \sum_{i=1}^\infty \lambda^*(E^i) = \lim_{n \rightarrow \infty} \sum_{i=1}^n \lambda^*(E^i) \\
&= \lim_{n \rightarrow \infty} \sum_{i=1}^n \int_X \tau(x, E_x^i) \mu(dx) \\
&= \int_X \lim_{n \rightarrow \infty} \sum_{i=1}^n \tau(x, E_x^i) \mu(dx) \\
&= \int_X \tau(x, \bigcup_{i=1}^\infty E_x^i) \mu(dx) \\
&= \int_X \tau(x, (\bigcup_{i=1}^\infty E^i)_x) \mu(dx).
\end{aligned}$$

Hence, \mathcal{N} is a σ -field. Furthermore, it is clear that for every $A \in \Sigma_1$ and $B \in \Sigma_2$, $A \times B \in \mathcal{N}$. Since the product σ -field $\Sigma_1 \otimes \Sigma_2$ is the smallest σ -field that contains $\Sigma_1 \times \Sigma_2$, we have $\Sigma_1 \otimes \Sigma_2 = \mathcal{N}$. Therefore, $\lambda^*(E) = \int_X \tau(x, E_x) \mu(dx)$ for every set $E \in \Sigma_1 \otimes \Sigma_2$.

Now, we complete the proof of the theorem. We just proved that for every set $E \in \Sigma_1 \otimes \Sigma_2$ we have

$$\int_{X \times Y} \mathbf{1}_E d\lambda^* = \lambda^*(E) = \int_X \tau(x, E_x) \mu(dx) = \int_X \int_Y \mathbf{1}_{E_x} \tau(x, dy) \mu(dx).$$

Hence, it is clear that for any bounded and measurable step function ϕ on $X \times Y$ we have

$$\int_{X \times Y} \phi d\lambda^* = \int_X \int_Y \phi_x \tau(x, dy) \mu(dx) = \int_X \int_Y \phi \tau(x, dy) \mu(dx),$$

where $\phi_x(y) = \phi(x, y)$. Let $f : X \times Y \rightarrow \mathbf{R}$ be a bounded and measurable function with respect to the σ -field $\Sigma_1 \otimes \Sigma_2$. Then, there is a sequence of bounded and measurable step functions $\{\phi^n\}_{n=1}^\infty$ such that $\phi^n \uparrow f$ pointwisely. Thus, by the Monotone Convergence Theorem we have

$$\begin{aligned} \int_{X \times Y} f d\lambda^* &= \int_{X \times Y} \lim_{n \rightarrow \infty} \phi^n d\lambda^* \\ &= \lim_{n \rightarrow \infty} \int_{X \times Y} \phi^n d\lambda^* \\ &= \lim_{n \rightarrow \infty} \int_X \int_Y \phi^n \tau(x, dy) \mu(dx) \\ &= \int_X \int_Y \lim_{n \rightarrow \infty} \phi^n \tau(x, dy) \mu(dx) \\ &= \int_X \int_Y f \tau(x, dy) \mu(dx). \end{aligned}$$

■

Fixed point theorems

Let X and Y be two metric spaces. A correspondence between X and Y is a map from the elements of X to the collection of all subsets of Y . So, for every $x \in X$, we have $F(x) \subseteq Y$. A correspondence F between X and Y is upper-hemicontinuous if for every $x \in X$ and every sequence $(x_n)_{n=1}^\infty$ in X converging to x and every sequence $(y_n)_{n=1}^\infty$ in Y converging to y with $y_n \in F(x_n)$ it holds that $y \in F(x)$. A point $x \in X$ is called a fixed point for a correspondence $F : X \rightrightarrows X$ when $x \in F(x)$. We use the next theorem, Kakutani fixed point theorem, to prove the existence of weakly glof perfect equilibrium in chapter 2.

Theorem 4.6.6 (Kakutani's fixed point theorem) *Let X be a non-empty, compact and convex subset of an Euclidean space. Let $F : X \rightrightarrows X$ be an upper-hemicontinuous correspondence such that $F(x)$ is non-empty, closed and convex for all $x \in X$. Then F has a fixed point.*

The following fixed point theorem is used to prove the existence of distributional perfect equilibrium in chapter 4. This theorem is derived from Glicksberg [13].

Theorem 4.6.7 *Let S be a nonempty compact and convex subset of a locally convex Hausdorff space. Let $F : S \rightarrow S$ be an upper hemicontinuous correspondence with nonempty and convex values. Then, F has a fixed point.*

Nederlandse Samenvatting

Simon en Stinchcombe hebben in 1995 het begrip perfect evenwicht gedefinieerd voor spelen met oneindige compacte verzamelingen van acties. Zij onderscheidden twee hoofdlijnen voor de mogelijke definities van perfect evenwicht. De eerste lijn is gebaseerd op het begrip compleet gemengd evenwicht, waarmee het sterke en zwakke perfecte evenwicht zijn gedefinieerd. Deze aanpak kan worden opgevat als een rechtstreekse generalisatie van de oorspronkelijke “trembling hand” definitie van perfect evenwicht door Selten in 1975. De tweede lijn van definities, vaak aangeduid met de term “finitistic approach”, maakt gebruik van de notie van het ε -perfecte evenwicht in eindige benaderingen van het oorspronkelijke oneindige spel. Het resulterende begrip wordt aangeduid met “limiet-van-eindig” perfect evenwicht. Simon en Stinchcombe bewezen dat de eerste lijn van definities alleen gebruik maakt van zogeheten limiet toelaatbare strategieën. Verder spraken ze het vermoeden uit dat de twee benaderingen niet vergelijkbaar waren.

In hoofdstuk 2 onderzoeken we de relaties tussen de verschillende soorten van perfecte evenwichten binnen het kader van spelen in strategische vorm met compacte actieruimten en continue uitbetalingsfuncties. Verder introduceren we een verbeterde versie van de “finitistic approach”, aangeduid met “globaal-limiet-van-eindig” perfect evenwicht, en bewijzen het bestaan van zulke evenwichten. Ondanks het feit dat de finitistic approach zeer intuïtief aandoet, lijken onze resultaten—met name voorbeelden [3] en [4]—een serieuze kritiek op deze aanpak te impliceren. In het eerste voorbeeld selecteert elke variant van de finitistic approach een Nash evenwicht dat niet limiet toelaatbaar is. Het tweede voorbeeld beschrijft een compleet gemengd (dus automatisch trembling hand perfect) Nash evenwicht dat niet finitistisch perfect is. Verdere voorbeelden dienen ter illustratie van de relaties tussen de twee verschillende benaderingen van het perfecte evenwicht, en de relatie tot toelaatbaarheid en ongedomineerdheid van strategieën.

In zogeheten second price veilingen met particuliere waarderingen voor de bidders heeft iedere bidder een dominante strategie waarin hij zijn persoonlijke waardering

voor het object biedt. Echter, in een second price veiling met incomplete informatie en onderling afhankelijke waarderingen hebben bieders niet altijd een dominante strategie, terwijl er veel evenwichten kunnen zijn in een dergelijke veiling. Dit creëert de noodzaak om een instrument te ontwerpen om in zulke zogeheten Bayesiaanse spelen de minder intuïtieve evenwichten uit te sluiten. Met dit doel voor ogen ontwikkelen we in hoofdstukken 3 en 4 het begrip trembling hand perfect evenwicht voor Bayesiaanse spelen met oneindige type en actie ruimten, ter verfijning van de verzameling Bayesiaanse Nash evenwichten.

In hoofdstuk 3 baseren we ons onderzoek op zogeheten gedrag strategieën. Een centraal oplossingsconcept is het begrip Bayesiaans Nash evenwicht (BNE), een directe generalisatie van het Nash evenwicht. Een BNE is een profiel van gedrag strategieën, een voor elke speler, zó, dat de strategie van een speler, gegeven zijn type, in verwachte waarde een beste antwoord is op de strategieën van de tegenspelers, waarbij in de verwachte waarde alle mogelijke typen van de tegenspelers in beschouwing moeten worden genomen. Anders gezegd, de beste-antwoord eigenschap van het evenwicht wordt op interim niveau geëist, als een speler al weet wat zijn type is. Ons doel in dit hoofdstuk is om een formele definitie te geven van perfect BNE in Bayesiaanse spelen, en de eigenschappen daarvan in kaart te brengen. Als eerste stap definiëren we perfectie voor een gedrag strategie, dus niet noodzakelijk voor een BNE. We beschouwen drie varianten van perfectie, die verschillen in het convergentiebegrip dat gehanteerd wordt over de type ruimten. Kort gezegd is het centrale idee om een gedrag strategie β perfect te noemen als er een rij $(\beta^k)_{k=1}^{\infty}$ compeet gemengde strategieën bestaat zó, dat voor elke speler i de afstand tussen β_i^k en β_i en de afstand tussen β_i^k en de beste antwoorden tegen β^k beide naar nul convergeren. Met convergentie bedoelen we hier convergentie in de actie ruimte met betrekking tot de zwakke metriek, en convergentie in de type ruimten in één van de volgende drie betekenissen: uniform voor alle typen, puntsgewijs voor elk type, en puntsgewijs voor bijna elk type. In het algemeen is een dergelijk profiel β niet per sé een BNE. Als β ook nog een BNE is, dan noemen we β uniform-perfect, puntsgewijs-perfect, of b.o.-puntsgewijs perfect. We geven een gedetailleerde analyse van elk van deze drie versies van perfect BNE, en bespreken de relaties tussen deze begrippen. We beschouwen ook enkele speciale gevallen, zoals compactheid van type en actie ruimten, en continuïteit van de uitbetalingsfuncties.

In hoofdstuk 4 beschouwen we Bayesiaanse spelen met n spelers waar de type ruimte van elke speler een separabele metrische ruimte is. Zodra spelers hun type kennen, dienen ze gelijktijdig een actie uit een compacte metrische ruimte te kiezen, waarna elke speler een uitbetaling ontvangt die af kan hangen van zowel de typen van

de spelers als de acties die ze hebben gekozen. Zoals in Milgrom en Weber (1985) veronderstellen we dat de a priori kansverdeling op het product van de type ruimten absoluut continu is in relatie tot het product van de resulterende marginale kansen. We nemen ook aan dat de uitbetalingen equicontinu zijn. Milgrom en Weber (1985) bewijzen dat er in dit geval minstens een evenwicht in distributie strategieën bestaat. Aangezien het niet duidelijk is hoe spelers een distributie strategie dienen te spelen, definiëren we een analoog begrip voor gedrag strategieën. Een gedrag strategie wordt een distributie evenwicht genoemd als de resulterende distributie strategieën een evenwicht vormen.

Om het begrip trembling hand perfect evenwicht te generaliseren naar Bayesiaanse spelen, definiëren we in dit hoofdstuk het distributie perfect evenwicht als een gedrag strategie profiel wiens resulterende distributie strategie profiel voldoet aan de voorwaarden voor het trembling hand perfect evenwicht. We bewijzen dat voor bovenstaande klasse van Bayesiaanse spelen distributie perfectie een verfijning is van het distributie evenwicht. Ook bewijzen we dat een distributie perfect evenwicht bestaat, en dat de verzameling distributie perfecte evenwichten rijgesloten is in Tychonoff topologie, indien we de verzameling van kansmaten op de actie ruimten topologiseren met de sterke topologie.

We benadrukken dat de aanpak in hoofdstuk 3 om perfecte evenwichten te definiëren natuurlijker is dan de methode die we hanteren in hoofdstuk 4. Echter, om de theorie van perfectie te ontwikkelen, en met name om existentie van perfecte evenwichten te bewijzen, is het eenvoudiger om de tweede aanpak in hoofdstuk 4 te gebruiken dan de eerste in hoofdstuk 3.

Verder, in beide hoofdstukken, gebruiken de deze methoden in de context van symmetrische sealed-bid second-price veilingen met onderling afhankelijke waarderingen, en laten zien dat perfectie een specifiek type evenwicht selecteert, en de minder natuurlijke evenwichten uitsluit. Verder merken we op dat in deze veilingen de bidders geen dominante strategieën hebben, en dat er een groot aantal evenwichten in ongedomineerde strategieën bestaat.

Preciezer gezegd, in hoofdstuk 3 beschouwen we een second price veiling waarin voor elke $i = 1, 2$ de waardering voor bidder i wordt gegeven door $v_i = 5 + t_i - \alpha t_j$, met $\alpha \in (0, 1)$ en $j \neq i$. Er zijn veel BNEs in deze veiling, maar we laten zien dat perfectie een BNE β selecteert die uniek is binnen een klasse van strategieën, en de minder natuurlijke evenwichten uitsluit. We benadrukken dat de keuze van de rij gedrag strategie profielen $(\beta^k)_{k=1}^{\infty}$ een subtiele zaak is, aangezien de meest voor de hand liggende kandidaat niet het gewenste resultaat geeft.

In hoofdstuk 4 beschouwen we een symmetrische second price veiling met twee bidders waar de waardering van bidder i voor het object af kan hangen van beide typen. Deze waardering wordt aangeduid met $v_i(t_1, t_2)$ en heeft de volgende eigenschappen:

- (1) $v_1(t_1, t_2) = v_2(t_2, t_1)$.
- (2) v_i is continu differentieerbaar.
- (3) v_i is strikt stijgend in t_i and stijgend in t_j voor $j \neq i$.

We gebruiken distributie perfectie in deze veiling om een kleinere verzameling evenwichten te verkrijgen, en de contra-intuïtieve evenwichten uit te sluiten.

Biography

Elnaz Bajoori was born on September 18, 1980 in Zahedan, Iran. She did her undergraduate studies in pure mathematics at Iran University of Science and Technology, Tehran. She continued with a research Master in pure mathematics, mathematical analysis at Kharazmi University (Tarbiat Moallem University) in Tehran. She did her Master thesis on "fixed point theorems for set-valued functions with applications to game theory" which was a turning point for her to get interested in game theory and economics. She was a lecturer at Azad University of Saveh in Iran for four years, besides she was learning economics and game theory by self-studying and sitting in different economics classes.

She started her PhD program in September 2009 at Maastricht University under supervision of Prof. Dries Vermeulen and Dr. János Flesch. Her PhD research was on trembling hand perfect equilibrium in games with infinite action spaces. During her PhD she visited the Economics Departments of the University of Chicago, the University of Birmingham, and the University of Exeter. She has presented her research papers in several conferences and workshops such as International Conference on Game Theory in Stony Brook, Economic Theory Workshop of the University of Chicago, Fourth Congress of Game Theory in Istanbul, and seminar series in Mathematics Department of London School of Economics.

To pursue her academic life, Elnaz is going to take up a lectureship position at the University of Bath, Department of Economics from September 2013.
